**MOTION FOR EXTENSION
OF TIME TO FILE REPLY BRIEF**

Appellant moves to extend the deadline for filing the reply brief by thirty days, through July 8, 2020. NRAP 31(b)(3). This is the first such motion for extension. The brief would otherwise be due June 8, 2020.

More time is needed to complete the reply brief due largely to the volume of the answering brief, which, at 24,477 words, is 75% longer than the maximum size contemplated in the rules. *See* NRAP

32(a)(7)(A)(ii) (limiting briefs to 14,000 words). The answering brief is about 6,000 words longer than the opening brief. And it develops points and authorities beyond what plaintiffs filed in the district court. The additional time will enable appellant to respond appropriately.
