**MOTION FOR EXTENSION
OF TIME TO FILE REPLY BRIEF**

Appellant moves to extend the deadline for filing the reply brief by thirty days, through August 7, 2020. NRAP 31(b)(3). This is the second motion for extension regarding this brief. The brief was originally due June 8, 2020 and, without an extension, would be due July 8, 2020. No requests for extension have been denied or denied in part.

The extension is necessary under the circumstances. First, appellant's counsel continue to address all of the points and authorities raised in the answering brief, which is 75% longer than the maximum size contemplated in the rules (NRAP 32(a)(7)(A)(ii) (limiting briefs to 14,000 words)) and nearly 6,000 words longer than the opening brief. Second, lead appellate counsel has had to prepare for back-to-back arguments before this Court *en banc* (July 6) and the Ninth Circuit (July 8), the scheduling of which was beyond appellant's control. Third, another of the appellate attorneys has had to care for his elderly parents, both of whom are experiencing serious health issues. The additional time will enable appellant to ensure this Court is apprised of all the relevant authorities and considerations relevant to resolving the important issues in this case.
