Appellant Marcus Campbell is currently an inmate at High Desert State Prison. Appellant filed a pro se appeal from an order of the Eighth Judicial District Court denying his motion to correct/modify an illegal sentence. The district court entered the order denying Appellant's motion on March 21, 2019, and notice of appeal was due on April 22, 2019. Appellant's notice of appeal was not filed until May 1, 2019.

A notice of appeal must be filed with the district court clerk within thirty days after the entry of the judgment or order being appealed. NRAP 4(b)(1)(a). An inmate's deadline for filing is met if evidence can be produced showing that the appellant delivered his notice of appeal to a prison official for mailing within the thirty days period of time for filing a notice of appeal. *Kellogg v. Journal Communications*, 108 Nev. 474, 477, 835 P.2d 12, 13 (1992). However, in this case no such evidence exists.

In compliance with this Court's Order Directing Attorney General to Obtain and Transmit Certified Copy of Notice of Appeal Log or Other Log Maintained by the Prison, the foregoing evidence, that the notice of appeal was untimely, is presented:

Identification of Inmate

Exhibit 1 reflects that Appellant's name and prison identification number, as well as his current assigned place of incarceration at High Desert State Prison.

Exhibit 2 shows that Appellant was housed at High Desert State Prison during the entirety of the relevant period in which notice of the entry of the district court order was served upon the Appellant, and date the Appellant's notice of appeal was filed with the clerk of the Eighth Judicial District Court.

Notice of Appeal Logs

Exhibit 3 is a copy of the High Desert State Prison "Inmate Notice of Appeal Log" maintained by the prison in accordance with Nevada Department of Corrections Administrative Regulation 722.07. No entry is reflected for the Appellant's notice of appeal under the inmate's name or identification number.

Other Evidence

Exhibit 4 is a copy of the Appellant's daily transaction account summary for the dates between March 21, 2019 and June 12, 2019. There are no transactions for postage listed.

NRAP 4(d) provides:

Appeal by an Inmate Confined in an Institution. If an inmate confined in an institution files a notice of appeal in either a civil or a criminal case, the notice is timely if it is delivered to a prison official for mailing on or before the last day for filing. If the institution has a notice-of-appeal log or another system designed for legal mail, the inmate must use that log or system to receive the benefit of this Rule.

Respondent has made a diligent effort to locate evidence of the Appellant's efforts to serve his notice of appeal but have found no relevant information that is dispositive of the timeliness of Appellant's notice of appeal. As the Appellant failed to avail himself of the prison's inmate notice of appeal log, his notice should be deemed untimely.
