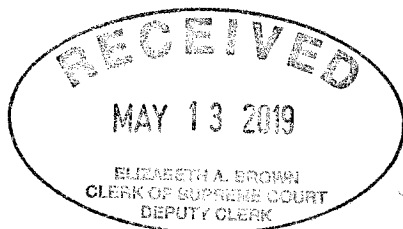
9 MOTION TO WAIVE FILING FEES FOR PETITION FOR WRIT OF

requests that said filing fees be waived in the Interest of Justice.


