COMES NOW, Appellant Michael McNair, by and through his attorneys, JoNell Thomas, Special Public Defender, and Navid Afshar, Deputy Special Public Defender, and requests this Honorable Court to allow Appellant to supplement the Appendix with Court's Exhibits 1, 2 and 3 which were submitted at trial in the district court under Case No. C-17-327395-1.

This request is made and based on the pleadings and papers on file with this Court as well as counsel's declaration attached hereto.

STATEMENT OF THE CASE

After proceeding to trial, Appellant Michael McNair was found guilty by the jury of First Degree Murder with use of a deadly weapon and Carrying a Concealed Firearm or other deadly weapon. Mr. McNair agreed to waive the penalty hearing and be sentenced by the Court. He was sentenced to 20 years to Life plus a consecutive term of 60-240 months for the use of the deadly weapon and a concurrent sentence for Count 2. The Judgment of Conviction was filed May 3, 2019, and the Notice of Appeal was timely filed on May 22, 2019.

The Opening Brief and Appendix were filed November 16, 2020.

The State filed their Answering Brief January 14, 2021.

Appellant filed a second motion for an extension of time to file his Reply Brief, up to and including April 12, 2021. In his Motion, Counsel for Appellant advised the Court that based on a claim made by the State in its Answering Brief, it would be necessary to supplement the appendix with the Court's Exhibits (Court's Exhibit 1 (Race & Ethnicity Report); Court's Exhibit 2 (Transcript from C-239029); and Court's Exhibit 3 (2018 Census Stats)) in order to reply to their claim.¹ Counsel requested the clerk of the district court vault provide copies of the exhibits under case number C237395, but the clerk provided copies of exhibits under case number C293029. A response to counsel's request to provide the correct exhibits was delayed as the clerks were out of the office for several days. The correct exhibits were provided on this date.

Based on the reasons set forth in the declaration attached hereto, counsel for Appellant is requesting this Court to allow him to
