I request that an authorized officer of the institution in which I am confined, or other designated entity, such as Inmate Scrviccs for the Nevada Department of Prisons (NDOC), complete the below Financial Certificate.
.I understand that:

- (1) if I commence a petition for writ of habeas corpus in federal court pursuant to 28 U.S.C. $\S 2254$, the filing fee is $\$ 5.00$, and that such fee will have to be paid by me if the current account balance (line \#1 below), or the average account balance (line \#2 below), or the average deposits to my account (line \#3), whichever is greater, is $\$ 20.00$ or more;
(2) if I commence a civil rights action in federal court pursuant to 42 U.S.C. § 1983, the filing fee is $\$ 350.00$, which I must pay in full; and
(a) if my current account balance (line \#1 below) is $\$ 350.00$ or more, I will not qualify for in form pauperis status and I must pay the full filing fec of $\$ 350.00$ before I will be allowed to proceed with the action;

(c) I must continue to make installment payments until the $\$ 350.00$ filing fee is fully paid, without regard to whether my action is closed or my release from confinement.
