1. I am an attorney licensed to practice law in the State of Nevada; I am a deputy public defender assigned to handle the appeal of this matter; I am familiar with the procedural history of this case.

2. Our office filed the Notice of Appeal in this matter on May 23, 2019. This case is governed by the provisions of NRAP 3C, which require the Appellant to file a Fast Track Statement 40 days after the filing of the Notice of Appeal. Accordingly, the instant Fast Track Statement is due to be filed no later than Monday, July 15, 2019.
