Counsel, as I indicated to you in chambers, we received a phone call over the evening hours or early this morning from juror number three who is asking to be excused. She's here. final packet instead of saying "during the course of trial,"
it will say, "you heard evidence." I changed it again to say,
"during the course of this trial you will hear evidence
regarding circumstances which occurred in Churchill County
before the offense of this case." I continue with what had

been in the original proposed Instruction with just a couple of changes midway through the sentence in the original starting at line six. And mine starts at the end of line 4 with the words, "however you may consider." I changed it to "all of the evidence you hear in this trial," rather than Churchill County, they can consider all of it they hear, not just the Churchill County. For those purposes, those were the changes I made.

THE COURT: You all have discussed this with your client, the strategic decision to offer it just once at the end when the jury, I give the Instructions after the close of evidence?

MS. BOND: Yes. It is strategic on our part.

Rather than emphasizing over and over, this is something else you are hearing about, we want it given once so they have a frame work of how they are going be instructed to use it and place it in their thoughts during the trial. We didn't want to emphasize it over and over again there are other acts.

THE COURT: Mr. Young.

MR. YOUNG: Could I have one moment, Your Honor?

Instruction. I have no objection with one caveat. If you look

THE COURT: It would read: However, you may consider all of the evidence you hear in this trial and the defendant's involvement in the events that are presented to you?

MS. BOND: Yes. That is acceptable to us as well.

THE COURT: Okay. You all would like me to say that before opening statements or as soon as the Information is read?

MS. BOND: I prefer after opening statements just before the first witness.

MR. YOUNG: Again, it is for the defense's benefit in part. I will defer. It is separate, obviously, from the 48.045 Instruction. That case law says it should be given immediately before the PBA evidence is given. We are not going to get into the Churchill County incident until Abraham Lee testifies today. So, again, I will defer to the defense. If you want to give it prior to that evidence, it would be, it again is to the defense's benefit. I will defer how they want to proceed.

MS. BOND: Our only concern, we don't want it before opening. I understand they may prefer it. We will leave it to your discretion if you prefer to do it at the beginning of any evidence or before the first Churchill County evidence.

MS. BOND: That is acceptable, Your Honor.

THE COURT: Okay. That done, you all have some redacted transcripts I think you are going to be using?

MR. YOUNG: Yes. They have been marked as exhibits. 55 is the transcript of Jerome Vaughn. 56 is the transcript of Kevin Lattyak, L-A-T-T-Y-A-K. 57 is the transcript of Linda Solomon. There have been redactions to all those in large part to assist with the ease of reading. The first time around, there were three defense attorneys, a couple other issues that were presented. So counsel and I sat down and made the redaction. It is my understanding both parties are stipulating and agreeing to all the redactions that would be presented in the transcript.

1 MS. BOND: The State also removed certain objections 2 where the objection had been sustained. So that evidence wasn't heard by the last jury either in reference to the 3 earlier penalty. THE COURT: Exhibits 55, 56, 57 are admitted for the 5 6 purpose of reading only and will not be presented to the jury 7 other than in an oral format. That is based on the 8 stipulation of counsel, correct? 9 MS. BOND: Yes, Your Honor. MR. YOUNG: I don't intend on admitting them. They 10 11 will just be used for reading, obviously part of the Court 12 record. 13 THE COURT: Right. Do you have a copy for the 14 Court? 15 MR. YOUNG: Yes. I apologize. I just made copies for 16 the State's witnesses, that being Mr. Lattyak and Mr. Vaughn. 17 I can do Ms. Solomon later. We won't get to her until later. 18 We do have one for Ms. Solomon. 19 THE COURT: Counsel, you have copies of all of 20 these, right? 21 MS. BOND: We do. 2.2 THE COURT: Thank you. (Exhibits 55, 56, 57 admitted in evidence for reading.) 2.3 24 THE COURT: Now we had a discussion earlier on

Exhibits 11-a and b. I see from the exhibit list you did not mark those. I think there was some discussion about wanting to use the same information that had been on the VHS tapes in a digital format, did those get marked a different number.

THE CLERK: I did not mark 11-a and b as part of this trial because those were the old type tapes. We did mark 11-c and 11-d as the CD's for this trial.

THE COURT: Those were dropped, essentially off your list, so you want to add them to your list? The clerk does have those exhibits, so 11-c and 11-d, it is my understanding they are a duplication of 11-a and b used previously in VHS format. These are discs.

MR. YOUNG: 11-c, as I understand. 11-a and B from 1997 or '99 of the trial were the two separate VHS discs which contain Mr. Harte's interview. They ran over one to the other. 11-c, as I understand it, is that entire two VHS discs goes on to one disc for ease purposes. 11-d is effectively a redacted copy of the full interview. The only redactions are made is it cuts out the empty space, about 15 minutes, before the interview starts where it just shows Mr. Harte sitting there. I didn't think that was necessary to show. It would be a waste of time. It cut out the last maybe ten minutes, again after Mr. Harte leaves the interview room. Again, there is no significance to that. It cut out end time. The only

redaction, if you will, I did do, Mr. Evans, our IT personnel, at one point in the interview Mr. Harte is asked for his Social Security number. With the prohibition of introducing the Social Security number, it is video, it is still playing but it mutes the volume for the eight to ten second period where Mr. Harte provides his Social Security. The full unredacted copy was provided to defense counsel. The redacted 11-d was provided to defense counsel to make sure they were satisfied with what I did, it is 11-d. I intend on presenting to the jury the full interview minus the Social Security.

MS. BOND: Your Honor, the Court made rulings many years ago regarding the admissibility of the interview. It is not being readdressed. We would not object to the jury being able to hear or view 11-d.

THE COURT: Okay. So while we are here with that, are you asking to admit 11-d now or stipulating to that and wait during the course of the trial?

MR. YOUNG: I prefer to wait, Your Honor.

THE COURT: Are there any stipulations on any of the evidence that you want to stipulate to?

MR. YOUNG: Your Honor, we haven't talked about any stipulation. I frankly don't anticipate too many problems with them. I am okay stipulating at this point. If counsel

would like us to lay a brief foundation, I am certainly okay doing that as well.

MS. BOND: I understand they are going to offer it as they go through. I think in most cases there won't be much issue, there might be one or two. I informed them of one photograph I have a problem with. Frankly, I don't really think it detracts much from the case if they don't use it. As we go, we can go through that.

THE COURT: The only problem I have any difficulty is with exhibits while doing the trial, I have to send the jury out to have the discussion on the record because

Mr. Harte needs to hear the discussion. It is fine with jury selection in the sidebar record. It is more difficult to do that. So since I think I know from the clerk what the exhibit is, maybe we can deal with that, that photograph now and then we don't have to. The other thing counsel, I would like to limit as much as we can.

MR. BOND: If I could grab the exhibit. Mr. Lee was fine. Mr. Young was not. Exhibit 37 is the one we are talking about.

THE COURT: You can make your record.

MS. BOND: Thank you. On Exhibit 37, it is a bookshelf containing a number of books that appear to have been from Mr. Harte's room. One of the books at the right-

hand end of the row of books in fact it looks like it is the last actual book on that shelf is the Anarchist Cookbook.

This Court said it was not admissible at the trial at the pretrial hearings. We object to 37 being admitted because of that book that is in there. It has already has been ruled it cannot be admitted.

John Castro, a human being by means of shooting John Castro in the head with a .22-caliber handqun thereby inflicting mortal injuries upon the said John Castro from which he died October 26, 1997; or, that the said defendants, Latisha Marie Babb, Weston Edward Sirex and Shawn Russell Harte individually and/or in joint participation on or about the 26th day of October A.D., 1997 or thereabout at the County of Washoe, State of Nevada did unlawfully kill and murder John Castro a human being during the perpetration of a robbery with the use of a deadly weapon by means of shooting John Castro in the head with the use of at .22 caliber handgun thereby inflicting mortal injuries upon John Castro from which he died on October 26, 1997; or, that the said defendants, Latisha Marie Babb and Weston Edward Sirex individually or in joint participation on or about the 26th day of October A.D. 1997 or thereabout at the County of Washoe, State of Nevada did aid, abet and or encourage Shawn Russell Harte who did willfully, unlawfully and with malice aforethought, deliberation and premeditation kill and murder John Castro a human being by means of shooting John Castro in the head with a .22 caliber handown from which he died on October 26, 1997 in that the defendant, Latisha Marie Babb followed the taxi cab which John Castro was driving in Shawn Russell Harte's vehicle to provide a means of escape after the murder; and/or the said defendant, Latisha Marie

THE COURT: Ladies and gentlemen of the jury, the next stage of the proceedings are for the State and defense to present their opening statements to you. Mr. Lee.

MR. LEE: Thank you, Your Honor. Ladies and gentlemen, good morning. From the words of a convicted killer, Shawn Harte, "I chambered a round and point blank an inch above the ear to behind, boom. That simple. That easy. No remorse."

You will hear more about this letter later. The words of Shawn, Harte, himself. Ladies and gentlemen you have been told already Mr. Harte's guilt has been established and that you have some options for sentencing. At the conclusion of this trial, the State will be asking you to return a verdict of life without the possibility of parole for the killing of John Castro, Jr.

On the late night of October 25, 1997 at approximately the 11:00 o'clock hour, Mr. Castro was at work driving his cab for the Reno-Sparks Cab Company. He received a call at the Speedway Market at Neil and Peckham and picked up two individuals. His cab wasn't heard from again. Jerome Vaughn who you will hear from his transcript, Mr. Vaughn is no

longer with us, he passed away, you will hear his transcript from previous testimony. He testified he came on duty in the middle of the night and began looking for the cab and Mr. Castro. Having no luck, he checked different businesses in the area, went to the Speedway Market, didn't find Mr. Castro. At the time, Reno-Sparks Cab Company did not, remember this is 1997, did not have GPS locators in their At 12:00 a.m. shortly after, this is now October 26, 1997, at John Lagamma's residence, 17865 Cold Springs Drive, he's staying there actually with a friend and he hears a car pull up in front of the residence. He looks out the window expecting or out the door expecting his son to return. sees a car, couldn't identify exactly what kind of car. turned the light on and went back inside. At 12:30 in the morning he looks out again. The car is there, moved forward a little and that's it. Mr. Lagamma goes to bed, and that is the last he thinks of that at that moment. Again, still can't tell what kind of vehicle it is. At 2:00 a.m. you will hear from Mr. Ronald Holst. Mr. Holst was a volunteer at the time with the Cold Springs Volunteer Fire Department. Mr. Holst is returning home from a personal engagement at 2:00 a.m. in the morning, drives past the location on Cold Springs Drive and sees the cab stopped in front of this residence. He thinks nothing of it. A cab parked there 2:00 a.m. Mr. Holst, again,

had no reason to think about it until he returned a few hours later in his duties with the Volunteer Fire Department. resident at that same home with John Lagamma at 17865 leaves for work early in the morning, and the cab is there and he sees an individual inside and reports that. Police are notified at the time. Deputy Kandi Payne-Davis, now sergeant Kandi Payne Davis responded. She was the first one on the scene. She arrived at 6:50 and now approximately seven hours after the cab picked up the individuals at the Speedway Market. Deputy Payne sees the cab parked in the travel lane of Cold Springs Drive. Again, not knowing what to expect, she approaches the cab. She sees through the window which were fogged at the time, this is October, late October, windows were fogged, she sees an individual sitting in the front driver's seat sitting up. He had slumped down. She could hear something. She could hear loud raspy breathing from this individual. On closer inspection looking inside, she sees blood coming from this individual's nose and mouth area. tries gaining the individual's attention. He's unresponsive. She and another deputy open the door, try to shake the Unresponsive. She sees a name tag, also noticed this man matches the description from dispatch as the cab driver, John Castro, Jr. Again, still breathing, blood coming out of his mouth and nose but unresponsive. Medical is called.

They respond. In the meantime, deputy Payne, realizing he's still breathing, doesn't want to move him, doesn't want to change the status quo since he's still breathing. She takes some Polaroids, pulls off the scene while medics respond. Medics do respond including Ronald Holst who you will hear from today. They assist Mr. Castro. He's Care Flighted to Washoe Medical. By this time, several law enforcement officials arrive at the scene. One of them is Chuck Lowe. Charles Lowe who you will hear from. At the time, he was a forensic investigator for the Washoe County Sheriff's Office. He searched the cab and found on the front passenger seat a single casing of a .22-caliber. He collects that as evidence to submit to the Washoe County Crime Lab. Missing was Mr. Castro's trip sheet which you will hear from the transcript of Mr. Vaughn was kept by all cab drivers. It records their doings, essentially. That was missing. At that point, investigators, detectives, deputies, they search. canvass the area. They go door to door. They search ditches, search a roadway for the weapon, for the trip sheet. They find nothing. They look for a possible suspect in the area. They find nothing. The case goes cold. There is no leads. That is where it was left for some time.

I am going to take you backwards now two weeks before that, approximately. October 14, 1997, eleven, twelve

days previous. In Churchill County, unbeknownst to the detectives in Washoe County, in Churchill County, Abe Lee is coming from Las Vegas driving to Fallon for business. car is a single passenger, David Burnett. Their car is completely full of personal belongings, a blue Jeep Cherokee, back seat folded down crammed full of personal belonging. They have got luggage, golf clubs, things of that nature. As he comes down a hill approximately 23, 24 miles south of Fallon, a flurry of bullets come in. He's under attack. first he thinks it is merely rocks from a dust storm. quickly realizes when he sees sparks out the window he's being shot at. Holes are found in his Jeep back window, side window shattered. There is a hole above the vizor right above his head. He heard the whizzing sound of those bullets. Transmission fluid under the passenger seat was hit. all over. Literally where David Burnett was sitting.

Fearing for their lives, Abe Lee races down the highway north towards Fallon and stops only when he finds the police station. That is when he gets out and sees the extent of the damage. He will tell you looking later he found even his clothing, all things in the back of his vehicle had holes in them, damaged. He's grateful that clothing was back there. His vehicle was chalk full of property. He will testify it was a miracle he was not struck. The Churchill County

investigation of that shooting again two weeks before the murder of John Mr. Castro ensues with Abe Lee's information where they were. Investigators find the scene where they believe the shooting came from October 16th now approximately a day later. They find the scene five hundred feet south of Mile Marker 2 on US 95 between Fallon and Schurz. At the scene they notice several things that are interesting. You will hear from then detective sergeant Jim Steuart who led the investigation. You will hear from investigator Billy Coleman who worked under Jim Steuart. Both arrive at the scene where casings are found, nine shell casings from a 7.62 millimeter bullet. They find a scanner as well, and as they looked further, they find shoe prints in the dirt and dust. The shoe prints have a pattern they are going to mark and diagram. They are able to backtrack the shoe print from the east side of the highway leading back to a dirt road. From this dirt road, they follow the shoe print a little further and they stop. They stop. They find four tire tracks. What is interesting about these tire tracks, three of the four are distinct. Again, the investigators are able to diagram what these tire tracks were like, the pattern. Again, three of the four were different. With those diagrams and having these distinct tread patterns, investigators, that is what they had at the time, some old fashion investigating, at that point a

Hail Mary, if you will. They go parking lot to parking lot, business to business searching cars all throughout the town of Fallon, apartment complexes anywhere they could find the car simply parked to compare. This went on for approximately a month. Again, these two investigations going on simultaneously unbeknownst to one another. Again, two weeks after that scene is diagrammed, the murder happened.

Two weeks later, now mid November, Churchill County gets a break. They find a car with these distinct tread patterns. They find it at the Frontier Plaza right in front of a Radio Shack. Detectives go there, exam the cars as quickly and best they could without giving themselves away with what they are doing. And sergeant Jim Steuart will testify he believes they found it. They surveil the car. They sat and watched it. They ran the car for registration. It was registered to Shawn Harte. 1985 black Honda Accord. watched the vehicle, they watched Mr. Harte exit the Radio Shack, get into the car and drive. They watched for sometime. He eventually goes to an address on Laverne Street in Fallon. 247 Laverne Street. They see Mr. Harte go there a few times. Eventually the car parks there. The night, in the cover of darkness, this location isn't far from the Sheriff's Office in Fallon, in the cover of darkness sergeant Steuart, investigator Coleman and investigator Mark Joseph who you will

hear from as well, go to the residence. It is an apartment complex, if you will. They will testify dogs were barking. They were trying to be guiet. They took photographs. took measurements of this vehicle, the tire pattern, the wheel base width, the width of each tire and guess what? matches. It matches the scene. Detective or investigator Coleman will testify the 7.62 millimeter round casing found at the scene is shot by a few weapons one being an SKS. Investigators also had information Mr. Harte at that time owned an SKS. With that information, investigators obtained a Search Warrant for the house and for the car. They planned this carefully. On November 12, 1997, with sergeant Jim Steuart leading the investigation, they decided to make a stop of Mr. Harte in his vehicle. That stop happens in front of the old Cock and Bull restaurant in Fallon which is no longer there, with Mr. Harte, in the front passenger seat, Latisha Babb and in the back seat is her infant child. Jim Steuart has the stop made in a marked patrol unit. Jim Steuart races to the front to make contact with Mr. Harte. He wanted that eye to eye contact knowing he will be interviewing Mr. Harte and talking to him. He showed Mr. Harte the Search Warrant. had Mr. Harte read the Search Warrant. He explained it to Mr. Harte, told him he was going to be searching his vehicle. Listen to what Mr. Steuart explains about Mr. Harte's

reaction, his demeanor at the time. Nonetheless Mr. Harte complies, exits the vehicle. Mr. Harte willingly goes to the Churchill County Sheriff's Office for an interview with sergeant Steuart. Latisha Babb is driven by another deputy back to the residence at North Laverne Street where officers were there to execute the Search Warrant at that address. The vehicle, Mr. Harte's vehicle, was searched. I mentioned an individual, Charles Lowe from the Washoe County Crime Lab. is a forensic investigator. He came out to Churchill County. At one point, after other officers saw a gun in between the front two seats of Mr. Harte's car, it was a Smith & Wesson 22-caliber pistol. Charles Lowe responds to Churchill County and does what he does to collect the evidence. He collects the firearm which you will see. He collects ammunition with the firearm which you will see. Part of the ammunition found in the vehicle are .22-caliber CCI Stinger rounds. You will hear more about those. Inside the vehicle as well is numerous scanning communication equipment, CB radios.

Again, now at the Laverne address where officers are executing the Search Warrant there, investigator Coleman, now sergeant Coleman, goes to the Laverne address where Mr. Harte is residing where they watch him go and stay the night. Ms. Babb is there. Latisha Babb is there with her infant son or infant child. A search is executed of Mr. Harte's room. They

found brown shoes that have a tread pattern matching the description from the scene. They find a Lahoton Valley newspaper which is the newspaper in Churchill County with the front page article talking about the shooting on US 95 that happened now approximately a month before. They find two rifles, a .22 rifle. They find an SKS rifle, same kind of rifle that shoots 7.62 millimeter rounds. They find documents that were of interest to them. Documents dealing with, Elimination it is called, with content regarding assassination, firearms, and explosives. In the residence they find a map of the Churchill County area. They find highlighted on that map stores and other places with money. You will hear from Mr. Harte, himself, about plans, plans to rob other places to get some money. Then they find something peculiar. Still, at this point, two investigations are going on unknown to each other. They find a single Reno-Gazette Journal article dated October 27th with a front page article about a cab driver who was murdered in Reno, John Castro, Jr., at the residence and then shortly thereafter at the Churchill County Sheriff's office Latisha Babb is interviewed by sergeant Bill Coleman. Based on that, he learns the name of Weston Sirex who worked at a cab company. Mr. Harte is being interviewed at the same time by sergeant Jim Steuart. Mr. Harte is asked to voluntarily go down. He's not under arrest, however, he's

Mirandized. His rights are given to him, explained to him. signs a waiver form. Mr. Harte denies, denies, denies, doesn't know anything about the shooting. He wasn't being asked about the murder at this point. They didn't know about it. But deny, deny, deny about the shooting on US 95. He states he never goes south of town. He had no reason to be south of He wasn't with Weston Sirex that day. The only thing he gives them is he owns an SKS rifle. He doesn't let other people borrow it, and he owns a .22 caliber pistol found in his vehicle between the two front seats. Mr. Harte also references Weston Sirex. He worked for a cab company in Reno. He states, again, this is now November 12th, two weeks earlier Mr. Castro was murdered, he stated the last time he saw Sirex was about two weeks ago. We went to the Circus Circus. You will hear about Circus Circus from the letter written by Mr. Shawn Harte. Throughout the interview, however, Mr. Harte denied, denied, denied. Hence a link is established.

Churchill County investigators contact Mr. Sirex at the cab company he worked for in Reno, the Whittlesea Cab Company. Based on that, a lead is discovered for the murder of John Castro.

An autopsy was performed on Mr. Castro, and you will hear from Dr. Palosaari who was the individual who performed the autopsy. He will explain to you that he determined the

cause of death was a single gunshot wound to the back of Mr. Castro's head. Inside Mr. Castro's skull, within the skull he found a bullet fragment. Now with the link established, a bullet casing found in the front seat of the cab, and now .22-caliber pistol found between the two front seats of Mr. Harte's car, forensic investigators examine those. will hear the transcript testimony from the transcript of Kevin Lattyak who was a forensic investigator at the time. Kevin Lattyak's examined the shell casing found in the front He examined the firearm found in Mr. Harte's vehicle. seat. He compared the two. He made the determination that the casing found in the cab was discharged from Mr. Harte's .22 pistol. Now with that information, Mr. Harte is interviewed again. Detective Jim Beltron leading the investigation in Washoe County for the murder of John Castro, Jr., responded to Churchill County. Mr. Harte is now in custody already under arrest for the Churchill County shooting. Again, he's given his rights, the Miranda waiver form. Mr. Harte agrees to talk. What does he do again? Deny, Deny, Deny. You will hear the interview. Mr. Harte essentially won't say anything until investigators, detective Beltron, can prove to him he already knows what went on, that he knows what happened, that he knows about the plan to rob Mr. Castro, that he knows about the microphone, a body microphone Mr. Harte was wearing so Latisha

Babb could hear everything going on in the cab as she followed closely behind as the get-way driver in Mr. Harte's car.

Detective Beltron explains to Mr. Harte we already know about the fact Reno-Sparks cabs don't have GPS at the time. Harder to track. Only then when Mr. Harte knows he's been caught, knows he's in trouble, does he start to talk. What does he say? Again, ladies and gentlemen, you will hear the entirety of that interview. He admits to the scheme whereby he and Weston Sirex robbed John Castro even using language whether they were going to actually do it, regarding a party, do you still want to party tonight. With the affirmative, the gun was placed to Mr. Castro's head and the trigger pulled. He admits pulling the trigger. He did it to John Castro to rob John Castro. He got approximately \$89 split three ways from Mr. Castro. They go to Circus Circus and spend it that morning.

You will hear evidence Latisha Babb and Weston Sirex received sentences. You will hear what their sentences are. They received a sentence of life without the possibility of parole.

At the conclusion of the State's case, you will also have an opportunity to hear from Mr. Castro's family. They will discuss with you who John Castro was. He was a family man. He was a man who served his country in the United States Army, tours in Vietnam, seen combat time. He worked as a cab

driver to support his family including his two month old son, newborn, Keoni. You will hear about Keoni, what he's doing now years later. Keoni grew up not knowing his father, without his father. You will hear of the huge impact the senseless crime had on Mr. Castro's family. I mentioned in my very first statement about a letter Mr. Harte wrote to his former girl friend, Lanette Bagby. You will hear this letter. You will hear the details of the offense and other plans Mr. Harte had undertaken. It will give you powerful insight into the mind and plans of Mr. Harte. While I won't share with you all the detail, it is approximately a five and a half page letter written about a year after the murder happened to a former girlfriend. He stated this, I will close with these remarks from the words of a convicted killer, Shawn Harte, in referencing the murder of John Castro: "Nothing to it. Just another chore like taking out the trash except easier and funner." Thank you.

THE COURT: Ms. Pusich, you may make your opening statement.

MS. BOND: Good morning, ladies and gentlemen. What you just heard is tragic and it is troubling and it is true. It should never have happened, but you cannot undo it. Before you decide what should happen next in Mr. Harte's life, we think you should know him, who he was and who he is today.

During this trial, you will see that this isn't going to be much like TV or movies. There will be very few interruptions as the evidence comes in. You have already been told Mr. Harte has been convicted. That's not going to be contested. The evidence, the State just explained to you, many of those witnesses testified previously. We know what they are going to say but need more information to make the decision we are asking you to make this week.

You are going to learn that in about 2002 after Mr. Harte had been in custody for a few years, a psychiatric evaluation was performed. The reason that is important is because it was the first time Mr. Harte actually started to come face-to-face with the person he had been. That may be a little hard to believe. At that point, he was about twenty-four, twenty-five years old. You will get information from him about that process and what an eye opening experience that began. Up until that point, Mr. Harte had been in a very violent traumatic existence long before he came across Mr. Castro, long before he met Weston Sirex or Latisha Babb. And he didn't really understand that what life had taught him to do to cope in the world were all the wrong things.

In 1997 and 1998, Mr. Harte would rather be viewed as a sociopath, someone who was mean and violent and unremorseful than admit to himself or anyone else any type of

weakness, any type of vulnerability. There were some reasons for that but what has happened in the last seventeen or eighteen years is that Mr. Harte has come to realize the damage that was done to him and the horrific damage he did to others in the world before he realized there were appropriate ways to cope with what he had been through. As a child, Mr. Harte was not given any of what we might view as the tools to deal with the world. He was trained he should make his life look normal no matter what happened. That was the most important goal of value of his upbringing. From the age of six, Mr. Harte was taken to hospitals and doctors over and over and often for horrible stomach aches and other things. They were sticking him with needles, trying to find out what was wrong and nobody was finding a condition or disease they could treat because what was wrong was how he was being That was the information never given to the doctors treated. or the hospitals.

Interestingly, because they were trying to find out what was wrong, Mr. Harte had the opportunity to meet with many doctors and therapists, but nobody was telling them the truth about what was happening to him and his older brother, five years older. Mr. Harte actually attended eleven different public schools between kindergarten and eleventh grade when he dropped out. He moved repeatedly. Part of it was his father

being in the Navy, but part of it was the instability of the home, itself. He will explain to you the environment he was raised in and his understanding of how that led him to the horrible crime you just heard described, actually the crime, because the shooting in Fallon didn't specifically harm anyone, it was horrible as well. It was very dangerous.

So how do children become killers? There are some things that happen in life and many people are able to survive the traumas of their background without turning to violence as an adult but some do not, and he is one of the ones that did not.

First, you will find out one of his earlier memories, his family just moved to Hawaii. He was six years old. His brother was eleven. They were in a hotel waiting for housing. His brother did something, Shawn doesn't even know what it was, that made his dad unhappy, and his dad punched his brother in the nose. He wasn't badly injured, but it looked terrible. His mother was furious. Instead of saying leave him alone or taking his brother and say let me take care of this, she tells the family he would be better off if he just killed himself. His father tries to dangle, actually did dangle himself over the fifteenth floor balcony of a hotel call the Halakia Hotel. Shawn is distraught. His six year old brother is bleeding. His mother is screaming. His dad is

dangling off the balcony. Mom convinces the dad to come in. They take care of his brother. All Shawn finds from this is if something bad happens, you fix it by making it worse, do something worse. Several years later at fourteen his dad is away. There is a family argument involving his mother and her boyfriend which raised different issues later. We'll talk about that. They are having a discussion, Shawn and the boyfriend, whether Hulk Hogan had been the actor who played Crocodile Dundee. This is not an argument typically important in the world. Kind of a silly argument. Sean had been on the phone talking with his girl friend, made some reference to the boyfriend who was about 250 pounds at the time. He grabs him from behind, behind the neck, yanks him out of the chair, throws him on the floor. You might think that was a traumatic incident. He was used to violence. His girl friend was on the other line. She heard this. Now the family was in a position where there was an outsider who understood what had been going on. He couldn't conceal the fact of this disfunction in his family, but really, the interesting thing from that incident is how his mother responded. She sent him away to a group home, throws him out of the family altogether. He was the person who caused the problem. In the group home he was surround by people who had been cheating. He didn't do that. Cutting school. He didn't do that. Attacking the

others in his family, he didn't do. All he did was embarrass his mother's boyfriend while his dad was out of town. So what he finds out is embarrassing your family, the number one thing, if do you that, you are out. They will just cut you lose.

He learned that the world is unsafe, that you can't trust anybody. That the things that you think are constant and the people you think will protect you, those things aren't there and those people won't.

As you probably know, it is very sad, but some people in the world suffer abuse, children, and obviously the vast majority of them never grow up to kill somebody else thank God, but a huge number of people who do kill other people have suffered violence themselves. It is one of the lessons you learn from a chaotic childhood how to do.

Sean learned early on how to take unfair advantage of others. In the early teen years, he and his mother were in the grocery store in line behind a lady who to him looked to him about 80 years old. She dropped a hundred-dollar bill on the ground. His mother picked it up, didn't say a word. The lady starts to go through check out, and she can't buy all the things. He explained to his mother what she did was unlawful. Later she split it with him. That was a moment of mother-son bonding in his family. You take something that doesn't belong

to you and it is funny, not this is wrong or we need to give this back. Now she realizes she's missing it. At no point in that circumstance did his mother ever say we should give this back or she needs this. At about age 12 or 13 Shawn's dad was actually sent with the Navy to serve in the first Gulf War. While he was gone, that is when his mother started dating someone else. Shawn didn't know all the specifics at the time, but he knew his dad wasn't there. This guy was there all the time and he slept in his mother's room and he was devastated by that, because he thought, that showed him that he couldn't trust anybody. His dad is doing something honorable. I think there were many times it was actually easier for Shawn and mom and brother not to have his dad in the home. He was serving the country, supporting his family. While he was gone, Shawn's mom was entertaining other men in their home. So that was very difficult as well, because he viewed his parents as good people. He wanted to believe in At that point, he didn't feel that he could. By about 1990 his dad has learned some of what has been going on with his mom while he's been away, and his dad was depressed, suicidal, purchased a .38 caliber revolver thinking that might be the end. The Navy gets wind of some of his problems and tells him he should go to AA, doesn't put him in any kind of psychological counseling. It was Shawn's mother abusing

alcohol at that point. Guns were also a constant in Shawn's life. Nothing quite as bad in any circumstances as blending abuse and neglect and psychological problems with firearms, but that is what happened. His first gun was purchased for him by his mother when he was sixteen. He kept it in his room. When he turned seventeen, he was living with a thirty year old girl friend or his surrogate mother. She bought him more guns. The gun used to kill John Castro was one of the gifts he got when he was seventeen. Shortly after that, Shawn decided he needs to get away from the situation. He joined the Army. He was deployed to Korea, served in the DMZ, eventually he gets an honorable discharge. I will give you a little more information about that.

He also ended up meeting Lanette Anderson when he was sixteen. He didn't view his relationship with her seriously committed. At that point in life I am not sure by age or experience that was something he could do, but they had periodic encounters. And while he was serving, Lanette contacted him and told him she was pregnant. Shawn didn't want to be the absent military father his father had been. He decided he needed to separate from the service. That kind of was the beginning of the end. He didn't go in and say I have a pregnant girl friend, I need to go home and take care of her. He decided to lie to his supervisor at that point in Ft.

Campbell Kentucky and said he was suffering hallucinations. They did allow him a separation. They sent him back and he came home. When he returned from his Korean deployment, he learned Lanette had been involved in drugs, and he was very unhappy. He was not someone who had turned to drugs, himself. A lot of abuse and neglected kids do. Shawn avoided that. Ιt was something he was very unhappy about. Lanette miscarried, and he blamed that on drugs. And all things drug related became his enemy. You will also learn he lost his best friend at age fourteen, Joe Molinar, who was shot in the back by drug dealers up in Bremerton, Washington and died as a result. late 1997, Shawn was basically suicidal. He was living lawlessly. He was lying. He was cheating. He was stealing. He expected to be caught and he expected to die in a confrontation with the police, and he didn't care. John Castro's murder was partially the result of Shawn's anger and misery. Every minute of Shawn's anger was focussed on that cab and that firearm that night.

We know John Castro didn't deserve to die. He's out there doing his job. It is a difficult job. It is a vulnerable job. We know the person who knew all those things was Weston Sirex, a fellow cab driver who came up with this idea.

John Castro should be here. He should be here with

his family and loved ones, and there is no one in this courtroom who is going to tell you that that should not happen, but it can't.

In 1997 and 1998 Shawn Harte didn't have any understanding of how his life and upbringing were affecting him. But you are going to find out that today in 2015 he does. In 1997 and 1998 if Shawn looked in a mirror, he didn't recognize the damaged kid looking back. In 2015, he can look in a mirror and he can see a person with respect, to him things he's done in the last 15 years he can be proud of. He certainly never looks in the mirror and feels proud of what he did that night despite the outrageous letter he wrote in 1998.

You are going to learn in 1997 Shawn was arrested and put in jail and he hadn't been in custody before. He was sentence to the group home after he got into the disagreement with his mother's boyfriend. He found a whole new group of people with very different ideas. He met people who had swastikas tattooed on their face. They didn't have anybody like that in the military in 1997. Shawn had a messed up childhood, but the level of disfunction he came across when he went to jail was a whole new level. Some of the other inmates told Shawn he should be proud of what he had done because the victim wasn't a woman or a child. He only knew about jail and prison from TV before he was arrested. And he learned that

letting other inmates know your crime was violent was a way to protect yourself in custody. He wanted to be taken seriously and wanted to be left alone. And he wrote the letter that you have heard described by the District Attorney to Lanette Bagby. A short time later, about probably two or three years after he was first arrested, Shawn was moved to the Nevada Department of Corrections. That is, actually, in Nevada prisons, are the facilities people convicted of violent crimes. Jails are for people waiting for trial or less serious crime. When Shawn got moved, at first he was concerned what am I going to find here. What he found were some people were actually kind and helpful. They weren't that way because Shawn was tough, just because that is who they were.

He started to think of his life and decided to study. He didn't have a high school diploma. The first thing he did was got his diploma. He found he really enjoyed learning. You are going to find he studied calculus, physics some really difficult things. But, honestly, he will explain to you first he was doing those things because it made people think he was smart. He was still focussed on how other people thought of him. Over time, he decided he needed to look at himself and started studying things like philosophy, psychology, religion. He learned those things really well. He's been a published author, wrote some very interesting

articles regarding philosophy and religion. Whether you agree or disagree, you will see some of those and realize these are things he's put a great deal of thought and study into. Those are good things and they help Shawn. But he also learned that he wouldn't be looking at himself well if he didn't contribute to others. So that is not an easy thing to deal with from a prison but he has.

Shawn let himself realize all the things that were wrong with himself and decided he wanted to try and help some other people not go through the same thing. He began counseling other inmates. That is who he lives with now, so that is who he has access to. William Castillo is one of the people, an inmate receiving a sentence for an extraordinarily violent crime. But you will hear in their circumstances

Mr. Harte gave a great deal of helpful advice to Mr. Castillo. He actually writes a letter on his behalf explaining how that helped him. Shawn realized many people in custody had traumatic life experiences that contributed to their ending up in prison, again to focus them as a way to have peace in their lives today and be productive.

You will find he wanted to share his emotional growth and understanding with his mother as well. He realized, looking at his mom and dad, they had things in their background that created the environment they raised him in and

he wanted to try and help. When he called his mother to explain what he felt, what he learned in his progress and asked to share it with her, she wasn't interested in it. His mom retreated even further in alcoholism to deal with her life and his conviction. She told him if he wanted to talk about those things, he didn't need to call her back. He didn't. She died December 26, 2010.

Shawn killed John Castro in 1997, and started behaving like an idiot. In custody he said stupid alarming offensive things. But while he was at the Washoe County Jail, about eighteen months, he was released from his cell in a group of about 112 inmates at one time. If he wanted to hurt someone else or cause trouble, you are going to learn had he wanted to do things like that back in 1997, he had lots of opportunity, and that never happened. He's been at the Ely State Prison now a little over fifteen years. You are going to learn that is a maximum security facility. It is designed to be safe and keep people in and outside safe also. very strict rules. They have a list of things that are called infractions that in the general public, people wouldn't even notice you doing, but they are problems in a prison. keep very tight reigns on everyone. But while there, Shawn has been released in groups with other inmates. He's interacting with staff members, and he's caused no trouble.

His unit, which includes only inmates who have not caused trouble in custody, he has full contact visits. They have access to other people in the world. He's released with 15 other inmates. At a time, once again you are going to learn that he said a really outrageously stupid thing in 1997, 1998 shortly after his arrest, but his actual behavior over the last decade and a half shows you that he has not been causing trouble in prison. You will find he's been doing just the opposite, helping other inmates to take care of themselves and staying out of trouble.

You are going to meet Mr. Harte's fiance, Janine
Marshall. She met him after he was convicted living in Ely
State Prison, and she knows where he is. She knows what he did
seventeen years ago, but tells you who he is today is far more
important to her. She will tell you about the man that she

she's committed to Mr. Harte. He knows he's lucky to have her
love and support. She will tell you that she's lucky to have
him. Shawn Harte today is not the out of control young man he
was in 1997 and 1998. Today he has sponsored three children
overseas. You will see their pictures and hear their stories.
He used some of the money he inherited when his mom died to
send along to a small group of women in India trying to make
their lives better for themselves and their families. And he

did those things before he knew that he would be facing you here today. He did them to help other people, not himself.

 - A Just that it was a missing cab which isn't unusual.

- Q Was it your understanding from the dispatch the cab had been missing for some time?
- A Yeah. Dispatch mentioned that the cab had been missing since sometime around midnight.

- A When I pulled up, it was, it was, dawn was just breaking, so it was still pretty dark. But there was a cab in the travel lane on Cold Springs Drive.  - A Basically blocking the majority of the travel lane.

- A I pulled up behind it, turned on my lights. Of course, since it was blocking the travel lane, people could, you know, there was an obstruction in the roadway. I approached the vehicle to look at the cab.

- A No. Cold Springs Drive is not a very busy road. It is a residential street in the Cold Springs area. Being that early in the morning, there wasn't a lot of commuting traffic yet.

- A I looked in the driver's side window and I saw the cab driver or a person sitting behind the driver's seat slumped over.
 - Q What did you think at that point?

Since he wasn't answering me, that is when I noticed there was an excessive amount of blood coming from his nose and mouth area.

10	Q Good morning, sir, if you could state your first and			
11	last name and spell both for the court reporter?

14	A Yes.			
15	Q What did you do for a living?			
16	A Used to be a truck driver.			
17	Q How long did you drive trucks?			
18	A Twenty-five plus years.			
19	Q Did you also work in a volunteer capacity with a			
20	Fire Department?			
21	A Yes.			
22	Q What department was that?			
23	A Cold Springs Volunteer Fire Department.			
24	Q What years did you work as a volunteer for that			

1 department? 2 Approximately 1990 to 2003. Α To 2003? 3 0 4 Yeah, January. 5 So we are talking fifteen, twenty plus years for 6 that as well? 7 Yes, sir. Α 8 How do you become a volunteer firefighter? 9 Something to do. Back then there was no paid Α department out there, so a lot of times it took 20 minutes for 10 11 a fire truck to come out of Reno or the Stead area. So just 12 basically something to do, too. 13 Did you live, I don't need the exact address, did 14 you live in the Cold Springs area? 15 Α Yes. 16 Did you go through training to become a volunteer 17 firefighter? 18 Α Yes. I don't need a litany, but briefly what did that 19 20 entail? 21 I am State certified. I had to go through the same 2.2 thing paid people did, so I am a Certified Firefighter I 2.3 class. 24 Same thing with the paid people, paid firefighters?

- 1 A Same exact thing. Same thing they do. Training.
- Q What were your responsibilities. Were those
- 3 likewise the same as a paid firefighter?
- 4 A Yes.
- 5 Q What did that include?
- 6 A From fire rescue to fire fighting to medical calls.
- 7 Q Medical calls. Did you, as a volunteer firefighter,
- 9 A Yes.

10 Q Of all different types, right?

respond to medical calls or emergencies?

- 11 A Yes.
- Q Sir, I am going to direct your attention to October
 26th of 1997. I am going to start in the very early morning
 hours of that night.
- Q Were you driving that night and had the opportunity to pass 17865 Cold Springs Drive?
- 18 A Yes, sir.
- 19 Q What time were you driving?

Yes, sir.

- 20 A Approximately 2:00 a.m.
- 21 Q Why were you driving?
- A I was out with a friend. I was taking him home to drop him off so he could go to bed.
- 24 Q You passed that Cold Springs residence we discussed?

1 Α Yes, sir. 2 That is in Washoe County, Nevada? 0 Yes, sir. 3 Α And when you passed that residence, did you see 4 5 anything which in part leads you here to court? 6 Α I saw a Whittlesea, I think it was Whittlesea, I 7 can't remember, Reno-Sparks Cab parked on the Cold Springs 8 Drive there as I was taking this gentleman home. So this is going on seventeen or eighteen years ago? Q 10 Α Correct, sir. 11 Was it a taxicab you saw? Q 12 Yes, sir. Α How was it situated? 13 0 14 It was parked along Cold Springs Drive there. I Α 15 think it was heading northbound. It was parked northbound. 16 Front of the car heading northbound. 17 When you passed the taxi cab at 2:00 o'clock in the 18 morning, anything particular that stuck out to you at that 19 time? 20 Α No. 21 Did you stop your vehicle and do any inspection of 2.2 that cab? 2.3 No, sir. Α 24 Just drove by?

1 Α Yes, sir. 2 Did you end up dropping off your friend? Q Correct, sir. 3 Α What did you do after you dropped your friend off? Q 5 Came back out and just went straight home. 6 Actually, I went to the 7-Eleven first, then I went home after 7 that. From the point of dropping your friend off, to the 9 7-Eleven, and then your home, did you pass that residence again during that time frame? 10 11 Α No. 12 No? 13 Α No. 14 Was there a time later on the morning of October Q 15 26th that you did go back to that cab? 16 Α Correct. Yes, sir. 17 Q Why was that? 18 We were toned out which means alerted to go to a Α 19 medical call on Cold Springs Drive. 20 Q When you say you were toned out, you are now back 21 with the volunteer firefighters? 2.2 Α Yes. 2.3 That is why you responded in that capacity? 24 Α Yes.

1 Did you go to the 17865 Cold Springs Drive 2 residence? Yes, sir. 3 Α When you got there, did you see what appeared to be 5 the same cab? 6 Α Yes, sir. 7 Did it appear to you it moved at all from the time you saw it at 2:00 a.m.? No, sir. Α I may have missed it, approximately what time was it 10 11 you responded back to that cab? 12 7:00 o'clock area. In the morning area. 13 7:00 o'clock in the morning? 14 Yes. Α 15 When you were toned out, that would be as you say, 16 for a medical call? 17 Yes, sir. Α 18 What did you do or what did you see upon your Q 19 arrival? 20 Α The taxicab still sitting in the area that I saw it 21 earlier that morning. And then I walked up to the vehicle. 2.2 Our qualified medical people were there, so I did crowd 2.3 control. As I walked back by, they were still working on the 24 gentleman.

1	Q	They being who?
2	A	The EMT's and the medical. They were more qualified
3	than I was	5 .
4	Q	Did you do any hands-on medical care
5	A	No, sir.
6	Q	with the gentleman? All right. Were you close
7	enough to	the gentleman to hear anything which caught your
8	attention'	?
9	A	Just a little bit. The whistling coming out of his,
10	you know,	out of his mouth.
11	Q	When you say out of his mouth, the gentleman being
12	worked on	?
13	A	Yes, sir, the victim.
14	Q	Did you know that individual at all?
15	A	No, sir.
16		MR. YOUNG: Your Honor, that is all the questions.
17	Thank you,	, Mr. Holst.
18		THE COURT: Cross-examination.
19		
20		CROSS-EXAMINATION
21	BY MS. PUS	SICH:
22	Q	Good morning. Do you need a drink of water?
23	A	Oh, no. I have got one here. Thank you.
24	Q	At 2:00 o'clock in the morning back on October 26,

1 1997, you did not notice anyone in the cab, correct? 2 No, ma'am. Α You had some training in medical response and 3 emergencies, right? 4 5 Yes, ma'am. 6 If you had seen someone needing help, would you have 7 tried to help them? Yes, ma'am. You never knew there was someone there at that time? Q 10 No, ma'am. I didn't notice. Α 11 By the time you responded the next morning, they 12 actually have EMTs and other people with more training than 13 yours? 14 Yes, ma'am. 15 MS. PUSICH: Thank you, sir. Thank you, Your Honor. 16 THE COURT: Anything further? 17 18 REDIRECT EXAMINATION BY MR. YOUNG: 19 20 Again, 2:00 a.m. when you were driving past that cab 21 the first time, did you stop at all to inspect the cab? 2.2 Α No, sir. 2.3 You just drove by and went on your way? 24 Yes, sir. Α

1 Nothing unusual about the cab at that particular 2 point to you? No, sir. 3 Α Thank you, Your Honor. MR. YOUNG: 5 THE COURT: Anything further? 6 MS. PUSICH: No thank you. 7 THE COURT: May this witness be excused? 8 MS. PUSICH: Yes, Your Honor. 9 MR. YOUNG: Yes, Your Honor. 10 THE COURT: Thank you, sir. You may step down. You 11 are excused. 12 (Witness Excused.) 13 THE COURT: You may call your next witness. 14 MR. LEE: The next witness will be by transcript, 15 Exhibit 55. Mr. Roy Stralla will be here to read that. And I 16 quess we'll call Roy Stralla. 17 MS. PUSICH: This will be Jerome Vaughn 18 THE CLERK: I am sorry, I didn't hear who you 19 called. 20 THE COURT: Jerome Vaughn, that is what you will be 21 reading? 2.2 MR. STRALLA: Yes, Your Honor. 2.3 THE COURT: Ladies and gentleman of the jury, you 24 are about to hear testimony that was recorded on a prior

15	BY MR. LEE:
16	Q From Exhibit 55. Could you please state your full
17	name and spell your last name, sir?
18	A Jerome Vaughn, V-A-U-G-H-N.
19	Q What do you do for a living, Mr. Vaughn?
20	A I am a part time bartender and part time cab driver.
21	Q What cab company do you work for?
22	A Reno-Sparks.
23	Q Were you working for Reno-Sparks Cab Company in
2.4	October 1997?

- 1 A Yes, I was.
 - Q At that time, were you what is known as a road boss?
- 3 A Yes.

- Q Describe for me what a road boss is?
 - A Kind of a supervisor that takes care of problems, customer complaints, driver complaints, break down of the cab, so on and so forth.
 - Q Would it be fair to say if a cab breaks down, you would go out, at least help the driver, pick him up, something like that?
 - A Yes. The road boss determines whether to have the driver drive the cab to the lot or have it towed or whatever.
 - Q How long have you been a cab driver?
 - A About two and a half years full and part time.
 - Q What does a cab driver need to go out and do on his daily business? What would you expect a cab driver to have based on your personal experience?
 - A You go in and get your trip sheet which you log your trips on, your keys, go out and take your cab, take certain readings off the meter.
 - Q Let's take that one at a time. What is a trip sheet, more specifically?
 - A It is a sheet that has certain Information about the meter. You log each trip, each call that you take, each fare

that you take that you have.

- Q Each time that you have a fare, what would you write down on the trip sheet? Let's say somebody is going to the location. When they get there, what does the cab driver write down?
- A Say for example I was sent to a home address and I am going downtown to Harrahs. You write down the address of where you made the pickup, and the discontinuation would be Harrahs.
- Q Does the cab driver need money?
- 11 A Well, you have some for change.
- 12 | Q Were you working on October 26, 1997, Mr. Vaughn?
- 13 A Yes, I was.
- 14 Q Do you recall what shift you were working on that 15 day?
- 16 A I worked the day shift from 5:00 a.m. to 5:00 p.m.
 - Q When you work from 5:00 a.m. to 5:00 p.m., what time do you get to work, usually?
 - A Well, I usually get there a little early. On that particular day, around 4:30 normally I would get there.
- Q On October 26th, you arrived at about 4:30 at the cab company?
- 23 A Yes, sir.
- Q Was everything normal at the cab company to the best

of your recollection?

- A Well, when I arrived, it was found out some things after, you know, after I got there.
 - Q Did you know John Castro?
- A Yes, I did.
 - Q And how did you know him?

- 11 A Approximately, I guess, a year, year and a half or 12 something.
 - Q Based on your previous testimony, would it be fair to say you were not close personal friends with him? He was just somebody you worked with?
- 16 A Right.
 - Q On October 26, 1997, when you got to work, what was it that was unusual that you found out?
 - A Well, I went to the dispatch office to check and see if there was things pending. As I said, I was the road boss. I found that John Castro and his cab had not been heard from since around midnight.
 - Q Midnight, that would be roughly the 25th of October to the 26th, around there?

A Right. Right.

- Q With that information now at approximately 4:30 to 5:00 o'clock, he had been missing for almost five hours, what did you do?
- A Well, I asked them if they had done anything. They said no. So I told the dispatcher to notify all the law enforcement agencies in the area, Reno, Sparks, Washoe County, Highway Patrol, check the hospitals.
 - Q Did you ask dispatch where his last call was?
- 10 A Yes, I did.
 - Q With that information, where did you go?
- 12 A I went to the location they are me which was the
 13 Speedy Mart convenience store at the corner of Neil and
 14 Peckham.
 - Q Is that here in Washoe County, State of Nevada?
- 16 A Yes.
- Q Was Mr. Castro there?
- 18 A No.
- Q After you found out that Mr. Castro was not there at the Speedway Market, the Speedy Mart as you refer to it, what steps did you take next?
- A Well, I talked to the clerk at the market, also a security guard that was on duty there.
- Q Okay. Don't tell me what those people said to you,

- but Mr. Mr. Castro, did you know where he was after talking to them?
- 3 | A No.

- 4 Q What did you do next?
 - A I called on my radio, told the dispatcher to ask for volunteers, start a search, restaurants, casinos, places he might have gone to eat, whatever. I also started to searching myself.
 - Q Where did you go to search for Mr. Mr. Castro?
- 10 A First place I went was the Atlantis casino.
- 11 Q That is pretty close in proximity to the Speedway
 12 Market, correct?
- 13 A Yes, sir.
- Q Why did you go there?
 - A Just a place to start. He might have gone there to eat or whatever. We had no idea where he was.
 - Q And you had told other cab drivers to be on the lookout for this cab as well?
- 19 A Yes.
- Q Did you tell them what cab number he was driving,
 give a physical description of Mr. Castro?
- 22 A Well, no. We basically were looking for the cab.
- Q Okay. So people knew what to look for; is that correct?

1 Α Yes, sir. 2 Approximately what time did you start this search for Mr. Castro? 3 Right at 5:00 o'clock give or take a few minutes. 5 Did there come a time on October 26, 1997 when you 6 saw Mr. Castro? 7 Α Yes. Excuse me. When you saw John Castro? 9 Yes. Α Where was that? 10 Q 11 In Cold Springs. I don't recall the address. Α 12 Is Cold Springs here in Washoe County? 13 Α Yes, sir. 14 Okay. Do you recall approximately what time you 15 went to Cold Springs? 16 Just about 7:00 o'clock, 7:00 a.m. 17 Why did you go there? 18 I was told by the dispatcher the cab had been Α 19 located. 20 So you went out to Cold Springs? 21 Α Yes. What did you see when you first got there? 2.2 2.3 When I arrived, there was an area that was taped Α 24 with police tape, a cab sitting approximately twenty,

- twenty-five yards inside the police tape. Some deputies there,
 deputy sheriffs.
 - Q Were you familiar with the cab?
 - A Yes, I was.
- 5 Q Was it a Reno-Sparks cab?
- 6 A Yes.

- Q Was it the cab that John Castro was driving when last heard from on October 25th, 26th in those early morning hours, 1997?
- 10 A Yes, it was.
- 11 Q Did you actually see Mr. Castro?
- 12 A I saw the back of him. I didn't see him.
- Q Could you tell it was him?
- 14 A I thought it was.
- 16 A He was in the cab sitting propped up or whatever.
- They were working on him. The sheriff, deputy sheriff and the Truckee Meadows Fire Department.
- 19 Q The Cold Springs area where he's found, how far away
 20 is that just based on your knowledge from here and downtown
 21 Reno?
- 22 A Twenty miles.
- 23 Q Is it in a valley or hilly area?
- 24 A Well, it's flat. There are some hills.

1 Have you ever driven out there, taken a fare out to 2 Cold Springs? No, I don't believe I have. 3 What type of cars were you driving or was 5 Reno-Sparks Cab Company driving back in 1997? 6 Mostly LTDs, Ford LTDs or Crown Victorias, excuse 7 me. Crown Victorias? Α Yes. Were they equipped with any type of location 10 11 devices? 12 Α No. 13 Based on your knowledge, did that type of equipment 14 exist in 1997? I believe it did. I think one cab company here in 15 Reno had that existing. 16 17 Is that known as GPS, the global positioning system 18 as far as you know? 19 Α I believe so. 20 But Reno-Sparks Cab Company didn't have that? 21 No. Α Based on your experience, would it be unusual for a 2.2 2.3 cab driver to pick up two people and have them ask him to 24 drive them out to Cold Springs?

1	A Yeah, I think it would be normal.
2	Q If a cab driver had been working his normal shift as
3	Mr. Castro was, would it be unusual for him to have money on
4	his person?
5	A Yes, he should have.
6	Q Would there be any reason for Mr. Castro to go back
7	into the Reno-Sparks Cab Company and leave his money there
8	while he
9	MS. PUSICH: Your Honor, he's been leading the
10	witness a long time. We object to leading questions.
11	THE COURT: Okay. Objection sustained.
12	BY MR. LEE:
13	Q Would there be a reason that somebody would have to
14	go drop their own money at the cab company?
15	A No.
16	MR. LEE: Court's indulgence. Nothing further, Your
17	Honor.
18	THE COURT: Cross-examination?
19	MS. PUSICH: Yes, Your Honor.
20	
21	CROSS-EXAMINATION
22	BY MS. PUSICH:
23	Q Sir, you indicated that you were the road boss
24	beginning what, 5:00 in the morning; is that what you said?

1 A Yes, sir.

- Q Who was the road boss before that between say midnight to 4:00?
- A I don't know who was on duty that night. I didn't check.
 - Q But in any event, the road boss didn't do anything to look for that cab, correct?

 - Q Sir, when you started to look for the cab, you indicated you spoke to a security guard, correct?
- 12 A Yes, sir.
 - Q And after that conversation, you had gotten a description of two people; is that correct?
 - A I don't know about description. They said there was two people he picked up there.
 - Q Sir, did you later give a statement to the Washoe County Sheriff's Department?
 - A I talked to I believe a lieutenant that was at the scene where the cab was found.
- Q Sir, do you recall a description of the gentleman
 who entered the cab?
- 23 A I was told.
- 24 Q And from that, did you give that statement to the

1 police? 2 Α Yes. Sir, you also indicated earlier you knew Mr. Castro; 3 is that correct? 5 I am sorry, I didn't hear that question. 6 Q That you had known Mr. Castro? 7 Just through work, yes. Α You didn't know him personally, though? 9 No. Α Sir, with respect to the trip sheets that you 10 Q 11 indicated that each cab driver picks up, is that correct, when 12 they start work? 13 Α Yes. 14 Did you recover that trip sheet, yourself? 15 No. 16 Sir, when you arrived at the Cold Springs address at 17 7:00 a.m., do you recall whether or not the vehicle that you 18 said was the Reno-Sparks cab that you recognized was running 19 or not? 20 I don't believe it was. I was never allowed, you 21 know, close to the cab. 2.2 Mr. Vaughn, when a cab picks up a call or dispatch, 2.3 you indicated they write it down on their log as to who they 24 picked up and where they are going to?

- 1 A Yes, sir.
- 2 Q Do they write down both, how many passengers?
- 3 A Yes, sir.
- Q Do you write down the nationality of the passenger?
- 5 A I am sorry, what is that?
 - Q Do they write down the nationality of the passenger?
- 7 A No.

- 8 Q Indicate whether they are female or male?
- 9 A No.
- 10 Q If they receive a fare, do they call into dispatch 11 and advise where they are going?
- 12 A No.
- 13 O Never?
- 14 A Not that I know of unless maybe -- We are required
 15 now to call in any out of town trips, but not anything out of
 16 Washoe County.
 - Q The dispatcher I thought would kind of keep an idea as to where the taxis are going so they might get a fare for a return trip from that area?
 - A No.
 - Q Do they call in after they reach a destination?
- A Well, now we use computers. When you reach the destination, terminate the trip, you punch in your computer what location you are in.

1 In October 1997, they didn't have that computer 2 system in effect? Yes, we did, yeah. 3 Would the computer system have known where Mr. 5 Castro was going? 6 Α No. 7 Do the cab drivers own their own taxis? No. No. They have lease agreements. So the cab company actually owns the Ford LTDs. Q 10 They owned it? 11 Yes, sir. Α 12 Mr. Castro leased it? They have lease and company employee's. I don't 13 know which one Mr. Castro worked under. 14 15 Does more than one cabby operate the same taxi? 16 Yes. They usually have two shifts. 17 The cabs are on the road basically twelve hours a Q day with two shifts? 18 19 Well 24 hours a day with two shifts. Two twelve-20 hour shifts. One cab has two twelve-hour shifts? 21 2.2 Right. Α 2.3 Mr. Castro would have been, in theory, on shift for twelve hours? 24

1 Α I guess so. Do you know when he came on shift that day? 2 No, I don't. He was working the night shift. I 3 don't know. 4 5 You don't know. Do they vary? Do they have a 6 standard break like midnight to 12:00? 7 Well, they have shifts. One might start at 4:00 or 5:00, and then 6:00. That way you always have cabs out on the road. You don't have everybody coming in, you know, ending 10 their shift. 11 And you went down to the Atlantis as the first place 12 to look for Mr. Castro? 13 Α Yes. 14 Is that a hangout for cab drivers? Do they eat 15 there, gamble there? 16 No. I was looking any place he might have stopped 17 to eat, take a break or whatever. 18 Did you go inside or drive around looking for the Q 19 cab? 20 Α I drove around through the parking lot. 21 Are the cabs marked distinctly? 2.2 Yes. Α

Of course Reno-Sparks and the number.

They don't really call in. They 19 basically work on the computer. 2.0 Q Okay. You know what the computer then tells you 21 about where the cabbie is reporting? 2.2 Yes, sir. Α 2.3 You don't know what he's doing in between then?

1 He's free to take breaks, eat, do anything he wants 2 at any time? 3 Α Yes. Basically they are pretty free to run their shift 5 any way they want; is that fair? 6 Α Yes, sir. 7 Now when you came on at 5:00 o'clock, you were concerned about this cab and why it was missing, right? Α Yes. And you did some investigation of your own? 10 11 Right. Α 12 You did go to the Speed Way Market? 13 Α Yes. 14 Why did you go there? 1 Okay. Did you talk to anybody else as far as you 2 know? 3 Α No. What were you trying to find out when you 4 5 were speaking to them? Just find out, check and see if there is anything I 6 7 find out where John might be. Okay. Any information that you could get to follow 8 up from there? I am sorry? 10 Α Right. 11 Eventually, you ended up out at Cold Springs, Q 12 correct? 13 Yes, sir. Α 14 At some point, of course, as counsel took you 15 through, you found the cab and ended up speaking to the police 16 in this matter? 17 Yes. Α 18 Did you tell the police the result of your Q 19 investigation? 20 Yes, I did. That is when I started 13 the mortgage. 14 That's when you started what? I imagine there were fragments after impact where a bullet would go. That is why we heard multiple. 10 11 The only bullet hole you saw in the front windshield 12 was this one, but you heard several whizzes? 1.3 Α Yes. 14 You think those might be pieces of things that were 15 the shattered windshield or the vizor clip? 16 No. They were actually fragments of the bullets. 17 The police told me -- They showed me my car afterwards. You 18 could see it took them hours to pick off all the steel 19 shrapnel from the bullets. 2.0 So pieces, fragments of the same bullet? 21 I don't know if it was one or two bullets, Yeah. 2.2 whatever got through. 2.3 I missed something at the end of your direct

I had also done some reserve time with the Fallon 14 Police Department. I started my career with Mineral County 15 Sheriff's Department, was hired on with Fallon Police 16 Department and then from there I went to the Churchill County 17 Sheriff's Office. 18 How long were you with Churchill County? 19 Α Approximately seventeen years. 20 Q What position or assignment did you retire from in 21 2005? Sergeant of Investigations, Supervisor for 2.2 2.3 Investigations. 24 How long were you in that position?

A I was in Investigations for seventeen years, right at seventeen years, then supervisor for approximately six.

Q What were your duties as a supervisor of the Investigations Division?

A You have to oversee and be aware of all cases that came into the department. Even the cases generated by the Patrol Division. Send any paperwork to the District Attorney's Office, and coordinate with the District Attorney's Office on any of the major crimes, and the core preparation, things of that nature. Also to supervise investigations. Sometimes actively investigating the case myself, but also supervising other investigators as they investigated the case.

- Q Were you in that capacity as the Investigations sergeant in October 1997?
 - A Yes, I was.

- Q Do you recall the incident on US 95 October 14, October 15, 1997?
 - A Yes, I do.
 - Q What role did you play in that investigation?
- A On October 14th late at night probably close to midnight that night, I was home and I had received a call from the office, Sheriff's Office that there was a report of a shooting that occurred on US 95 south, south of Fallon, and they were requesting that I come in and investigate, which I

did.

- Q Where did you stop first? Where did you go first as part of your investigation? Did you respond to the Sheriff's Office?
 - A I responded to the Sheriff's Office.
- Q Excuse me just a moment, please. With respect to that shooting and the investigation, did you have an assignment in that? Were you the lead detective or investigator?
- A I was going to be the lead investigator or supervisor for that investigation which would consist of supervising other members of our department and the investigation team.
- Q So if someone is giving out assignments with regard to that investigation, was it you?
 - A It would have been me, yes.
- Q So you mentioned the early morning hours of the 15th of October that you responded, you got that cal and responded into the Sheriff's Office. What did you see? Was there a vehicle?
- A I had met with the people that had reported the shooting out on the highway. They were there at the Sheriff's office. Their vehicle was parked in our parking lot.
 - Q Do you recall an individual named Abraham Lee?

A Yes, I do.

- Q Do you recall what his or his passenger's demeanor was like?
- A He was upset. He was scared. He had told me upon my arrival that him and his friend, David, were driving northbound south of Fallon coming toward Fallon. It was nighttime, and someone had shot at his vehicle.
- Q As a result of that, did you take a look at the vehicle, yourself?
 - A Yes, I did.
- Q What did you see on that vehicle just briefly and generally?
- A There was actually a total of five bullet type holes in the vehicle and in the glass. The passenger door, the splash plate underneath the door had damage to it. The rear quarter panel on the passenger side had a hole in it and damage. The window on the passenger side but at the rear of the vehicle also had damage to it, and then the rear window at the rear of the vehicle had a hole in it or damage. If I remember correctly, there was damage to the front windshield, but that was determined caused by projectiles that passed through the vehicle.
- Q Mr. Steuart, at that point, just after that, after talking with Mr. Lee, his passenger and looking at the Jeep

1 itself, did you have any leads on that, any suspect right off the bat? 2 3 Α No. What was the next thing that happened in the case? 5 Well, after interviewing with Abe Lee, we secured 6 his vehicle to process it in the morning, and then for the 7 next three or four weeks --Let me back you up before that time, actually. the 16th of October were you informed that a possible scene of the shooting was done? 10 11 Yes. We started checking the highway south of 12 Fallon is what we did. 1.3 Were you informed by another officer, anyway, a 14 possible scene was located? 15 That would have been on the 16th, two days 16 We had search and rescue, other officers, reserve 17 officers walking the highway south of Fallon. 18 Did you respond out to that scene? 19 Yes. Investigator Coleman and I responded to the 20 area where they had located some evidence indicating the 21 shooting had occurred. 2.2 Investigator Coleman, is that Bill Coleman? Bill Coleman. 2.3 Α

With regard to that scene, what did you find? Why

did you guys believe that was the scene of the shooting?

A We had found nine expended shell casings and a scanner, portable type scanner laying on the embankment of the highway, the dirt embankment of the highway. The shoulder I guess you could say, but it was quite an embankment. Those items were located in that location.

In addition to that, we could see impressions in the soft soil as if someone had been laying in the soil or moving around in the dirt along that embankment.

- Q Do you recall the nine casings, what they were?
- A The shell casings were 7.62 caliber.
- Q Did you also see prints, any other prints in the area?
- A We found a shoe impression that led to a dirt road that ran somewhat parallel but distanced itself from the highway.
 - Q Did those prints lead you to that road?
 - A Investigator -- Yes, it did.
- Q On that road, did you see other markings that were of interest to you?
- A We found tire tracks. A set of tire tracks. We backtracked the shoe impressions to the dirt road, and at that location, we had found where a vehicle had come down that road. So we found tire tracks and where a vehicle had turned

around and then drove forward like back toward the highway and then stopped. And that is where the shoe impressions had taken us to that location.

- Q Was there anything unique about those tire tracks?
- A Oh, the tire tracks, we noted the two front tires, the left and the right front tires had a street type tread with three distinct or three lines that actually went around the entire tire. So there was three lines. The right rear tire was somewhat of a mud or snow type tire, and the left rear tire was somewhat of the street type tire only with four lines going around the tire. So out of four tires, it had three different types of tire tread on that vehicle.
- Q Did you direct someone to diagram the impressions of the tires?
- A The impressions of the tires and the shoe impressions. I had investigator Bill Coleman do that.
- Q Okay. Then on October 16th then, beside the Jeep, you have the shoe prints, the casing, the tire tracks. Any suspect at that point?
 - A No suspects.

- Q What was the plan then at that point? How did the investigation further?
- A Now that we had tire tracks, we started -- This was not an effort to identify any one person. It was a collective

effort on a lot of personnel from our department, but we started checking public parking lots, apartment complexes anywhere you could park the car we were looking at tires to find that combination of tire tread, you know, on a vehicle. And we did that for probably a couple of weeks or so.

Q Was this something a lot of law enforcement officers had a diagram of the tire treads they were just randomly looking at?

A I don't remember if we actually gave to each officer a diagram. You know, we showed them probably pictures, photos of the tire impressions that we had found located out at the scene, and coupled with showing diagrams to officers, and then many of us just walking the parking lots during the day and at night.

- Q About a month after the shooting, middle portion of November, did you respond to the Frontier Plaza?
 - A Yes, I did.

- Q What did you find there?
- A There was a vehicle parked in the Frontier Plaza. The Frontier Plaza has several stores, and it is just an open parking lot. But the vehicle in question that was parked in the parking lot had tire treads at the scene, that was consistent with what we found out at the scene on US 95 in what was one of the stores that was in the Frontier Plaza.

- Q Was the registration run on the vehicle?
- A Yes, it was.
 - Q Who did it come back registered to?
 - A Registered to Shawn Harte.
 - Q After that then you see the vehicle. Did a swarm of officers come and surround the vehicle at that point?
 - A No, we didn't.
- Q What happened?
 - A We were at the early stages of identifying this vehicle and the registered owner, and we also wanted to make sure that we had the right vehicle, the tire tread design.

 And so there was some investigation going on as far as that goes. We photographed or I photographed the tires in the parking lot when the vehicle was parked in the Radio Shack parking lot at Frontier Plaza.

Aimme Lane and also 247 south -- North Laverne Street which is an apartment.

- Q How far is North Laverne street from the Sheriff's Office?
 - A Only a few blocks.

- Q One of the nights was this vehicle parked there overnight, at least in the dark?
- A It was. The vehicle was parked at the North Laverne apartment address at night overnight.
- Q Did you and other investigators then seek anymore confirmation that this was the vehicle while it was parked at the North Laverne address?
- A Yes, we did. Myself, investigator Bill Coleman and investigator Mark Joseph, at night we went over to the apartment complex and walked up to the vehicle. We, again I again photographed the tires to be sure we had also gotten -- we had also brought a tape measure along with us and measured the wheel base of the vehicle and then left the area.
- Q Based on those measurements and everything, what did you believe?
- A We felt that we had the right vehicle that was on the dirt road south of 95 as far as the tire tracks that we had found out there.
 - Q Was that under the cover of darkness you went and

did that at Laverne?

 - A No, it wasn't.
- Q So then after you had that information, what did you -- what did your investigation lead to next?

A That morning, that next morning, I believe that would have been the 12th of November, I had the photos developed and, again, we looked or I looked at the photos of the tires that were on this vehicle and the tire impressions that we had photographed and diagramed out at the scene south of 95. They were consistent with each other, and so I went to the District Attorney's office to obtain Search Warrants.

- Q At that point, did you have a tip on ownership of a weapon?
- A During that time when we initially had seen the vehicle parked in the Radio Shack parking lot and ran the registration, we had a tip that the registered owner, Shawn Harte, worked, was employed at Radio Shack and that he had made— he had, in conversation, told people that he had an SKS rifle.
- Q With all that information, is that how you obtained the search warrant?

A That's correct.

Q Where were you intending on searching? What locations?

A We wanted to search the vehicle, the 1985 Honda Accord registered to Shawn Harte. We wanted to search the apartment at 247 Laverne Street, and contained within the Search Warrant was an address of 1051 Aimme Lane there in Fallon which was Shawn Harte mother's residence.

Q With those Search Warrants then what was the plan?
How were they all to be executed?

A The plan that we came up with after that, for almost two days we had done surveillance on the vehicle and watched Shawn Harte leave work, go to the Aimme Lane address and also go to the North North Laverne address. So on the 12th, that evening, I had planned a traffic stop. That I would have a patrol officer make a traffic stop on Shawn Harte's vehicle after work, and then I would show him the Search Warrants that I had obtained for his vehicle, the apartment and the house.

Q Did everything go smooth with that stop of the vehicle?

A Everything went smooth as far as the stop of the vehicle except for one thing. Not knowing where someone is going to go when you are tailing them or doing surveillance, he had left work, driven over to the Aimme Lane address and

then from Aimme Lane just a couple blocks away he left that address, too. He was only there momentarily. And then he turned, and he went to a restaurant there in Fallon on the end of town that is called Cock & Bull, and he stopped there.

Q At this time, what was going on?

I designated a patrol deputy to make the stop upon my command, my order. I had investigator Bill Coleman, investigator Mark Joseph out with us also at the Sheriff's Office. You had the Sheriff, Undersheriff, the Captains and agent Kip Steel from the FBI. So we had a lot of officers not just the ones I named. There were several others. plan was to make this traffic stop as safe as possible, show Shawn Harte the paperwork, the Search Warrants and then go from there. And when Shawn had made a right turn to go south on South Taylor Street and then immediately turned into Cock & Bull. It kind of threw things off a little bit. We didn't know what was going on. We knew he had occupants and other people in the vehicle. I had called into advise my supervisors back at the Sheriff's Office and said, hey, this is what is happening out here. And a Captain had come back over the radio, and because it wasn't -- it was going according to plan but it wasn't, he instructed me to abort the mission, not make the traffic stop and we would replan something. But he said abort the mission over the radio.

- Q At that point, did you abort the mission?
- A As he was saying that over the radio, I observed Shawn Harte coming out of the Cock & Bull restaurant and getting into his car. That stop was only momentary. With no disrespect meant or anything, I got back on the radio, and I was a Sergeant, I told the Captain negative, and I gave the order to make the traffic stop. From that point on, we were back on schedule. Everything was going as we had planned.
 - Q Was that on November 12th of '97?
- A November 12, 1997.

- Q Again, you didn't light the vehicle up, meaning you didn't make the stop, another deputy made the stop?
- A I had a deputy, patrol deputy in a marked unit with red lights to make the stop.
 - Q Who was the first to make contact with Mr. Harte?
- A I was. That was the other part of the plan that I was the supervisor in charge and I wanted-- and I knew I would be interviewing Shawn Harte back at the Sheriff's office. FBI agent Steel and myself would be conducting an interview. I also had the paperwork, the Search Warrant, and I wanted to make, first make contact with Shawn Harte to develop a rapport with him and talk and explain to him the Search Warrant process.
 - Q Was he in the driver's seat of the vehicle?

- A Shawn Harte was identified and was in the driver's seat of the 1985 Honda Accord.

 Q Do you see Mr. Harte in the courtroom today?

 A Yes, I do.

 Q Could you please identify Mr. Harte for us?

 A The light blue shirt sitting at this table over here in the center.

- A I showed Shawn the original search and seizure warrant and had him read it and asked him if— after he was done reading it, I asked him if he understood the warrant, and he stated yes.
- Q What did you state to him regarding his custody status at the time?

A I told him he was not under arrest. At this point in time in the investigation, we were confident that the tire impressions that were left out at the scene were very consistent with the tires on this vehicle. With the other information as far as Shawn Harte owning a rifle, we -- I was not going to arrest him. I wanted to interview him and find out what took place, what happened or if he was connected or knew anything about the shooting that had occurred on South 95. He was not under arrest. He was not handcuffed. One of the things I did ask him was if he had any weapons in the car.

- Q What did he say?
- A He told me, yes, he had a .22 pistol in between the front and the front passenger seat. The driver and the passenger seat.
 - Q Did you request Mr. Harte go with you to the

Churchill County Sheriff's Office for an interview?

A I told him he could ride with us to the Sheriff's Office which was only maybe a mile, little over a mile away. It was all in close proximity and ride with myself and investigator Bill Coleman, and if he would give permission for a deputy to drive his vehicle to the Sheriff's office so we could conduct the search. At the Sheriff's Office we would obtain his fingerprints and then do an interview.

- Q Did he go with you?
- A Yes, he did.

- 2 Q Did he tell you where Weston worked?

A Yes, it did. We had several, the Department had several things going on, and I would be stepping out of the interview room on occasion to find out what was happening at the Laverne Street address, what was going on with other deputies and investigators that had assignments. I was informed we also had two officers going to Reno to meet up with a Washoe County detective and locate Shawn's friend, Weston. We also had another deputy going to Reno to the Washoe County lab to meet with a lab tech.

Q Based on, without even going there, based on the results of all of those, did you place Mr. Harte under arrest?

A Yes. About the last time I stepped out of the interview room between 10:00 and 10:30 that evening, I was discussing with my supervisor, the Sheriff, the Undersheriff the collection of information that we were obtaining in those hours, evening hours, and Shawn Harte. Q Describe those, if you could?

A Searchers located shoe tracks leading away from this position beside the road. We back tracked the shoes that basically were a flat sole type of deck shoe, if you will. It had a horizontal wavy line extending from one side to the other. It was pretty distinctive because it had a line that circled the entire circumference of the shoe print, itself.

- Q Did these -- Was it a random shoe print or did it go somewhere?
- A It was definitely leading away from the highway and it crossed through a fence approximately -- If I could describe the scene a little?
 - O Please?

A The highway, itself, had an asphalt type curb beside it. And then it was a dirt shoulder, and then it was a very steep, about 27 foot embankment that went down. About 40 feet later there was a barbed wire fence which is common among highways to keep the cattle off the road. We followed the single set of shoe tracks from the highway area down through the fence in an easterly direction towards a dirt road.

- Q Did that dirt road ever lead back to the highway?
- A It does. It intersects with the highway. It is actually a dirt road that we believe was used by N.S. Fallon

1 for the workers on the range. Did you follow the tracks back to the road? 2 Back to the dirt road from the highway, yes. 3 From the highway back to the dirt road. About how 5 far did you follow he shoe tracks? 6 Altogether about 150 yards to the road. The dirt 7 road, itself. On the dirt road, did the tracks continue? Yes, sir. For about a tenth of a mile still in an 10 easterly direction. 11 Then what happened? 12 We actually found where the shoe tracks lead us to 13 some vehicle tracks that were along the dirt road, itself. 14 And it appeared that whoever made the shoe tracks actually 15 exited the vehicle at that point. 16 Were the shoe tracks leading to the highway or from 17 the highway? 18 From the highway. Α 19 Q From the highway to the dirt road? 20 Α Correct. 21 Is that location on the dirt road you just described where the shoe tracks ended? 2.2 2.3 Yes, sir. Α

What did you pick up at that point?

1 We followed the vehicle tracks. And the vehicle tracks were pretty unique. If I may? 2 Describe that? 3 Well, the vehicle tracks had mixed matched tires. 5 It was pretty easy to determine that the same vehicle had 6 three different sets of tires on it. Actually different sizes as well. Were they easily visible in the dirt? Yes, sir. Α Did you do anything with the scene there, 10 11 specifically with the shoe prints and the tire tracks? 12 Yes, sir, I did. I diagramed both the shoe tracks 13 and the vehicle tracks. 14 MR. - A Yes, sir. The top two tracks represent the front tires of the motor vehicle tracks that we found. As you can see, they are both the same type of tread pattern.

- Q Can you see that okay?

- A We did. The outside outside wheel base was sixty-four inches. I believe the inside inside was fifty and

- Q Explain then the rear tires that we see.
- A The rear tires, you notice the left rear has four center groves that will go along the circumference of the tire. It also is intersected by a diagonal lime, but those diagonal lines are actually opposite of the front tire. That tire, itself, was five and a half inches in width which was also unique.
 - Q How about the right rear tire?
- A Right rear was more aggressive snow or mud type tread design six inches in width, and it is not very common we would run into a vehicle that had three different sets of tires on it.

 - A Absolutely. We were looking for a car, passenger car with three different types of tires. Almost a month later a vehicle such as that was located in the Frontier Plaza on West William in Fallon.

 - A 1985 black Honda Accord.
 - Q Was a registration run?
- 10 A Yes. It came back to Mr. Shawn Harte.
- 11 Q Do you recall the address it was registered with?
- 12 A 1051 Aimme Lane in Fallon, City of Fallon.

If for some reason he's not comfortable simply based on some of the terminology used in the transcript, I want to make sure it is clean reading. So long as he is comfortable, short of that, I am giving the Court a heads up we may be ending a

 - A Yes, documented or tracked.
- Q If you have a piece of evidence here in court relating to evidence you collected back in 1997, would there be tracking of that that would say your name, what the evidence is, things like that?

A The most common request for examination we get in the laboratory is for us to look at a bullet or a cartridge case and determine whether it was fired in or fired from a particular firearm. They may ask us to look at a firearm or a gun and determine whether it is working correctly. There is a number of different examinations associated with guns, bullet cartridges, cartridge cases, that sort of thing that we do.

Q Sir, are you required to have any special training or do you have any special training or education in this area?

A Related to firearms, I am a graduate of the Colorado School of Trades. It is a gunsmith school. I have been trained by various gun manufacturers or their particular firearms including Ruer, Remington, Smith and Wesson just to name a few. I am a member of the Association of Firearms and Tool Mark Examiners and attend their training seminars. And a

member of the Southwestern Association of Forensic Scientists.

So a number of associations, organizations and different training.

- Q Does your training continue on a continuing basis?
- A Yes. Normally at least once a year we are sent somewhere for some additional training.
- Q Have you done that over the course of your employment with Washoe County?
 - A Yes, that is correct.
