- 7 June 2014, correct?
- 8 A. Yes.
- 9 Q. That the three of you leave in the early
- 10 morning hours. Is that a fair statement?
- 11 A. Yes.
- 12 Q. Okay. 5:00, 6:00 o'clock in the morning,
- 13 something like that.
- 14 A. Yes. 4:00 o'clock.
- 15 Q. 4:00 o'clock in the morning.
- 16 A. Yes.
- 17 Q. It was your idea to have Deborah and Anita
- 18 and you leave the house, correct?
- 19 A. It was more of my mom's idea because many
- 20 things were starting to get very very worse more
- 21 by the day passes.
- Q. Okay. This didn't have anything to do with
- 23 the conversation that you and Anita had the day
- 24 before.
- 25 A. We all brought it to each other at one

- 1 point.
- Q. Okay. So Deborah, you, and Anita all had a
- 3 conversation together about an incident the day
- 4 before you left. Is that a fair statement?
- 5 A. Most likely, yes.
- 6 Q. So the incident that I'm referring to is
- 7 that Anita was late for work and she asked you to fix
- 8 her something to eat or you offered to fix her
- 9 something to eat.
- 10 A. Yes.
- 11 Q. And there was an argument in the kitchen
- 12 between you and your father.
- 13 A. Yes.
- 14 Q. Because you were fixing Anita something to
- 15 eat.
- 16 A. Yes.
- 17 Q. And then there was some type of physical
- 18 scuffle between you and your father.
- 19 A. Yes.
- Q. Is that a fair statement? And Anita saw
- 21 that.
- 22 A. Yes.
- 23 Q. And that got Anita upset.
- 24 A. That's one of them.
- Q. But on that date at that time Anita was

- 1 upset because she saw this physical scuffle between
- 2 you and your father.
- 3 A. Yes.
- 4 Q. After that did you and Anita go outside and
- 5 have a conversation?
- 6 A. No.
- Q. Did you stay inside the house and have a
- 8 conversation?
- 9 A. No.
- 10 Q. Is that when the decision was made between
- 11 you and Anita that you wanted to leave the house?
- 12 A. Say that again. I just blacked out for a
- 13 minute.
- 14 Q. No problem. After that physical scuffle
- 15 between you and your dad, is that when you and Anita
- 16 decided that you wanted to leave the house?
- 17 A. Yes.
- 18 Q. And was Deborah part of that conversation?
- 19 A. Yes.
- Q. Okay. She was not working that day or home
- 21 from work already.
- 22 A. She was home from work already.
- Q. Okay. So this was the day before you guys
- 24 actually moved out. Correct?
- 25 A. I don't remember exactly if it was the day

- 1 before but maybe in that week before.
- Q. Okay. So the decision to move out was made
- 3 fairly quickly. Is that a fair statement?
- 4 A. Yes.
- 5 Q. It wasn't months and months of
- 6 conversation, correct?
- 7 A. Yes.
- 8 Q. But you decided to take some of your
- 9 belongings with you, correct?
- 10 A. Yes.
- 11 Q. Your clothes, your Playstation, things like
- 12 that.
- 13 A. Yes.
- 14 Q. You made the decision not to tell your
- 15 brother Ryan or your stepmom Terrie that you were
- 16 leaving, correct?
- 17 A. Yes.
- 18 Q. Or your other brother Tails.
- 19 A. Yes.
- Q. Was that a decision that you made yours or
- 21 was that a decision that you and Anita and Deborah
- 22 all made together?
- 23 A. We all made together.
- Q. Okay. Why did you guys decide not to tell
- 25 Terrie or Ryan or Tails that you were leaving?

- 1 A. Because at that time we all acted
- 2 differently in our personalities than we are today
- 3 because it most likely would have been brought up
- 4 somehow or some way to where everything would have
- 5 been stopped in our tracks, and it would have been
- 6 really bad after that.
- 7 Q. So from what you just said, is it fair to
- 8 say that you and Deborah and Anita did not trust
- 9 Terrie, Ryan, and Tails with that information that
- 10 you guys wanted to leave the house?
- 11 A. We did not want anyone to know.
- 12 Q. Because you were worried that they would
- 13 tell Christopher.
- 14 A. No, but if something did happen.
- 15 Q. Like what?
- 16 A. I don't know. There could be many variety
- 17 of ways or things that could happen.
- 18 Q. I'm sorry. I'm just not understanding.
- 19 A. I don't know how to explain it.
- Q. What would happen that would prevent you
- 21 from moving out of the house?
- 22 A. Some way of preventing.
- Q. Okay. So when you and Deborah and Anita
- 24 left the house, was it your understanding that Anita
- 25 stayed up awake all night long the night before you

- 1 left?
- 2 A. Yes.
- 3 Q. But you were sleeping in your room --
- 4 A. Yes.
- 5 Q. -- with Ryan.
- 6 A. Yes.
- 7 Q. And after you guys left the house, you
- 8 watched the video feed on Anita's phone, correct?
- 9 A. Yes.
- 10 Q. You watched Christopher's reaction on the
- 11 phone, correct?
- 12 A. Yes.
- 13 Q. That was June of 2014, correct?
- 14 A. Yes.
- 15 Q. And then from the house that day you guys
- 16 went to the safe house, correct?
- 17 A. Yes.
- 18 Q. While you were living at the safe house,
- 19 did you get any type of counseling or any type of
- 20 therapy while you were staying at the safe house?
- 21 A. I think a little bit before I left.
- Q. Okay. How long if you recall did you stay
- 23 at the safe house?
- A. About one month.
- Q. Now, when you were staying at the safe

- 1 house, all three of you were there.
- 2 A. Yes.
- 3 Q. Deborah, Anita, and yourself.
- 4 A. Yes.
- 5 Q. While you were staying there, there were
- 6 other people at the safe house as well, correct,
- 7 people that you didn't know prior to living there?
- 8 A. Yes.
- 9 Q. Were any of those people contacting the
- 10 police regarding whatever was going on in their
- 11 lives, if you know?
- 12 A. I am not sure but if I'm right, it's for
- 13 people that's living like I'd say a hard life or
- 14 abusive life, stuff like that.
- 15 Q. And yet you and your mom and Deborah -- I'm
- 16 sorry. You and your mom and Anita opted not to go to
- 17 the police at that point in time, correct?
- 18 A. Yes.
- 19 Q. You didn't go to the police for two or
- 20 three months, correct?
- 21 A. Yes
- 22 Q. Do you recall during your interview with
- 23 the police telling the police that Terrie, your
- 24 stepmom, would flash you occasionally?
- 25 A. Yes.

- 1 Q. In other words pull up her shirt and show
- 2 you her breasts.
- 3 A. Yes.
- 4 Q. And that would happen occasionally when
- 5 Christopher wasn't around, correct?
- 6 A. No, he was around.
- 7 Q. In the room?
- 8 A. Yes.
- 9 Q. Was anybody else in the room when that
- 10 would happen?
- 11 A. No.
- 12 Q. After -- the first time that something like
- 13 that happened, did you tell your mom about it?
- 14 A. No.
- 15 Q. What part of the house were you in when
- 16 that happened?
- 17 A. I do not remember.
- 18 Q. You don't remember if it was the office,
- 19 the livingroom, or the master or nowhere?
- 20 A. Do not remember.
- 21 Q. Do you remember how old you were when that
- 22 happened the first time?
- 23 A. No.
- Q. Now, for a period of time when you were 14
- 25 or 15 Terrie and Ryan moved out of the house,

- 1 correct?
- 2 A. Yes.
- 3 Q. Okay. How -- what grade were you in when
- 4 Terrie and Ryan moved out of the house?
- 5 A. They were two things, they were really
- 6 thrown out of the house being blamed.
- 7 Q. What grade were you in, Brandon --
- 8 A. Oh, sorry.
- 9 Q. -- when they left the house.
- 10 A. I was I think starting to become a junior.
- 11 Q. A junior. You're a senior. You're going
- 12 into your senior year right now.
- 13 A. Yes.
- Q. So this time last year is when you recall
- 15 Terrie and Ryan being or leaving the house.
- 16 A. Yes.
- 17 Q. Okay. Is it possible that it could have
- 18 been a year before that?
- 19 A. Being thrown out?
- 20 Q. No. I'm not speaking of after you and
- 21 Deborah and Anita left. Prior to that.
- A. Before?
- Q. Sorry. I apologize. Maybe my question was
- 24 a little misleading. Before you and Deborah and
- 25 Anita left the house--

- 1 A. Yes.
- 2 Q. -- there was a time that Terrie and Ryan
- 3 left, correct?
- 4 A. Yes.
- 5 Q. Do you recall -- and that's the incident
- 6 I'm talking about. What grade were you in at that
- 7 point when Terrie and Ryan left?
- 8 A. I do not remember.
- 9 Q. Okay. Do you remember was it before or
- 10 after the incident of sex that you said you had with
- 11 Terrie?
- 12 A. I don't recall if it was before or after.
- 13 Q. Do you remember if it was before or after
- 14 the alleged incident you talked about with your mom?
- 15 A. I don't remember.
- 16 Q. Do you recall how long Terrie and Ryan were
- 17 out of the house?
- 18 A. Out of all the times.
- 19 Q. Let me interrupt you. Are you saying there
- 20 was more than one time that Terrie and Ryan left the
- 21 house?
- 22 A. Yes.
- Q. You lived at that house your whole entire
- 24 life or from a young age until you were 15 or 16,
- 25 correct?

- 1 A. Yeah.
- 2 Q. How old were you when the family moved to
- 3 that house?
- 4 A. I was just born that I know of.
- 5 Q. All right. And during the course of the
- 6 time that you lived at that household, how many times
- 7 do you remember Terrie leaving the house with Ryan?
- 8 A. About seven to nine times.
- 9 Q. Seven to nine times. Okay. Was this she
- 10 would go for a day or two or she would go for a
- 11 longer period of time?
- 12 A. For a longer period of time.
- 13 Q. Okay. And you pretty much your whole life
- 14 shared a room with Ryan, correct?
- 15 A. Yes.
- 16 Q. So when Terrie took Ryan, did you get the
- 17 room to yourself or was Tails in the room?
- 18 A. Tails was with us for a long time until he
- 19 moved out the first time because of an argument.
- Q. Okay. How old do you recall Tails being
- 21 that he moved out the first time?
- 22 A. 16.
- Q. Okay. How long was Tails gone at that
- 24 point?
- 25 A. Wait, sorry. 18.

- 1 Q. He was 18. Was it just after his 18th
- 2 birthday?
- 3 A. Maybe, most likely.
- 4 Q. Do you recall how long Tails was gone at
- 5 that point?
- 6 A. He was gone for about maybe a half a year.
- 7 Q. Okay. And when going back to the last
- 8 time -- well, the last time that you were living in
- 9 the house and Terrie and Ryan left, did that change
- 10 the atmosphere in the house that Terrie was gone?
- 11 A. When Terrie and Ryan left the last time,
- 12 when he was still there the last time? Not really.
- 13 Like it did for a while, then it just went back to
- 14 normal.
- 15 Q. Okay. How did it change?
- 16 A. It just got a little less violent for a
- 17 little bit.
- 18 Q. Okay. And who -- you say it was violent,
- 19 against yourself, against your sister, against your
- 20 mom? Who was the violence?
- 21 A. My dad being violent. He was always
- 22 violent to everyone. I really don't know how.
- Q. Okay. Isn't it true that there was one
- 24 incident where you volunteered to be tasered because
- 25 you wanted to see what that feels like?

- 1 A. Yes.
- 2 Q. That -- were you yourself ever physically
- 3 hit by your father?
- 4 A. Yes.
- 5 Q. Did you ever have bruises?
- 6 A. Yes.
- 7 Q. Okay. Did anybody outside of the family
- 8 see those bruises such as teachers or other friends?
- 9 A. No.
- 10 Q. How is it that teachers did not see the
- 11 bruises?
- 12 A. Because normally it would be hidden
- 13 because -- I don't know. Normally it's hidden.
- 14 Q. Hidden under your clothes?
- 15 A. Yes.
- 16 Q. So that if you lifted up your shirt and
- 17 showed a teacher, they would have been able to see
- 18 it, correct?
- 19 A. Yes.
- 20 Q. But you just did not ever show anybody
- 21 proof.
- 22 A. Yes.
- Q. Okay. After any of these incidents of
- 24 physical violence, you didn't call the police and
- 25 say, "My dad's hitting me, I need to get out of

- 1 here."
- 2 A. No.
- 3 Q. You didn't ask your sister Anita to call
- 4 the police for you and say, "We need to get out of
- 5 here. He's physically hurting us."
- 6 A. No.
- 7 Q. Of all of your brothers and sisters would
- 8 you say that you and Anita have the closest
- 9 relationship?
- 10 A. Yes.
- 11 Q. And I guess I mean that more from your
- 12 perspective. Are you closer to Anita than you are to
- 13 any of your brothers and sisters?
- 14 A. Yes.
- 15 Q. But you never confided in Anita about the
- 16 sexual goings-on in the house, correct?
- 17 A. Yes.
- 18 Q. You first confided in her right before you
- 19 guys decided to move out of the house or was it after
- 20 you moved out of the house?
- 21 A. I think before.
- Q. All right. Was it right before you left
- 23 the house?
- 24 A. Yes.
- Q. Did it contribute to the decision for you

- 1 to move out of the house, for all three of you to
- 2 move out of the house?
- 3 A. Yes.
- 4 Q. Anita was upset to hear about that, those
- 5 sexual things that you told her about, correct?
- 6 A. Yes.
- 7 Q. It made her very angry, correct?
- 8 A. Yes.
- 9 Q. But on that day that you were talking to
- 10 Anita you only told her about things that had
- 11 happened with your mom, correct?
- 12 A. I think it was about Terrie.
- 13 Q. Oh, you only told her about things that
- 14 happened with Terrie. You didn't say anything that
- 15 was happening with Deborah?
- 16 A. Yes.
- 17 Q. You only told her half about what you've
- 18 been testifying to today, correct?
- 19 A. Yes.
- 20 Q. At that point in time did Anita confide in
- 21 you about any sexual encounter that she may have had
- 22 with Deborah or with Terrie?
- 23 A. Only heard about my dad raping her. That's
- 24 it.
- Q. Anita didn't tell you about things with

- 1 Deborah or things with Terrie; is that correct?
- 2 A. Yes.
- 3 Q. Now, the house that you all lived in, it
- 4 wasn't an overly large house, correct?
- 5 A. Yes.
- 6 Q. There were seven people living in that
- 7 house when you were all there, correct?
- 8 A. Yes.
- 9 Q. And in all that time you never saw Chris
- 10 touch Anita in a sexual manner, correct?
- 11 A. Yes.
- 12 Q. You did not ever see that?
- 13 A. Never.
- 14 Q. And you didn't see him ever touch Brandon
- 15 in a sexual manner, correct? I'm sorry. I realized
- 16 it when I said it.
- 17 You didn't see him touch Ryan at all in a
- 18 sexual manner, correct?
- 19 A. Never saw.
- Q. Never saw him touch Tails in a sexual
- 21 manner, correct?
- 22 A. Correct.
- Q. There was a, some incident with the TV
- 24 remote control, correct?
- 25 A. Yes.

- 1 Q. Where it would be hitting somebody on the
- 2 leg with the TV remote control, correct?
- 3 A. Yes.
- 4 Q. And some of the incidents of abuse,
- 5 physical abuse that you talked about, correct?
- 6 A. Yes.
- 7 Q. You put those in that category, correct?
- 8 A. I would put it that way because he did it a
- 9 lot.
- 10 Q. But you also took the TV remote and you hit
- 11 other people in the family including Chris with the
- 12 TV remote, correct? It wasn't just a one-way thing
- 13 with Chris.
- 14 A. I never really hit him in the remote.
- 15 Q. Did anybody else in the family grab the
- 16 remote and do that same action?
- 17 A. No.
- 18 Q. You never saw Ryan or Tails take the remote
- 19 and hit anybody with it.
- 20 A. No. May I also add one thing?
- 21 THE COURT: You have to wait for a
- 22 question.
- THE WITNESS: Okay.
- THE COURT: Sorry.
- MS. RADOSTA:

- 1 Q. After you moved out of the house with
- 2 Deborah and Anita, whose decision was it not to call
- 3 the police?
- 4 A. I don't remember.
- 5 Q. This wasn't a collective decision on your
- 6 part to not call the police.
- 7 A. I don't think I remember that part.
- 8 Q. So you could have called the police once
- 9 you moved out if you wanted to, correct?
- 10 A. Yes.
- 11 Q. Did you -- you were -- at that point you
- 12 were at Western High School; is that correct?
- 13 A. Yes.
- Q. Did you have a favorite subject or favorite
- 15 teacher at Western?
- 16 A. No.
- 17 Q. Did you participate in any like
- 18 after-school activities, any sports, anything like
- 19 that?
- 20 A. No.
- 21 Q. So you didn't have anybody at school that
- 22 you felt you could confide in what was going on at
- 23 your house.
- 24 A. No.
- Q. Who is your best friend?

- 1 A. Used to be my best Elaina (phonetic) but
- 2 now it's like Q.
- 3 Q. While you were living at the house, who was
- 4 your best friend?
- 5 A. Elaina and my dude Q (phonetic).
- 6 Q. Did you ever confide in Elaina or Q what
- 7 was going on in the home?
- 8 A. A tiny bit.
- 9 Q. At what point, if you recall, did you talk
- 10 to Elaina about this stuff?
- 11 A. Whenever -- I don't remember when it was,
- 12 but normally whenever we were at school.
- 13 Q. So did you have more than one conversation
- 14 with Elaina about this what you say what was going on
- 15 at home?
- 16 A. A few.
- Q. What about Q, did you have one conversation
- 18 or more than one?
- 19 A. More than one.
- 20 Q. Did they advise you that you should try to
- 21 call the police or try to tell somebody that could
- 22 help you?
- 23 A. They were telling me a place I could go
- 24 before we moved. He was helping me saying if I need
- 25 a place to escape for the time, to come to his house,

- 1 he would protect me.
- 2 Q. And that was Q?
- 3 A. Yes.
- 4 Q. But there was no advice to call the police
- 5 or anything like that.
- 6 A. There was, it was at someplace but I can't
- 7 remember.
- 8 Q. So I'm not quite understanding your
- 9 answer. Did Q give you the advice or Elaina give you
- 10 the advice to call the police or was it somebody else
- 11 entirely?
- 12 A. Q's mother.
- Q. So Q's mother also was aware of some of the
- 14 stuff that was going on at home.
- 15 A. Yes.
- 16 Q. Did Q tell you or did you tell her?
- 17 A. Q was talking to her a little bit about it
- 18 because I let him.
- 19 Q. Do you happen to know Q's mom's name?
- 20 A. No.
- 21 Q. Is it true that you were under the
- 22 impression that Anita had actually told somebody
- 23 outside the family years earlier about abuse?
- 24 A. No.
- 25 Q. She never told you the story that she had

- 1 told at school and nothing happened. She never got
- 2 any help.
- A. Oh, I remember that one. Yes, I remember
- 4 that, yes.
- 5 Q. So Anita told you, "I told and nobody ever
- 6 helped me." Was that kind of a summary of it?
- 7 A. There was a point to where the CPS came to
- 8 the house and father got away buck free.
- 9 Q. Okay. So your understanding of what
- 10 happened and this was much, many many years ago,
- 11 correct?
- 12 A. Yes, when it happened to her.
- 13 Q. Okay. When she told was years ago.
- 14 A. When she told me was like, I don't remember
- 15 when but the first time but I've gotten told two or
- 16 three times.
- 17 Q. So you heard the story from Anita a couple
- 18 of different times, correct?
- 19 A. Yes.
- 20 Q. Just for clarification, when Anita actually
- 21 told CPS was a very very long time ago.
- 22 Is that your understanding?
- 23 A. Yes.
- Q. Okay. She was under the age of ten.
- 25 A. Yes. She was in elementary school.

- 1 Q. Okay. And your understanding of that story
- 2 is that CPS came to the house and nothing happened.
- 3 A. Practically.
- 4 Q. Okay. And Anita's the one that told you
- 5 that.
- 6 A. Yes.
- 7 Q. Did you ever ask your mom about CPS coming
- 8 to the house?
- 9 A. No.
- 10 Q. Did you ever ask Terrie about CPS coming to
- 11 the house?
- 12 A. No.
- 13 Q. Did that story make you feel like there was
- 14 very little that could be done to get you out of the
- 15 situation?
- 16 A. Yes.
- 17 Q. But you never heard of Anita getting
- 18 punished for telling, correct?
- 19 A. Yes, I heard that story.
- Q. How did she get punished?
- 21 A. I think she was grounded for more than a
- 22 year but I don't -- I know there's one more thing I
- 23 think but I can't remember.
- Q. And Anita's the one who told you that,
- 25 correct?

- 1 A. Yes.
- 2 Q. It's your understanding that your dad had
- 3 friends that worked at Metro, correct?
- 4 A. Yes.
- 5 Q. And that was something that you felt
- 6 prevented you from being able to contact Metro.
- 7 A. Yes.
- 8 Q. You felt that his friends and acquaintances
- 9 at Metro would side with him, correct?
- 10 A. Yes.
- 11 Q. I believe you told the police that he had
- 12 Metro friends coming -- I'm sorry. I believe you
- 13 told the police that your father had Metro friends
- 14 coming over to the house regularly.
- 15 A. Yes.
- 16 Q. Okay. Do you recall the names of any of
- 17 those Metro officers that came over to the house
- 18 regularly?
- 19 A. Officer Brinkley (phonetic).
- Q. Do you know Officer Brinkley's first name
- 21 by any chance?
- 22 A. No.
- 23 Q. Any other Metro officers that came over to
- 24 the house?
- 25 A. I know their faces but not their names.

- 1 Q. Okay. Approximately how many different
- 2 Metro officers did you see come to your house
- 3 regularly?
- 4 A. Mainly just Brinkley I heard regularly came
- 5 over, but I physically seen him a few times.
- Q. You physically saw Brinkley or others a few 7 times.
- 8 A. Brinkley whenever like if I came home and 9 he was there.
- 10 Q. Okay. So in a given month how often would
- 11 Officer Brinkley be at your house?
- 12 A. Me hearing about him coming over at least
- 13 maybe ten, 12 times. Me seeing him once or twice.
- 14 Q. Okay. A month?
- 15 A. About.
- 16 Q. And did he hang out at the house, Officer
- 17 Brinkley?
- 18 A. He'd do a quick stop by.
- 19 Q. Would it be like when he was on duty or
- 20 when he was off duty?
- 21 A. I don't know.
- Q. Was he in uniform when he would stop by?
- 23 A. Depending, most of the time yes.
- Q. Pull up in a patrol vehicle?
- A. Not sure.

- 1 Q. Did he ever go into the back office? Did
- 2 Officer Brinkley ever go into the back office?
- 3 A. Yes.
- 4 Q. Okay. And why -- what prevented you from
- 5 going to like the substation down the street and
- 6 reporting it to somebody that didn't know your
- 7 father?
- 8 A. Because it would eventually get to most
- 9 likely Metro was what I thought.
- 10 Q. Okay. So ultimately you didn't go to Metro
- 11 because you didn't want to tell Metro. Is that your
- 12 understanding?
- 13 A. No. It's because he had friends and I was
- 14 sure they were going to side with him because my dad
- 15 is a good manipulative liar.
- 16 Q. Okay. But ultimately when you did go to
- 17 Metro with your mom, they believed everything that
- 18 you said, correct?
- 19 A. Yes.
- 20 Q. As a result of your -- as a result of you
- 21 going to Metro, your dad got arrested, correct?
- 22 A. Well, I'm not sure if they were Metro. I'm
- 23 not sure what they were. I just know the police
- 24 office.
- Q. Well, you told somebody outside of the

- 1 family and after you told somebody outside the
- 2 family, your father was arrested, correct?
- 3 A. Yes.
- 4 Q. And then a few months later your mom was
- 5 arrested, correct?
- 6 A. Yes.
- 7 Q. How did that make you feel when your mom
- 8 got arrested?
- 9 A. I felt really sad.
- 10 Q. Okay. And is it fair to say you don't
- 11 think she should be charged with a crime?
- 12 A. In my honest opinion no.
- 13 Q. Are you in any way angry that your mom is
- 14 being prosecuted at this point in time, angry with
- 15 the prosecutors for going after your mom?
- 16 A. I'm not angry and I am.
- 17 Q. You mean you are a little angry and you
- 18 aren't. You're kind of --
- 19 A. Yes, I'm both.
- Q. You're both. Okay. But you're not angry
- 21 that they are prosecuting your dad, correct?
- 22 A. No.
- Q. How many times have you met with the
- 24 prosecutors to discusses your testimony?
- 25 A. Maybe four times.

- 1 Q. Four different times. And sometimes it's
- 2 in relationship to Deborah and sometimes it's in
- 3 relationship to Chris, correct?
- 4 A. Just basically my mom I think.
- 5 Q. Okay. Have you met with your mom's defense
- 6 attorney?
- 7 A. Yes.
- 8 Q. How many times have you met with your mom's
- 9 defense attorney?
- 10 A. Once, twice.
- 11 Q. Do you know your mom's defense attorney's
- 12 name?
- 13 A. No, I do not.
- Q. Did you -- now you're still living with
- 15 Anita and have been since your mom got arrested,
- 16 correct?
- 17 A. Yes.
- 18 Q. Do you and Anita ever sit down and talk
- 19 about everything that's going on, the testimony,
- 20 having to come to court, things like that?
- A. I do my best not to.
- Q. Okay. And why is that?

- 3 A. June.
- 4 Q. Do you remember the date by chance, early

- 6 A. Was early June.

- 8 A. Yes.
- 9 Q. Just briefly, tell me a little about your
- 10 family, brothers, sisters, mom, dad.
- 11 A. Brandon is a gamer.
- 12 Q. Okay. Brandon is your brother?
- 13 THE COURT: I don't think she understood
- 14 the question.
- MS. HOLTHUS:
- 16 Q. I meant more of name, age, relationship.
- 17 A. Okay. Father, Christopher Sena. I don't

- 9 Q. Okay. Brothers?

- 14 A. Terry. His name is Terry Tails Sena.

- 20 Sena, the defendant, that causes you to be in court

- Q. When did it begin?
- 24 A. When I was 11.
- Q. Where were you living?

- 1 A. At 6012 Yellowstone Avenue.
- Q. And is that in North Las Vegas, Clark
- 3 County, Nevada?
- 4 A. That is at Sunrise Manor.
- 5 Q. Is that Clark County, Nevada, though?
- 6 A. I believe so.
- 7 Q. Who were you living there with?
- 8 A. With Chris, Terrie and Deborah.
- 9 Q. Any of your siblings?
- 10 A. Yes.
- 11 Q. Which ones?
- 12 A. It was Tails, Brandon, and Ryan.
- 13 Q. You said you were how old?
- 14 A. 11.
- 15 Q. How did it begin?
- 16 A. It began like after school.
- 17 Q. 11. You were in approximately what grade?
- 18 A. I was in sixth grade I believe.
- 19 Q. Okay. What happened?
- 20 A. I came home. Everybody was gone normally
- 21 at school or at work. Chris was normally home so I
- 22 came home. We were just acting like a normal
- 23 daughter between father --
- MS. RADOSTA: Your Honor, I'm going to have
- 25 to object, lack of foundation. At this time we have

- 1 11 years old in sixth grade. I have no idea what
- 2 time of year, what day of the week, anything. So

- 23 A. Just one bathroom.
- Q. Okay. And who stayed there back when you

- 1 A. I stayed in the back room near the master
- 2 bathroom or near the bathroom and then the master
- 3 bedroom.
- 4 Q. And then how old were Brandon and Tails at
- 5 the time?
- 6 A. They were real young.
- 7 Q. What's the age difference among you?

- 21 A. Deborah and Chris.
- 22 Q. And Terrie.
- 23 A. She was in the livingroom at the time.
- Q. The livingroom. That's where she stayed.
- 25 A. Yes.

- 1 Q. How old were you when -- Terrie and Chris
- 2 were married, correct?
- 3 A. Yes. No. Yes.
- 4 Q. They were divorced?
- 5 A. Yes.
- 6 Q. And then at some point Deborah moved into
- 7 the home.
- 8 A. About four years before I turned 11 Chris
- 9 and Deborah were together.
- 10 Q. And your mom had come back into the home.
- 11 A. Yes.
- 12 Q. Do you know how old you were? And when I'm
- 13 talking mom, I'm talking bio mom.
- 14 A. Okay. About nine she came back.
- 15 Q. Back to you're 11.
- 16 A. Uh-huh.
- 17 Q. Tell me about the first incident you
- 18 remember.
- 19 A. He was asking me if I loved him and stuff

- 4 2009.
- 5 A. Yes.
- 6 Q. Was it how frequent?
- 7 A. It was normally during the weekdays when
- 8 the moms were gone so it would happen about three or
- 9 twice a week.
- 10 Q. Every week?
- 11 A. Almost every week, yeah.
- 12 Q. Did he ever go more than one week without
- 13 doing it?
- 14 A. On a rare occasion, yes.
- 15 Q. Did he ever go more than one month?
- 16 A. No.

- 18 A. At least once a month until 2009 it did

- 2 Q. Tell me what happened.
- 3 A. I got home from school which is normally
- 4 when it happens. My dad was already naked, and he
- 5 brought Deborah out and told me to get undressed so I
- 6 did. He wanted to see us play with each others boobs
- 7 and he wanted us to rub each others clits, then he
- 8 told me to lie down and Deborah to crawl on top of
- 9 me.
- 10 Q. Did you play with Deborah's clit?
- 11 A. I had to.
- 12 Q. Did she play with your clit?
- 13 A. She only rubbed on the outside.
- 14 Q. The outside of your clit?
- 15 A. The outside of my vagina.
- 16 Q. Okay. When she was rubbing, was she
- 17 rubbing between the lips where it's moist?
- 18 A. No.
- 19 Q. But when you rubbed her, it was between the
- 20 lips.
- 21 A. Yes.
- Q. What was your demeanor?
- What were you saying, doing?
- A. He was pretty much telling us what to do.
- Q. Were you crying?

- 1 A. I was almost in tears but I had hold it
- 2 back.
- 3 Q. And why was that?
- 4 A. Because normally my dad would give you a
- 5 reason to cry.
- 6 Q. What about Deborah?
- 7 A. She was a little bit emotional.
- 8 Q. Did you want to have sex, touch Deborah?
- 9 A. No.
- 10 Q. Why did you?
- 11 A. Because I was told.
- 12 Q. By?
- 13 A. Chris.
- Q. Did anything else happen that time?
- 15 A. That was when Chris started doing
- 16 penetration of me on the floor. He was behind us
- 17 when he put his penis in my pussy at this time.
- 18 Q. Okay.
- 19 A. He went a while before he took himself out
- 20 and then he put himself in Deborah.
- Q. Where in Deborah if you saw or know?
- 22 A. I believe it was anal. I'm not quite sure.
- Q. While his penis was in your vagina, where
- 24 was Deborah?
- 25 A. She was still on top of me.

Q. I'm sorry. You probably said this. Were

34

- 2 you on your front?
- 3 A. I was on my back.
- 4 Q. So you're on your back. Deborah's on top
- 5 of you.
- A. Yeah. She's like on her hands and knees on 7 top of me.
- 8 Q. Facing you.
- 9 A. Over facing me.
- 10 Q. How does Chris get his penis into you at
- 11 this point?
- 12 A. He lifted me up a little bit to get better
- 13 access of me. Deborah was still on top of me of
- 14 course but she had to move into an awkward way for
- 15 him.
- 16 Q. To get to you.
- 17 A. To get to me.
- 18 Q. Did this all happen on the floor?
- 19 A. Yes, on the floor in the livingroom.
- 20 Q. Obviously no one else was home.
- 21 A. Nobody was home.
- 22 Q. So then after he pulled out of you, you
- 23 said then he put himself into Deborah.
- 24 A. Yes.
- 25 Q. But you're not sure whether it was anus or

- 1 vagina.
- 2 A. Correct.
- 3 Q. Where are you during this?
- 4 A. I'm still on the floor.
- 5 Q. Are you still under Deborah?
- 6 A. Yes.
- 7 Q. And he's still up above?
- 8 A. Yes.
- 9 Q. Is anyone else touching any part of your
- 10 body with any part of their body?
- 11 A. Nobody was pretty much touching me. The
- 12 only thing that was touching me was Deborah's nipples
- 13 up against my chest.
- 14 Q. Okay.
- 15 A. Because of the angle and position that we
- 16 were in. That was the only place that was really
- 17 touching me.
- 18 Q. Did Chris touch you anywhere else that
- 19 time?
- 20 A. After that position he told me to get out
- 21 from underneath her so I did. He then put Deborah on
- 22 her back and entered her again with a pillow
- 23 underneath her back this time.
- Q. Were you able to tell where he was entering
- 25 her?

- 1 A. No. Then he told me to play with myself so
- 2 I played with myself but only on the outside but not
- 3 on the inside of where the wet is.
- 4 Q. And you played with yourself.
- 5 A. So he could watch.
- 6 Q. What part of your body with what part of
- 7 your body?
- 8 A. My hand up against my vagina.
- 9 Q. But you said the outside, right?
- 10 A. Right.
- 11 Q. And then what?
- 12 A. He finished inside of Deborah.
- 13 Q. Do you know -- when you say inside, where
- 14 exactly did he finish?
- 15 A. I don't know where he finished at. All I
- 16 know is that he was penetrating her. I don't know.
- 17 Q. We're talking though somewhere between the
- 18 vagina and the anus.
- 19 A. Correct. After he finished he normally
- 20 gets up, goes to the bathroom, gets a wash cloth to
- 21 clean himself up.
- Q. You said normally. Did he do that on that
- 23 day?
- 24 A. Yeah, he did on that day.
- Q. Was there any other touching?

- 1 Did you touch anyone else?
- 2 A. Other than what he told me to touch and
- 3 stuff like that, no.
- Q. Did he tell you to touch anything else
- 5 other than Deborah's clit?
- 6 A. And boobs, that was it.
- 7 Q. He had you touch Deborah's boobs.
- 8 A. Yes. That was it.
- 9 Q. And you did that.
- 10 A. Yes.
- 11 Q. With your hand.
- 12 A. Yes.
- 13 Q. Did he have Deborah touch you anywhere
- 14 else?
- 15 A. Yes, on my boobs like I did with her and
- 16 also on the outside of my pussy.
- 17 Q. And you indicated your hand on your boobs.
- 18 Deborah put her hand on your boobs because the
- 19 defendant told her to.
- 20 A. Yes.
- MS. HOLTHUS: Court's indulgence.
- Q. Was there any kissing going on?
- 23 A. I know I kissed my father.
- Q. Okay. Where did you kiss him?
- 25 A. On the lips.

- 1 Q. Was it closed lips?
- 2 A. It was closed lips.
- 3 Q. Okay. Did you -- was there any other
- 4 kissing going on other than the lips or any other
- 5 body parts?
- 6 A. I don't remember at this time.
- 7 Q. Did Deborah kiss your breasts?
- 8 A. I don't remember.
- 9 Q. I'm sorry. You don't remember?
- 10 A. I don't remember.
- 11 Q. Did you put your mouth on Terrie's
- 12 breasts? I'm sorry. Forget that.
- Was there anything else that happened
- 14 between you and Deborah, you and the defendant,
- 15 Deborah and you on that particular occasion?
- 16 A. Other than that day that was the only day
- 17 so . . .
- 18 Q. And did you want to do any of that?
- 19 A. No.
- Q. Why did you?
- 21 A. I was told to.
- 22 Q. By?
- 23 A. Chris.
- Q. Did you ever tell anybody?
- 25 A. No.

- 1 Q. Why not?
- 2 A. In fear of what Chris would do to me.
- 3 Q. Had he threatened you?
- 4 A. On some occasions yes. The first occasion
- 5 when we first did that and I told him I was
- 6 uncomfortable and that it was wrong, he said
- 7 something about me being taken away, that I'd be sent
- 8 to juvie.
- 9 Q. So pretty much between being told if you
- 10 love me, this is what you do and threats.
- 11 A. Yes.
- 12 Q. You did it for years even though you didn't
- 13 want to.
- 14 A. Yes.
- 15 Q. And just to clarify, between the age of
- 16 eleven and 14 it was primary anal intercourse, right?
- 17 A. Yes.
- 18 Q. And then from 14 through 23 --
- 19 A. Correct.
- 20 Q. -- it was anal intercourse and vaginal
- 21 intercourse.
- 22 A. Yes.
- 23 Q. Sometimes at the same time, sometimes
- 24 different times.
- 25 A. It varied on the day.

- 1 Q. But always at least once a month.
- 2 A. Always.
- 3 Q. Without a doubt one anal intercourse every
- 4 year from the time you were eleven until the time
- 5 that you were 23.
- 6 A. At least once, yes.
- 7 Q. And between the ages of eleven and 23 at
- 8 least one time every year of anal intercourse.
- 9 A. Yes.
- 10 Q. What about his fingers inside your pussy.
- 11 A. He did that rarely.
- 12 Q. What does "rarely" mean?
- 13 A. Probably once a year depending on the year,
- 14 sometimes twice a year.
- 15 Q. At least once a year.
- 16 A. At least once.
- MS. HOLTHUS: Thank you. We'll pass the
- 18 witness.
- 19 (Whereupon Ms. Holthus concluded
- this portion of her examination
- 21 at 1:51 p.m.)
- 22 CROSS-EXAMINATION
- 23 BY MS. RADOSTA:
- Q. Good afternoon, Anita. My name is Violet
- 25 and I'm going to ask you questions. I might be a

- 1 little bit longer than Ms. Holthus was so let me know
- 2 if you need a break. Okay?
- 3 A. Yes.
- 4 Q. The first thing actually I want to ask you
- 5 about is I think on direct you testified that you
- 6 moved out in June of 2013. Isn't it actually June of
- 7 2014 that you moved out?
- 8 A. It was June. Yeah, it was June 2013.
- 9 Q. 2013?
- 10 A. 2013.
- 11 Q. So we're September 2015 right now, correct?
- 12 A. Yes.
- 13 Q. So you moved out not last June, not this
- 14 past June, not the June before that but two Junes ago
- 15 or was it?
- 16 A. No, it was 2014. I'm sorry.
- 17 Q. All right. No problem. So it was June of 18 2014.
- 19 A. Yes.
- Q. And then in relationship as to that I
- 21 believe you said that the last incident was -- when
- 22 you originally said you moved out in June of 2014,
- 23 you said the last incident was January 2013 because
- 24 you remember it was a few months before you had moved
- 25 out, correct?

- 1 A. Yes.
- 2 Q. So is that more accurately now the last
- 3 incident was January 2014?
- 4 A. I'm sorry. Repeat that question.
- 5 Q. I apologize. It's a little confusing. You
- 6 originally testified that you moved out June of 2013,
- 7 correct?
- 8 A. June 2014.
- 9 Q. Well, now you realize that it was June of 10 2014.
- 11 A. Yeah. The wrong year. Sorry.
- 12 Q. And on direct you originally testified that
- 13 the last incident that you recall happening to you
- 14 was January 2013 because you had said it was a few
- 15 months before you had moved out. Do you remember
- 16 saying something along those lines?
- 17 A. Yeah, I believe I did say that.
- 18 Q. So would the more accurate testimony be
- 19 that the last incident was that you allege happened
- 20 would have been January 2014 because you moved out in
- 21 June of 2014?
- 22 A. Yeah.
- Q. So it's fair to say that you had the date
- 24 wrong when you testified on direct --
- 25 A. Yeah.

- 1 Q. -- as to the last incident that you were
- 2 talking about with you and Deborah and Chris.
- 3 A. Right.
- 4 Q. You said that this had happened in the
- 5 livingroom, correct?
- 6 A. Yes.
- 7 Q. And you were 17 or 18 years old.
- 8 A. 17 or 18.
- 9 Q. And you're saying 17 or 18 'cause it was
- 10 right around your birthday. Is that fair? So you
- 11 don't know if it was before your 18th birthday or
- 12 after your 18th birthday?
- 13 A. Yes.
- 14 Q. The incident you say happened one day.
- 15 Were you coming home from school?
- Were you coming home from work?
- 17 A. I was coming back from school.
- 18 Q. And what school were you attending at that
- 19 time?
- 20 A. El Dorado High School.
- Q. What time did you get out of high school?
- 22 A. I normally get out at 1:00, 1:00 to 1:15.
- Q. Was that Monday through Friday?
- A. Monday through Friday.
- 25 Q. Did you ever have any after-school

- 1 activities that would keep you later?
- 2 A. No. The school let out early due to a
- 3 repopulization of the students. You could either
- 4 attend lunch after classes -- you had six classes
- 5 straight and then lunch -- or you could just go home
- 6 and not have lunch at the school.
- 7 Q. Okay. So what was your normal pattern?
- 8 A. My normal pattern was getting up, going to
- 9 school, going through all of my classes and I
- 10 normally didn't stay for lunch.
- 11 Q. Did you sometimes stay for lunch?
- 12 A. Sometimes yes.
- 13 Q. Do you recall on the date that this
- 14 incident originally happened with Deborah if you
- 15 stayed for lunch or not?
- 16 A. No, I did not stay for lunch.
- 17 Q. So you would have gotten home between 1:00
- 18 and 1:15, would that be correct if you did not stay
- 19 for lunch?
- 20 A. Yes.
- 21 Q. And your next younger brother was Tails,
- 22 correct?
- 23 A. Correct.
- Q. Was he also in high school at that point?
- 25 A. No. He was in middle school.

- 1 Q. So what time did Tails come home?
- A. He normally came home about 2:00 or 3:00.
- 3 Q. And the younger boys were in elementary
- 4 school at that point or were they in middle school as
- 5 well, Ryan and Brandon?
- 6 A. They were in elementary.
- 7 Q. What time would they normally get home?
- 8 A. 3:00.
- 9 Q. So you'd get home between 1:00 and 1:15 and
- 10 Tails could get home any time between 2:00 and 3:00.
- 11 A. Yes.
- 12 Q. And your mother Terrie, was she working at
- 13 this point in time?
- 14 A. Yes.
- 15 Q. Where was Terrie working at?
- 16 A. I believe she was working -- -- she had
- 17 different jobs. I'm trying to remember which job she
- 18 was at that year.
- 19 THE COURT: What year are we talking
- 20 about?
- MS. RADOSTA: Right around her high school
- 22 graduation so 2,000 and -- I think it would have been
- 23 2008.
- Q. Is that correct?
- 25 A. She would be working at the Clark County

- 1 School District.
- Q. Was she teaching school at that point in
- 3 time?
- 4 A. She was substituting.
- 5 Q. So some days she would be home and some
- 6 days she wouldn't if she got a call to come fill in.
- 7 A. Yes.
- 8 Q. That day your mom Terrie was not home.
- 9 A. She was not home.
- 10 Q. Do you recall if she was actually teaching
- 11 that day?
- 12 A. She was most likely teaching that day.
- 13 Q. But you don't have a specific
- 14 recollection.
- 15 A. No.
- 16 Q. Do you have any idea what time she would
- 17 have been expected home --
- 18 A. 3:00 or 4:00.
- 19 Q. -- if she were teaching that day?
- 20 A. Yes. She would stay after class to grade
- 21 homework.
- Q. And so you get home between 1:00 and 1:15
- 23 and you say that the incident like you noticed almost
- 24 immediately that Chris was naked. Is that fair?
- 25 A. As soon as I entered the door.

- 1 Q. And then from that point to the point when
- 2 you left the livingroom how long did the incident
- 3 last?
- A. 20 minutes, almost 30 minutes.
- 5 Q. And after the alleged incident ended, what
- 6 did you do?
- 7 A. Acted as if it was a normal day.
- 8 Q. Okay. And what does that mean?
- 9 A. My mouth was shut, no emotions to overrule
- 10 me, do homework, do chores, and the boys get home.
- 11 Q. And how long after the alleged incident
- 12 ended did the boys get home, did Tails get home?
- 13 A. About almost an hour later.
- 14 Q. All right. And this happened in the
- 15 livingroom. And there were cameras in the
- 16 livingroom, correct?
- 17 A. At this time no.
- 18 Q. At what point did the cameras go in?
- 19 A. The cameras came in like a year after I
- 20 graduated.
- Q. And there were cameras so you're saying
- 22 what, 2009 --
- 23 A. Yes.
- Q. -- the cameras in the livingroom were put

25 up.

- 1 A. They should have been.
- 2 Q. Prior to this incident starting, did
- 3 anybody go and lock the front door?
- 4 A. Yes.
- 5 Q. Okay. Who went and locked the front door?
- 6 A. Chris told me to lock the front door.
- 7 Q. Okay. So you went and locked the front
- 8 door.
- 9 A. Yes.
- 10 Q. And was there a back door to the house?
- 11 A. Yes.
- 12 Q. And what happened with that door?
- 13 A. That door was always locked.
- 14 Q. That door was always locked. Door led out
- 15 to the office.
- 16 A. That door led out to the back. It was the
- 17 side of the trailer.
- 18 Q. How would you get from the main house to
- 19 the office, which door would you use?
- 20 A. The front door.
- Q. Okay. And you said that Deborah came out
- 22 from -- Deborah came into the livingroom. Where was
- 23 Deborah coming from?
- 24 A. From the back, from the master bedroom.
- Q. And she was already naked as well when she

- 1 came out of the master.
- 2 A. Yes.
- 3 Q. Did that surprise you when you saw Deborah
- 4 naked coming out of the master bedroom?
- 5 A. Yes.
- 6 Q. Did you say anything to Deborah when you
- 7 saw that she was naked?
- 8 A. No.
- 9 Q. Did you ask her -- did you call Deborah
- 10 "Deborah," or did you call her mom or what do you
- 11 call her?
- 12 A. I call her Deborah.
- Q. Did you say, "Deborah, what's going on?
- 14 Sorry, did I interrupt something," anything like
- 15 that?
- 16 A. Didn't say anything.
- 17 Q. And Deborah didn't say anything to you?
- 18 A. No.
- 19 Q. You testified on direct that after the
- 20 alleged incident with Terrie you became more hateful
- 21 of her because she let it happen.
- 22 A. Correct.
- Q. Did you become more hateful of Deborah
- 24 after this incident because she allowed it to happen?
- 25 A. I didn't like it but after the incident she

- 1 did say sorry.
- 2 Q. And that was enough so you did not have the
- 3 same feelings of hate towards Deborah that you did
- 4 towards Terrie?
- 5 A. Correct.
- Q. And on the beginning of your testimony when
- 7 the State asked you, when Ms. Holthus asked you to
- 8 identify your family members, you called Deborah your
- 9 mother, correct?
- 10 A. Correct.
- 11 Q. That was not a misstatement. That's how
- 12 you feel about Deborah, correct?
- 13 A. Correct.
- 14 Q. You regard her as your mom and Terrie as
- 15 just Terrie?
- 16 A. Yes.
- 17 Q. I want to go back just a little bit to the
- 18 testimony that you gave about the first alleged
- 19 incident. I believe you testified that you were
- 20 eleven or 12 years old, correct?
- 21 A. Correct.
- 22 Q. And that it ended because the moms were
- 23 coming home.
- 24 A. Correct.
- 25 Q. So your younger brothers were home at that

- 1 time.
- 2 A. No.
- 3 Q. Okay. Where were your younger brothers?
- 4 A. They were most likely at school.
- 5 Q. And you were eleven years old at that time
- 6 so your, Ryan and Brandon would have been three,
- 7 correct?
- 8 A. Correct.
- 9 Q. So they were too young to actually be
- 10 enrolled in school, correct?
- 11 A. Correct.
- 12 Q. So were they with your mom?
- Were they at home?
- Who was watching the boys?
- 15 A. They would be babysitted somewhere else
- 16 like grandma's house.
- 17 Q. Okay. So they were not at school. They
- 18 were somewhere else.
- 19 A. Yes.
- 20 Q. And do you recall where your moms were --
- 21 I'm using plural -- where Deborah and Terrie were on
- 22 that particular occasion?
- 23 A. Terrie was at grandma's and Deborah was at
- 24 work.
- Q. And do you remember the first alleged

- 1 incident, what time of year it was, spring, summer,
- 2 winter, fall?
- 3 A. I don't remember what time of the year it
- 4 was.
- 5 Q. No recollection if it was near Christmas or
- 6 near summer break?
- 7 A. It wasn't near summer break. I don't
- 8 believe it was anywhere near Christmas at the time
- 9 but I know it was during school.
- 10 Q. During the school year do you mean?
- 11 A. In the school year.
- 12 Q. Do you recall what day of the week it was?
- 13 A. No.
- 14 Q. Do you recall approximately how long it
- 15 lasted?
- 16 A. About 20 minutes.
- 17 Q. Okay. Is there any type of -- after that
- 18 alleged incident occurred, who was the first person
- 19 in the family that you saw other than Chris?
- 20 A. I don't understand the question.
- 21 Q. Did you see -- who was the first person to
- 22 come home, was it your brother, was it your mom, was
- 23 it Terrie, who was the first person to come home?
- 24 A. Terrie.
- Q. And where were you in the house when Terrie

- 1 came home?
- 2 A. In the livingroom.
- 3 Q. And what were you doing when Terrie came
- 4 home?
- 5 A. At this moment in time I was already
- 6 dressed and watching TV.
- 7 Q. Okay. Approximately how long after the end
- 8 of the alleged incident did Terrie come home?
- 9 A. About 15, 17 minutes after.
- 10 Q. Okay. And there was nothing about your
- 11 demeanor that had Terrie ask you, "Hey, Anita what's
- 12 wrong?"
- 13 A. She normally goes straight to the office.
- 14 Q. Oh. In other words she did not ask you
- 15 what was wrong.
- 16 A. No.
- 17 Q. Did she say hello to you when she came in
- 18 the house?
- 19 A. No. She normally just walked straight on
- 20 the office.
- 21 Q. And then who was the next person to come
- 22 home?
- 23 A. Deborah.
- Q. Okay. And how long after Terrie got home
- 25 did Deborah come home?

- 1 A. About a couple of hours after.
- Q. Did Deborah ask you what was wrong?
- 3 A. At this moment in time I was acting normal.
- 4 Q. Okay. Prior to this alleged incident that
- 5 you testified to, had you had any type of
- 6 conversation with either of your moms about sex?
- 7 A. I wasn't allowed to tell anybody.
- 8 Q. No, just general sex. Had your mom had any
- 9 type of conversation with you about this is how sex
- 10 works, this is how a baby was made, anything like
- 11 that?
- 12 Did you have any knowledge about how sex
- 13 occurred?
- 14 A. At the age of 12 I had that talk.
- 15 Q. You had that talk at the age of 12.
- 16 A. Yes.
- 17 Q. So prior to this alleged incident, had you
- 18 had that talk?
- 19 A. No.
- Q. Okay. And I only say that because you said
- 21 that the first incident was maybe when you were
- 22 eleven and maybe when you were 12. So outside of any
- 23 conversation with your moms, had you had any type of
- 24 health class or sex education class at school where
- 25 you had learned about sex?

- 1 A. In seventh grade.
- Q. And at this time you are testified that
- 3 this alleged incident happened when you were in sixth
- 4 grade, correct?
- 5 A. Yes.
- 6 Q. So this alleged incident that you talked
- 7 about was your first information about any type of
- 8 sexual contact. Is that fair to say?
- 9 A. Yes.
- 10 Q. And you didn't tell your mom about it
- 11 afterwards, correct?
- 12 A. Correct.
- 13 Q. You didn't tell Deborah about it
- 14 afterwards, correct?
- 15 A. Correct.
- 16 Q. You didn't go and tell your grandmother
- 17 about it, correct?
- 18 A. Correct.
- 19 Q. When you went to school -- did you have
- 20 school the next day?
- 21 A. Yes.
- Q. Okay. You didn't tell any teachers about
- 23 it at school, correct?
- 24 A. Yes.
- Q. Okay. When you were growing up, was the

- 1 majority of your childhood -- 6012 Yellowstone?
- 2 A. I was living at 6012 Yellowstone.
- 3 Q. Okay. I believe you testified that you
- 4 were about nine when Terrie moved into that
- 5 residence; is that correct?
- 6 A. Correct, after grandpa died.
- 7 Q. And grandpa being Chris's father, correct?
- 8 A. Chris's father.
- 9 Q. So prior to nine years old, do you -- when
- 10 was the last time you had lived with Terrie, your
- 11 mother Terrie?
- 12 A. At eight.
- 13 Q. And where was that?
- Was that at your grandfather's house?
- 15 A. At my grandma's house.
- 16 Q. At your grandma's house.
- 17 A. On Terrie's side.
- 18 Q. And sorry. I'm just trying to remember the
- 19 date. When you were approximately five or six, is
- 20 that when Terrie and Chris got divorced?
- 21 A. Yes. Around there, yes.
- 22 Q. Prior to Terrie and Chris getting divorced,
- 23 as far as you remember did you live with both of
- 24 them?
- 25 A. I lived with both of them and then it came

- 1 to the point where I was living at grandma's house.
- 2 Q. I'm sorry. You were what?
- 3 A. Mainly at grandma's house.
- 4 Q. And grandma being Terrie's mom?
- 5 A. Yeah, Terrie's mom then it came to me and
- 6 Chris living with Tails.
- 7 Q. So at some point in time Terrie, your mom
- 8 Terrie left the family and left you and Tails with
- 9 Chris.
- 10 A. No. They were still -- she was still
- 11 living with grandma. I guess during the divorce I
- 12 was with Chris on the weekdays and Terrie on the
- 13 weekends.
- Q. Do you recall if you ever -- and I know you
- 15 were quite young. Do you recall if you ever made a
- 16 choice that you wanted to live with Chris?
- 17 A. I don't recall.
- 18 Q. And so after the divorce you were primarily
- 19 living with Chris; is that correct?
- 20 A. Correct, yes.
- 21 Q. And during that period of time he met
- 22 Deborah.
- 23 A. Yes.
- Q. All right. And how long after he met
- 25 Deborah if you remember did he and Deborah --

- 1 actually let me rephrase that.
- 2 How long after you met Deborah did Chris
- 3 and Deborah get married?
- 4 A. How long did I know Deborah before they got
- 5 married?
- 6 Q. Yeah.
- 7 A. About. I know it's been almost a year.
- 8 Q. Okay. And did you like Deborah right away?
- 9 A. Yes.
- 10 Q. And during that period of time when --
- 11 well, after Chris and Deborah got married, how long
- 12 after Chris and Deborah got married did Terrie move
- 13 back into the house?
- 14 A. A few years after.
- 15 Q. A few years after. Okay. And it was
- 16 shortly after Deborah and Chris got married that
- 17 Brandon was born, correct?
- 18 A. Correct.
- 19 Q. So at this point you've got yourself and
- 20 your younger brothers Tails and Brandon living in the
- 21 house.
- 22 A. Yes.
- 23 Q. So how old was Ryan when Ryan came and
- 24 started living at the house with Terrie?
- 25 A. About seven or eight months.

- 1 Q. Okay. So you had two babies in the house
- 2 at the same time.
- 3 A. Yes.
- 4 Q. Because Brandon and Ryan are quite close in
- 5 age, correct?
- 6 A. Correct.
- 7 Q. So after Terrie moved into the house, how
- 8 old were you when she comes back with Ryan if you
- 9 remember, maybe eight or nine?
- 10 A. About nine.
- 11 Q. From age of nine until you moved out in
- 12 2014 when you were 24 years old.
- 13 A. Correct.
- 14 Q. How many times did Terrie move in and out
- 15 of the house?
- 16 A. About five or six.
- 17 Q. And was there any as far as you could
- 18 tell -- let me rephrase that.
- 19 Did it mostly happen when you were
- 20 younger?
- Did it happen when you were older?
- Was it just all throughout that 15-year
- 23 period of time?
- 24 A. All throughout that 15-year time.
- 25 Q. And whenever Terrie moved out, she always

- 1 took Ryan with her, correct?
- 2 A. Correct.
- 3 Q. She never left Ryan back for you and
- 4 Deborah to take care of.
- 5 A. She never left Ryan.
- 6 Q. She also left Tails behind.
- 7 A. Correct.
- 8 Q. And left Tails with you and Chris.
- 9 A. Correct.
- 10 Q. And sometimes at least once or twice Terrie
- 11 moved out after the alleged abuse had already begun,
- 12 correct?
- 13 A. Correct.
- 14 Q. And you said that the incident that you
- 15 described where it was you and Terrie and Chris
- 16 happened when you were 14 years old; is that correct?
- 17 A. Yes.
- 18 Q. And Terrie moved out after that incident,
- 19 correct?
- 20 A. Yes.
- Q. And left you with Chris unsupervised,
- 22 correct?
- 23 A. Yup or yes, sorry.
- 24 Q. The most -- do you remember prior to you
- 25 leaving the house in June of 2014 when was the most

- 1 recent time that Terrie left the house?
- 2 A. Two years prior she left for a whole year.
- 3 Q. Okay. She left for a whole year. Do you
- 4 remember what time of year she left and what time of
- 5 year she came back, was it June or was it January?
- A. She left a few weeks after my birthday.
- 7 Q. Okay. So it would have been June of 2012
- 8 and she came back June of 2013.
- 9 A. I believe so.
- 10 Q. Approximately.
- 11 A. Yeah.
- 12 Q. When Terrie wasn't in the house, was it a
- 13 different dynamic in the house?
- 14 A. It was different, yes.
- 15 Q. Okay. Was it -- would you in your opinion
- 16 say it was better or worse when Terrie was gone?
- 17 A. It was less violent.
- 18 Q. And when -- do you recall asking or texting
- 19 Terrie to move back into the house during that year
- 20 when she was gone?
- 21 A. No
- 22 Q. Okay. Did you ever ask or ever have any
- 23 contact with Ryan to ask him to ask Terrie to move
- 24 back into the house?
- 25 A. No.

- 1 Q. You were fine that Terrie was out of the
- 2 house. Is that a fair statement?
- 3 A. Yes.
- 4 Q. Regarding the day that you moved out of the
- 5 house in June of 2014, after moving out you and
- 6 Deborah -- well, Deborah and Brandon went with you,
- 7 correct, when you moved out?
- 8 A. They took me with them.
- 9 Q. Okay. They took you with them.
- 10 A. Yes.
- 11 Q. That makes it sound like it was somebody's
- 12 idea other than yours.
- 13 A. It was.
- 14 Q. Whose idea was it?
- 15 A. Deborah.
- 16 Q. Deborah. Okay. And all three of you went
- 17 to safe house?
- 18 A. Correct.
- 19 Q. Did you know prior to the morning that you
- 20 all left that you were leaving?
- 21 A. I knew that we were leaving.
- 22 Q. Okay. When did you -- I believe the date
- 23 was like June 12th. Does that sound right?
- 24 A. Correct.
- Q. Okay. You leave early in the morning hours

- 1 of June 12th, correct?
- 2 A. Correct.
- 3 Q. How many days, hours, weeks whatever before
- 4 June 12th did you know that you were leaving?
- 5 A. About a month.
- 6 Q. Okay. It was about a month prior?
- 7 A. Almost a month, yes.
- 8 Q. And what was the -- if Deborah gave a
- 9 reason, what was the reason to leave?
- 10 A. The main reason was Chris --
- MS. HOLTHUS: Object, that's hearsay.
- MS. RADOSTA:
- 13 Q. What was your reason for leaving?
- 14 A. It was becoming too violent.
- 15 Q. Okay. And was that violence against you,
- 16 violence against Deborah, violence against Brandon?
- 17 A. Against Brandon.
- 18 Q. Was there an incident in particular that
- 19 you saw?
- 20 A. It was in the kitchen. I was working on my
- 21 bike because one of the employees at my work loosened
- 22 the bolts of my bike so I was fixing my bike. Chris
- 23 was outside cleaning the pool. Brandon came out and
- 24 asked me if he could make me dinner because I was
- 25 running late. I said yeah, sure. Thank you. So he

- 1 went into the house to make me dinner.
- I was still out fixing my bike. Chris
- 3 asked me where is Brandon. I'm like he's inside and
- 4 he's like what is he doing, I'm like making me
- 5 dinner. So he walked past me. I followed. He went
- 6 into the kitchen where Brandon was at. He asked
- 7 Brandon, "What are you doing?" Brandon said, "Making
- 8 my sister dinner." He hit him.
- 9 Q. What was -- if you know what was wrong with
- 10 Brandon making you dinner?
- 11 A. He technically wasn't supposed to be making
- 12 me dinner. He was supposed to be helping Chris clean
- 13 the pool and he didn't indicate or tell Brandon that
- 14 he was supposed to help him.
- 15 Q. I'm sorry. That was a little confusing.
- 16 In your opinion Brandon was slapped because he was
- 17 supposed to be helping Chris but didn't know he was
- 18 supposed to be helping Chris. Is that a fair
- 19 statement?
- 20 A. Correct.
- 21 Q. So he was making you dinner instead and
- 22 that got him in trouble.
- 23 A. Yes, and then when Chris asked him again
- 24 what are you doing, he replied the same answer, he
- 25 slapped him again. Then Chris kind of got a little

- 1 rough, put his hand up, said, "Do you want to go?"
- 2 This time -- I'm sorry -- this time while he was
- 3 backing Brandon up against the wall.
- 4 Q. Obviously you're getting a little upset
- 5 while you're talking about it. That clearly made you
- 6 upset to see any type of scuffle between Chris and
- 7 Brandon.
- 8 A. Correct.
- 9 THE COURT: I'm sorry. Did you say yes?
- 10 THE WITNESS: Yes.
- 11 MS. RADOSTA:
- 12 Q. Brandon is your younger brother, correct?
- 13 A. Correct.
- 14 Q. And you're actually related to him from
- 15 your, from Chris, correct? You share Chris as a
- 16 father.
- 17 A. Yes.
- 18 Q. Brandon is Deborah's son.
- 19 A. Yes.
- 20 Q. So that incident happened. Did that
- 21 incident happen -- in relationship to when you and
- 22 Deborah and Brandon moved out, you said the decision
- 23 was made a month before.
- 24 A. This one happened two weeks before we
- 25 left. We actually bumped it up because we were

- 1 trying to save money to get out of there.
- 2 Q. So now that incident happened two weeks
- 3 before you were moving out.
- 4 A. Correct.
- 5 Q. But actually moved out. But two weeks
- 6 before that incident you just described with Brandon
- 7 there's some type of a conversation with you and
- 8 Deborah where she says she's leaving and she wants
- 9 you to go with.
- 10 A. We were talking. It all started between me
- 11 and Brandon. We were talking. He got upset because
- 12 Chris was teasing him about Terrie's boobs. He kept
- 13 teasing about it. He actually told me what happened
- 14 between Terrie and Chris.
- 15 Q. Okay.
- 16 A. I didn't know that was happening to him so
- 17 I was really upset.
- 18 Q. So usual that what Brandon told you was
- 19 about he and Terrie and Chris. Correct?
- 20 A. Correct.
- Q. Not what about he and Deborah and Chris?
- 22 A. Correct.
- Q. And so you hear about what happened with
- 24 Brandon and that gets you upset as well.
- 25 A. Very upset.

- 1 Q. Does that conversation happen before or
- 2 after you see the scuffle over making you dinner?
- 3 A. Before.
- 4 Q. It happened before. And at the time that
- 5 Brandon told you about the alleged incident with him
- 6 and Terrie and Chris, did you confide in him about
- 7 anything that had been allegedly happening to you?
- 8 A. I told him that he wasn't alone.
- 9 Q. And is that the extent of what you said to
- 10 him?
- 11 A. Pretty much in those words.
- 12 Q. Okay. And what was Brandon's reaction to
- 13 that?
- 14 A. He was upset also and he was crying.
- 15 Q. Did he say anything that he was going to go
- 16 and confront about what you had just told him?
- 17 A. He said he was going to run away or commit
- 18 suicide.
- 19 Q. And this was after hearing about what you
- 20 had said or what he had told you happened to him?
- A. About what he had told me what happened to
- 22 him.
- Q. And after Brandon said that he was worried
- 24 or that he was upset and might commit suicide, did
- 25 you feel the need to perhaps tell Deborah about that?

- 1 A. I did.
- 2 Q. Did you tell Deborah about that?
- 3 A. Yes.
- 4 Q. Did you tell anybody else in the house
- 5 about that?
- 6 A. No.
- 7 Q. Did you tell Ryan about that or Tails?
- 8 A. No.
- 9 Q. Even though they shared a room with
- 10 Brandon, correct?
- 11 A. Correct.
- 12 Q. And they could probably keep a better eye
- 13 on him than you could.
- 14 A. Correct.
- 15 Q. They shared a room and slept in the same --
- 16 well, sorry. They spent the night in the same room
- 17 with him, correct?
- 18 A. Correct.
- 19 Q. When you -- the decision was made by
- 20 Deborah that you guys were going to leave the house.
- 21 A. I tried to convince them that we had to
- 22 leave and they said yes.
- Q. So it was your idea now to leave the house,
- 24 correct?
- 25 A. I said we got to get out of here.

- Q. Okay. And this was after your conversation with Brandon.
- 3 A. Yes.
- 4 Q. But before the scuffle with Brandon and
- 5 Chris.
- 6 A. This was all before the scuffle between
- 7 Chris and Brandon.
- 8 Q. And so there was a decision -- somebody
- 9 made the decision that you were going to go to safe
- 10 house, correct?
- 11 A. Yes.
- 12 Q. Deborah made that decision.
- 13 A. Yes.
- Q. Did you have any idea that that's where you
- 15 were going prior to leaving the house on the morning
- 16 of June 12th?
- 17 A. No.
- 18 Q. When you left the house on the morning of
- 19 June 12th, you had your phone with you, correct?
- 20 A. Correct.
- Q. And you were actually on the app on your
- 22 phone watching the house, correct?
- 23 A. Yes.
- Q. And the app on your phone was actually the
- 25 live feed of the cameras in the house, correct?

- 1 A. Correct.
- 2 Q. And so you and Brandon and Deborah leave
- 3 the house at about 5:00 in the morning. Is that
- 4 right?
- 5 A. Yes.
- 6 Q. And approximately how long before you saw
- 7 any movement in the house on your phone?
- 8 A. About almost 45 minutes later.
- 9 Q. Okay. And when you were watching on your
- 10 phone, what was the first thing that you saw on the
- 11 live feed?
- Was it Chris or was it Ryan or was it
- 13 Terrie?
- 14 A. Terrie.
- 15 Q. I'm sorry.
- 16 A. Terrie.
- 17 Q. It was Terrie. Okay. At what point in
- 18 your opinion did people realize in the house that you
- 19 and Deborah and Brandon were gone?
- 20 A. About eleven minutes after Terrie ran into
- 21 the main house and Chris ran out to the office.
- Q. Okay. And so there seemed to be a bit of
- 23 excitement, for lack of a better term, running around
- 24 --
- 25 A. Yes.

- 1 Q. -- looking for people. Is that a fair
- 2 statement?
- 3 A. I believe so, yes.
- 4 Q. Okay. And when that was happening, Tails
- 5 and Ryan were still in the house, correct?
- 6 A. Correct.
- 7 Q. And you didn't tell Tails or Ryan that you
- 8 were leaving with Deborah and Brandon, correct?
- 9 A. Correct.
- 10 Q. You didn't tell Terrie that you were
- 11 leaving.
- 12 A. Correct.
- 13 Q. Were you worried that if you told Terrie,
- 14 that she would tell Chris?
- 15 A. Correct.
- Q. Were you worried if you told Ryan, that he
- 17 would tell Chris?
- 18 A. Correct.
- 19 Q. And you were worried if you told Tails, he
- 20 would tell Chris.
- 21 A. Correct.
- 22 Q. So you felt that you couldn't trust them
- 23 with this particular piece of information.
- 24 A. Yes.
- Q. When you were watching on the live feed,

- 1 you also were able to tell I believe that Terrie and
- 2 Ryan were asked to leave the house that morning,
- 3 correct?
- 4 A. No.
- 5 Q. You couldn't tell that or they weren't
- 6 asked to leave?
- 7 A. I couldn't tell.
- 8 Q. Did you at any point in time come to find
- 9 out that Terrie and Ryan left the house?
- 10 A. Yes.
- 11 O. Moved out of the house.
- 12 A. Were kicked out of the house, yes.
- 13 Q. Were kicked out of the house. Were you
- 14 able to see that on the live feed or was that rumors
- 15 that you heard?
- 16 A. That was from an e-mail that Chris sent me.
- 17 Q. Okay. When did you receive that e-mail in
- 18 relationship to June 12th?
- 19 A. I didn't read any of the e-mails because I
- 20 didn't want to read the e-mails because when we left
- 21 -- I had a disturbing voicemail that said that Chris
- 22 wanted to commit suicide and he thought that Deborah,
- 23 me, and Brandon committed suicide because of the
- 24 early suicide the few weeks before we left.
- Q. Okay. I'm really sorry to ask you

- 1 questions about that because I understand it's
- 2 upsetting, but I just don't understand your answer.
- 3 You received a voicemail from Chris.
- 4 A. Correct.
- 5 Q. And you leave on June 12th. Did you
- 6 receive the voicemail that day, the next day?
- 7 A. The day.
- 8 Q. The day. Did you listen to it that day?
- 9 A. I listened to the first e-mail or
- 10 voicemail.
- 11 Q. Okay.
- 12 A. He said that he wanted to commit suicide,
- 13 that he thought his family committed suicide.
- Q. Okay. So it was an upsetting voicemail to
- 15 hear.
- 16 A. Yes.
- 17 Q. And after that, and please correct me if
- 18 I'm wrong, after you heard that voicemail, you did
- 19 not listen to any further voicemail.
- 20 A. Correct.
- 21 Q. Ever or did you just delay listening to
- 22 them?
- 23 A. I allowed Brandon and Deborah to listen to
- 24 the voicemails. They were too upsetting.
- 25 Q. Did you ever listen to any further

- 1 voicemails of Chris?
- 2 A. No.
- 3 Q. Okay. I had asked you a question about and
- 4 you responded about receiving an e-mail from Chris.
- 5 A. Yes.
- 6 Q. And you said you didn't read any e-mails
- 7 because of the voicemails.
- 8 A. I stopped listening to the voicemails and I
- 9 didn't read the e-mails until a couple months later.
- 10 Q. Okay. But the e-mail, do you recall when
- 11 the e-mail was sent?
- 12 A. No, I'm sorry.
- 13 Q. Okay. No problem. So and just to make
- 14 this a little bit clearer, it was an e-mail that you
- 15 learned that Deborah or, I'm sorry, that Terrie and
- 16 Ryan had been kicked out of the house.
- 17 A. Yes.
- 18 Q. So you didn't learn that for several
- 19 months.
- 20 A. Correct.
- 21 Q. So you and Deborah and Brandon go to the
- 22 safe house on the morning of June 12, 2014, correct?
- 23 A. Yes.
- Q. The rules for staying at the safe house I
- 25 believe is that you have to be a victim of abuse,

- 1 correct?
- 2 A. Yes.
- 3 Q. Now, Brandon was allowed to stay with
- 4 Deborah because he's a minor, correct?
- 5 A. Correct.
- 6 Q. He didn't necessarily have to be a victim
- 7 of abuse in order to stay with his mom. If Deborah
- 8 had gone in and said, "I'm a victim of abuse and this
- 9 is my son," they would have let Brandon stay with
- 10 her, correct?
- 11 A. Correct.
- 12 Q. But you were an adult, correct?
- 13 A. Correct.
- 14 Q. So in order for you to stay there you had
- 15 to also be a victim of abuse.
- 16 A. Correct.
- 17 Q. When you get to the safe house on
- 18 June 12th, did you and Brandon and Deborah all share
- 19 one living space?
- 20 A. Yes.
- Q. Okay. And you stayed at the safe house for
- 22 how long?
- A. Two weeks.
- Q. But you did not immediately report -- you
- 25 did not immediately report any of the incidents at

- 1 the house to the police, correct?
- 2 A. No.
- 3 Q. As a matter of fact you did not speak to
- 4 the police until after Deborah filed for divorce,
- 5 correct?
- 6 A. Actually I talked to the police in
- 7 September.
- 8 Q. Deborah started filing divorce paperwork in
- 9 August; is that correct?
- 10 A. I believe it was a month more before August
- 11 I think.
- 12 Q. Maybe even in July.
- 13 A. Yeah.
- 14 THE COURT: I'm sorry. What year?
- MS. RADOSTA:
- 16 Q. Of 2014?
- 17 A. Yeah.
- 18 Q. So you guys move out in June of 2014. Your
- 19 recollection is that Deborah starts divorce
- 20 proceedings against Chris in July of 2014.
- 21 A. I believe so.
- Q. And you're living with Deborah this entire
- 23 time, correct?
- A. Correct.
- Q. And then you don't speak to the police

- 1 until September 2014, correct?
- 2 A. Correct.
- 3 Q. And did you and Deborah and Brandon all
- 4 speak to the police on the same day?
- 5 A. Correct.
- Q. At this point in time do you have any idea
- 7 -- when you're speaking to the police in September
- 8 of 2014, do you have any idea where Tails or Ryan is?
- 9 A. Tails was living with Chris still and Ryan
- 10 and Terrie were living with her, I guess her fiancee
- 11 Ed.
- 12 Q. Now, you at this point had some
- 13 knowledge -- strike that. Let me rephrase.
- Brandon had told you of an alleged incident
- 15 of sexual acts between him and Chris and Deborah,
- 16 correct, and him and Chris and Terrie, correct?
- 17 A. It was just Terrie not Deborah.
- 18 Q. But you were aware that there was some type
- 19 of sexual conduct between Chris and Brandon and
- 20 Terrie.
- 21 A. Yes.
- Q. And when you left the house, you knew that
- 23 Tails was still in the house, correct?
- A. Correct.
- Q. Were you worried about Tails at all living

- 1 at the house?
- 2 A. No because he tends to leave.
- 3 Q. Okay. But he was in the house when you
- 4 left that day.
- 5 A. Yes.
- 6 Q. And you knew that Ryan was still in the
- 7 house when you left that day, correct?
- 8 A. Yes.
- 9 Q. Were you worried that anything might have
- 10 happened to Ryan since you had information that
- 11 things had happened to Brandon?
- 12 A. I was worried, yes.
- 13 Q. And yet you waited almost 90 days to go to
- 14 the police, correct?
- 15 A. Correct.
- 16 Q. Okay. Why -- you were 24, 25 years old at
- 17 this point. 24 I believe, correct?
- 18 A. Yes.
- 19 Q. Did you and Deborah decide not to go to the
- 20 police or was that your decision on your own?
- 21 A. I asked to go to the police because Chris
- 22 was sending some awful things. He was sending
- 23 e-mails to Deborah's work to try to get her fired.
- 24 He was using Deborah's Facebook to make things seem
- 25 like it was okay. He was still sending e-mails to

- 1 us.
- 2 Q. Okay.
- 3 A. He also it looked like a warning on
- 4 Facebook where he was counting down because normally
- 5 when he counts down, it means something bad is going
- 6 to happen.
- 7 Q. So the reason why you eventually went to
- 8 the police was because of things that you saw on
- 9 Facebook, correct?
- 10 A. Not only Facebook, he also stole Deborah's
- 11 truck from work.
- 12 Q. Okay. Did you see him take the truck from
- 13 work or are you assuming that he took the truck from
- 14 work?
- 15 A. No. He took the truck.
- 16 Q. Did you see that happen?
- 17 A. No.
- 18 Q. So you don't know for a fact that Chris is
- 19 the one that took the truck from work, correct?
- 20 A. I know that he took the truck because it
- 21 was in front of the house when we had it.
- 22 Q. So you know the truck was in front of the
- 23 house and you know the truck had been at Deborah's
- 24 work, correct?
- 25 A. Correct.

- 1 Q. But you don't know for a fact how it got
- 2 from work to the house.
- 3 A. No.
- 4 Q. Although it appears you suspect that Chris
- 5 took the truck from work, did you report that theft
- 6 of the vehicle to the police?
- 7 A. Yes.
- 8 Q. Okay. When did you report that to the
- 9 police?
- 10 A. Deborah reported it to the police on that
- 11 day that -- they said that they couldn't do anything
- 12 because they believed Deborah and Chris were still
- 13 married.
- 14 Q. Something having to do with the fact that
- 15 his name might have been on the ownership of the
- 16 truck.
- 17 A. Correct, yes.
- 18 Q. The Facebook incident, Deborah's Facebook
- 19 account you mentioned it a second ago, that that was
- 20 the reason why you decided to go to the police. Is
- 21 it fair to say that you felt that Chris hacked into
- 22 Deborah's Facebook page?
- 23 A. Yes.
- Q. Okay. That fact made you mad enough to
- 25 want to go and report Chris to the police, correct?

- 1 A. Correct.
- 2 Q. It was one fact that made you want to go to
- 3 the police; is that correct?
- 4 A. There were several facts.
- 5 Q. But that's one of them, hacking into the
- 6 Facebook account.
- 7 A. Correct.
- 8 Q. You felt it was a real violation of
- 9 Deborah's privacy, correct?
- 10 A. Correct.
- 11 Q. How did you -- what made you think that
- 12 somebody had hacked into Deborah's Facebook account?
- 13 A. Because there was posts -- because I was
- 14 with Deborah constantly. We were -- one of the rules
- 15 for safe house was that you weren't supposed to be on
- 16 the media.
- 17 Q. On social media?
- 18 A. On social media.
- 19 Q. Okay.
- 20 A. When we left and we were able to
- 21 finally get onto the media or just check it, there
- 22 has been posts on Deborah's Facebook to this day that
- 23 weren't even allowed on the media.
- Q. And in your opinion that was Chris was the
- 25 one that had gotten into the Facebook account?

- 1 A. Yes.
- 2 Q. And by hacking into the account, this means
- 3 he got access to her page.
- 4 A. Yes.
- 5 Q. Knew her password. Knew her using name and
- 6 got onto the Facebook page.
- 7 A. Yes.
- 8 Q. Did Deborah ever report this, quote,
- 9 unquote, hacking to Facebook?
- 10 A. Yes.
- 11 Q. What was -- if you know, was anything done
- 12 about it by Facebook?
- 13 A. No.
- 14 Q. At what point -- you said that you stayed
- 15 at the safe house for two weeks and it was after you
- 16 left the safe house that you realized something had
- 17 happened.
- 18 A. Correct.
- 19 Q. Was it immediately after leaving?
- 20 A. After we left safe house we got an
- 21 apartment and we moved in and stuff like that. She
- 22 got a new phone and stuff like that because she left
- 23 -- Brandon and Deborah left their phones at the
- 24 house.
- 25 Q. And you referenced that you had your phone

- 1 and Deborah and Brandon did not.
- 2 A. Correct.
- 3 Q. Why did you decide to keep your phone and
- 4 they left their phones?
- 5 A. Because there was tracers on their phone
- 6 and my phone did not.
- 7 Q. How do you know there were tracers on their
- 8 phone?
- 9 A. They always have tracers.
- 10 Q. How did you know they had tracers on their
- 11 phone?
- 12 A. Before I was able to buy my own phone,
- 13 Chris was always able to trace us by our phones.
- Q. So it's a tracking program so he would know
- 15 where the members of his family were, correct?
- 16 A. Correct.
- Q. When you got your own phone, you didn't
- 18 have that.
- 19 A. Correct.
- Q. While you had your phone, though, you
- 21 continued to have access to the live feed at the
- 22 house, correct?
- 23 A. Correct.
- Q. After you moved out on June 12, 2014.
- 25 A. Correct.

- 1 Q. Did you continue to check the live feed
- 2 once you moved out of safe house?
- 3 A. After we left, no.
- 4 Q. You never checked it again?
- 5 A. I checked, we checked about a few times and
- 6 then we stopped because it was getting too upsetting.
- 7 Q. And at that point in time the only person
- 8 that was at the house was Chris, correct?
- 9 A. Chris and Tails.
- 10 Q. Chris and Tails. Tails did not move out.
- 11 A. I don't know.
- 12 Q. So when you checked on the live feed, did
- 13 you see Tails there or were you just assuming that
- 14 Tails was still there?
- 15 A. I'm assuming he was there.
- MS. RADOSTA: Court's indulgence. I
- 17 apologize.
- THE COURT: Do you want a break?
- MS. RADOSTA: I still have a fair amount.
- 20 If Anita wants --
- THE COURT: We'll take a few minute break
- 22 then. Ten minutes. All right.
- 23 (Whereupon a recess was taken
- 24 from 2:39 p.m. until 2:52 p.m.
- after which the following

- proceedings took place:)
- THE COURT: All right. We're back on the
- 3 record.
- 4 MS. HOLTHUS: Could I interrupt briefly,
- 5 Judge. We have our last witness out there with his
- 6 dad. We've been here multiple times. We're probably
- 7 not even going to start him let alone finish. I was
- 8 wondering if we can go ahead and just release him.
- 9 THE COURT: Sure. I take it you're not
- 10 going to be done by 3:30.
- MS. RADOSTA: No.
- 12 THE COURT: Can we begin tomorrow?
- MS. RADOSTA: We were all talking tomorrow
- 14 and all of our trial schedules are getting a little
- 15 bunched. If you want to set it sometime the week of
- 16 the 14th although Ms. Holthus and I might be in trial
- 17 that week, but she's definitely in trial next week
- 18 so. . . .
- 19 THE COURT: So the week of September 14th.
- MS. RADOSTA: With the caveat, Judge, that
- 21 if either of us are in trial, we're going to have to
- 22 reset it because the trial judges sadly don't care if
- 23 we have a prelim. They feel it's district court --
- THE COURT: So this will be Ryan. He
- 25 doesn't live out of state. He's local. Sure. If

- 1 you wanted to go to see him and see his
- 2 availability. The 18th is the only free day that we
- 3 have that week. We have no other prelims set at this
- 4 time. We don't have our in-custodies obviously yet.
- 5 Tomorrow we'll know how many in-custody prelims that
- 6 we have but otherwise September 18th.
- 7 MS. HOLTHUS: If we do it in the morning.
- 8 MS. RADOSTA: If they don't have any other
- 9 prelims and you might have in-custodies.
- THE COURT: We'll only set in-custody
- 11 prelims for the 18th but whatever in-custody prelims
- 12 that we have. We'll know tomorrow how many will be
- 13 set on the 18th and then --
- MS. HOLTHUS: Can we try to set the
- 15 morning.
- THE COURT: Yeah. Let's set it for 11:00
- 17 on the 18th and if we can start earlier, we'll let
- 18 you know.
- MS. HOLTHUS: If we plan on 10:00 only if
- 20 for any reason we were in trial, theoretically I
- 21 could get somebody to start at 1:00. Some judges
- 22 will depending on how you're going. You start at
- 23 1:00 if we know.
- THE COURT: I'm happy to set it at 10:00 I
- 25 just don't know you'll be able to go on at 10:00. We

- 1 obviously can let you know as someone who progresses
- 2 on the 18th or you can contact the track D.A. and
- 3 find out how many are going forward that day.
- 4 You know you're still under oath, correct?
- 5 THE WITNESS: Yes.
- 6 MS. RADOSTA:
- 7 Q. Anita, there were other over the years
- 8 other family members that would come over to the
- 9 house occasionally, correct, female family members?
- 10 A. Yes.
- 11 Q. And they were younger than you, correct?
- 12 A. Yes.
- 13 Q. And I'm talking primarily about Tamara and
- 14 Erin, correct?
- 15 A. Yes.
- 16 Q. You were aware that those girls, Tamara and
- 17 Erin, were coming over to the house, correct?
- 18 A. Yes.
- 19 Q. Were you always at the house when they were
- 20 at the house?
- 21 A. Sometimes.
- 22 Q. Sometimes but not always.
- A. Not always.
- Q. And they were coming over to the house
- 25 after the alleged abuse had started with you,

- 1 correct?
- 2 A. Correct.
- 3 Q. And you told Terrie that Erin and Tamara
- 4 shouldn't be coming over to the house, correct?
- 5 A. Yes.
- 6 Q. Did you tell Terrie that?
- 7 And you also told your aunt Melissa that
- 8 Erin shouldn't be coming over to the house, correct?
- 9 A. No.
- 10 Q. That's Erin's mom.
- 11 A. Yes.
- 12 Q. What about Tamara's mom, your aunt
- 13 Kimberly, did you ever tell her?
- 14 Did you tell your grandma that Tamara
- 15 shouldn't be --
- Who did Tamara live with?
- 17 A. Grandma.
- 18 Q. Did you tell grandma Tamara shouldn't be
- 19 coming over to the house?
- 20 A. No.
- Q. Did you tell your grandma that Tamara and
- 22 Erin shouldn't be coming over to the house?
- 23 A. No.
- Q. But you told Terrie because they were
- 25 Terrie's nieces.

- 1 A. Correct.
- 2 Q. And you felt that Terrie should be the one
- 3 to protect them if they needed protection.
- 4 A. True.
- 5 Q. How many times -- did you tell Terrie that
- 6 Erin and Tamara shouldn't come over to the house?
- 7 A. Yes.
- 8 Q. How old were you if you recall that you had
- 9 that conversation with Terry?
- 10 A. I was 13.
- 11 Q. And just so that we understand, how much
- 12 younger than you is Tamara?
- 13 A. I don't recall.
- Q. Okay. One year, five years, six years, no
- 15 idea. What about Erin?
- 16 A. Erin, no.
- 17 Q. You don't have any idea how much younger
- 18 she is than you.
- 19 A. No.
- Q. Okay. Just so that I'm clear, regarding
- 21 the conversation that you had with Brandon about when
- 22 he told you about the alleged sexual abuse of him
- 23 with Chris and Terrie, that was a different day than
- 24 the argument in the kitchen over him making you
- 25 dinner.

- 1 A. Yes.
- 2 Q. Two separate days.
- 3 A. Two separate days.
- 4 Q. The conversation with Brandon when he
- 5 confided in you, where did that conversation take
- 6 place?
- 7 A. Outside.
- 8 Q. Outside what, outside the house?
- 9 A. Outside the house.
- 10 Q. Okay. Where outside the house?
- 11 A. Out in the backyard.
- 12 Q. Okay. Can you describe the backyard.
- Where in the backyard was it?
- 14 A. In the backyard there's two sheds, a pool,
- 15 then the office and then there's an awning with
- 16 chairs. We were underneath the awning with chairs.
- 17 Q. And at that point in time there were
- 18 cameras outside of the house, correct?
- 19 A. Correct.
- Q. And part of that was for security to see
- 21 what was going on outside the house.
- 22 A. Yes.
- Q. And was there a camera, were you guys in
- 24 the camera line of sight when you were sitting under
- 25 the awning?

- 1 A. Yes.
- 2 Q. You were not worried that you were being
- 3 seen by Chris, correct?
- 4 A. Not at that moment, no.
- 5 Q. Okay. How long did the conversation with
- 6 Brandon last?
- 7 A. About 17 to 20 minutes.
- 8 Q. 17 to 20 minutes. Okay. And did either of
- 9 you cry during the conversation?
- 10 A. Yes.
- 11 Q. Did you give Brandon a hug after the
- 12 conversation?
- 13 A. Yes.
- 14 Q. When you came back inside the house, did
- 15 you have any indication if Chris knew about that
- 16 conversation?
- 17 A. No.
- 18 Q. What about Deborah?
- 19 A. I told her.
- Q. You told her about the conversation but she
- 21 was not -- she hadn't watched it on the live feed.
- 22 A. No.
- Q. Okay. When did you tell Deborah about that
- 24 conversation?
- 25 A. Later on that day when she came home.

- 1 Q. Okay. Did you tell Deborah everything that
- 2 Brandon had told you about his allegation against
- 3 Terrie?
- 4 A. I told her, yes.
- 5 Q. And Deborah's reaction to that information
- 6 was what?
- 7 A. A little freaked out.
- 8 Q. Define "freaked out."
- 9 A. Like horrified, like that.
- 10 Q. So you put your hand up in front of your
- 11 face.
- 12 A. No. I was doing the face like jaw open, a
- 13 little wide eyed.
- 14 Q. Did she get angry?
- 15 A. She got upset.
- Q. Okay. By "upset," what do you mean?
- Did she cry?
- Did she yell?
- 19 A. She was almost in tears.
- 20 Q. Almost in tears. Okay. Did she threaten
- 21 to do anything to Terrie when she heard this
- 22 information physically?
- 23 A. I don't recall if she did anything.
- Q. Did she say she was going to do anything to
- 25 Terrie?

- 1 A. I think she was more shocked that she
- 2 didn't say anything.
- 3 Q. I'm sorry. She is more shocked that she
- 4 didn't --
- 5 A. Say anything.
- 6 Q. At that point in time when you told Deborah
- 7 about that conversation, the decision had already
- 8 been made to leave the house.
- 9 A. After that conversation we talked a little
- 10 bit more about the violence in the house. How are we
- 11 going to get out of the house without Christopher
- 12 knowing.
- 13 Q. Okay. You did not pack up and leave that
- 14 night, correct?
- 15 A. Correct.
- 16 Q. You stayed in the house for another
- 17 approximately two to three weeks.
- 18 A. Yes.
- 19 Q. Prior to that June 12, 2014, date that you
- 20 and Deborah and Brandon left the house, had you ever
- 21 tried to leave the house before, you, just you?
- 22 A. I had wanted to leave the house, but I had
- 23 no money to leave the house.
- Q. So you did not pack up your bags and try to
- 25 leave the house.

- 1 A. No.
- Q. Okay. But you wanted to leave the house.
- 3 Is that fair?
- 4 A. Yes.
- 5 Q. Were you staying in the house because you
- 6 didn't want to leave without Brandon?
- 7 A. I didn't want to leave my brothers there.
- 8 Q. Any of your brothers?
- 9 A. Any of my brothers.
- 10 Q. So that would be Brandon, Tails, or Ryan?
- 11 A. Correct.
- 12 Q. You didn't want to leave any of them.
- 13 A. Yes.
- 14 Q. And what changed that made you leave --
- 15 what changed your decision to leave on the 12th of
- 16 June, 2014, that you did leave Tails and Ryan behind?
- 17 A. Tails wasn't supposed to be there that day.
- 18 Q. Okay.
- 19 A. Because he moved out. He was out of the
- 20 house. Terrie was going to leave anyways.
- 21 Q. Okay.
- 22 A. According to some hints that she gave that
- 23 she was going to leave again.
- Q. Okay. So it was your belief that Terrie
- 25 was on the verge of moving out.

- 1 A. Yes.
- 2 Q. But she never told you that.
- 3 A. No.
- 4 Q. That was just your impression.
- 5 A. Yes.
- Q. When you were watching the live feed on the
- 7 morning, that morning of June 12, 2014, was it
- 8 satisfying to see Chris running around the house
- 9 looking for you guys?
- 10 A. No. It was terrifying.
- 11 Q. It was terrifying. Okay. Did you see him
- 12 break anything, break any furniture or anything like
- 13 that as he was running around the house?
- 14 A. We didn't watch the feed that much.
- 15 Q. Weren't you watching the feed to see if he
- 16 left the house?
- 17 A. Yes.
- Q. Were you watching the feed to see if he was
- 19 using the phone to try to find you guys?
- 20 A. We were mainly keeping an eye on the
- 21 vehicles outside.
- Q. Okay. Were you watching the feed to see if
- 23 Terrie and Ryan were okay inside the house?
- A. We watched it to make sure that he didn't
- 25 leave the house to follow us. We were more terrified

- 1 of him finding us.
- Q. Okay. And he didn't leave the house that
- 3 morning, correct?
- 4 A. As I recall I don't really know if he left.
- 5 Q. You would remember, wouldn't you, if you
- 6 saw Chris get into the car while you were watching
- 7 him on the live feed that morning, correct?
- 8 A. Yes.
- 9 Q. And you didn't see him get in the car and
- 10 leave that morning, right?
- 11 A. No.
- 12 Q. And you didn't see him break anything in
- 13 the house, correct?
- 14 A. Not that I recall, no.
- 15 Q. You didn't see him hit Terrie or hit Ryan
- 16 that morning, correct?
- 17 A. No, not that I recall.
- 18 Q. And you testified that you guys were
- 19 worried, though, that he was going to get in the car
- 20 and try to find you?
- 21 A. Yes.
- 22 Q. But you were going to the safe house,
- 23 correct?
- 24 A. Yes.
- Q. Was Deborah continuing to work at that

- 1 point in time or did she not work at her place of
- 2 business?
- 3 A. She was working.
- 4 Q. She was working. And that was her place of
- 5 work her, place of employment that she'd been working
- 6 at for years, correct?
- 7 A. Correct.
- 8 Q. And for 10, 15 years she'd been working at
- 9 that location.
- 10 A. 15.
- 11 Q. 15 years, 15, 16 years. And after you guys
- 12 moved out on June 12th, Deborah continued to go to
- 13 work.
- 14 A. She requested two weeks off and then went
- 15 back to work.
- 16 Q. Okay. So there was a two-week break and
- 17 she went back to work at the place she had been at
- 18 for 16 years.
- 19 A. Yes.
- Q. And everybody in the family knew where
- 21 Deborah worked, correct?
- 22 A. Correct.
- Q. You knew the physical location of where she
- 24 worked, correct?
- 25 A. Yes.

- 1 Q. And Chris knew that physical location as
- 2 well, correct?
- 3 A. Correct.
- 4 Q. When you -- I'm sorry. I kept going back
- 5 to this conversation with Brandon when he first
- 6 confided in you. When you first found out that
- 7 information that Brandon said there was a sexual
- 8 encounter between him and Terrie and Chris, that made
- 9 you angry, didn't it?
- 10 A. Yes.
- 11 Q. Because you thought you were the only one
- 12 that anything was happening to in the house, correct?
- 13 A. Correct.
- Q. But nobody ever said that you were the only
- 15 one that anything was happening to, correct?
- 16 A. Correct.
- 17 Q. Chris never said you're the only one that
- 18 this is happening to, correct?
- 19 A. Correct.
- 20 Q. And you had the encounter with Deborah and
- 21 she never said you're the only one this is happening
- 22 to, correct?
- 23 A. Correct.
- Q. And you had the encounter with Terrie and
- 25 she never said you're the only one this is happening

- 1 to, correct?
- 2 A. Correct.
- 3 Q. So that was just your impression that it
- 4 was just you.
- 5 A. Correct.
- 6 Q. So when you found out that it wasn't just
- 7 you, you got angry.
- 8 A. Correct.
- 9 Q. Fair to say that some of the acts of sex
- 10 between you and Chris were you keeping him in a good
- 11 mood. Do you recall telling the police that?
- 12 A. Yes.
- 13 Q. Okay. That you would go into his room when
- 14 you thought he was in a bad mood.
- 15 A. Correct.
- 16 Q. And what would a bad mood be around the
- 17 house?
- 18 A. Him.
- 19 Q. I'm sorry. A bad mood of Chris's, what
- 20 would that be around the house?
- 21 A. Him hitting you or throwing something at
- 22 you.
- 23 Q. So you were worried about a bad mood and
- 24 you were trying to prevent a bad mood when you would
- 25 go into his room sometimes?

- 1 A. Yes, to prevent any hitting or yelling at
- 2 the boys.
- 3 Q. Okay. So you were trying to prevent
- 4 anything, any type of potential physical violence
- 5 against the boys.
- 6 A. Correct.
- 7 Q. Okay. The house that you described you
- 8 said originally it was configured to be a two-bedroom
- 9 house and you made it into a three-bedroom house.
- 10 It's actually a pretty small house, correct?
- 11 A. Yes.
- 12 Q. About 1,000 square feet.
- 13 A. About.
- 14 Q. You had your own room, correct?
- 15 A. Correct.
- 16 Q. And the three boys when everybody was
- 17 living under the same roof they all shared the same
- 18 room.
- 19 A. Yes.
- 20 Q. When you -- after you graduated high
- 21 school, you got a job. You were working, things like
- 22 that, correct?
- 23 A. Yes.
- Q. When you were home, where did you generally
- 25 spend your time in the house?

- 1 A. In my room.
- 2 Q. In your room.
- 3 A. Or in the livingroom.
- 4 Q. Or in the livingroom. Okay. When you were
- 5 in your room, were you generally alone in your room
- 6 or did the boys come in and hang out with you and
- 7 watch TV or were you pretty much in your room alone?
- 8 A. I was pretty much in my room alone but most
- 9 of the time some of the boys would come into my room
- 10 and hang out with me and watch TV in my room.
- 11 Q. You never -- when you were home, you never
- 12 saw Terrie bring Ryan into the master bedroom,
- 13 correct?
- 14 A. No.
- 15 Q. You never saw Deborah bring Brandon into
- 16 the master bedroom, correct?
- 17 A. No. The only time they got brought in the
- 18 room is when they were in trouble.
- 19 Q. Okay. Did you ever see that happen?
- 20 A. There was a few times when something
- 21 happened and the boys would get in trouble and he
- 22 would have the boys come into the bedroom with him
- 23 and close the door then, there would be times when he
- 24 opened the door and yell for the girls and the girls
- 25 would go into the bedroom.

- 1 Q. Okay. You gave me a lot of information
- 2 with that answer. When you thought the boys were in
- 3 trouble for something and they were taken or called
- 4 into the master bedroom, or were they taken into the
- 5 master bedroom?
- 6 A. They were told to go into the master
- 7 bedroom with Chris.
- 8 Q. Okay. So Terrie or Deborah would tell
- 9 Brandon or Ryan to go into the master bedroom.
- 10 A. When Chris tells them to tell them.
- 11 Q. So you would think the boys were in
- 12 trouble?
- 13 A. Yes.
- 14 Q. 'Cause you knew they were in trouble. You
- 15 saw something happened. Is that why you thought they
- 16 were in trouble?
- 17 A. Sometimes yes.
- 18 Q. And when the boys were in the master
- 19 bedroom at that point how long would they be in the
- 20 master bedroom, was it five minutes or was it a half
- 21 an hour?
- 22 A. About ten minutes.
- Q. And how many times would you say you saw
- 24 Brandon in the master bedroom with Deborah and Chris?
- 25 A. A few times.

- 1 Q. A few times, two, three?
- 2 A. Three.
- 3 Q. What about Ryan going in there with Terrie?
- 4 A. A lot.
- 5 Q. A lot. Okay. What is a lot, 10, 15, 20?
- 6 A. More than 20.
- 7 Q. More than 20 times. Was Ryan somebody that
- 8 was always in trouble at home?
- 9 A. Yes.
- 10 Q. Why was Ryan always in trouble at home?
- 11 A. He was always accused of doing something
- 12 wrong like stealing or going into the bedroom when he
- 13 shouldn't have or not doing homework.
- Q. Who was the one accusing Ryan of those
- 15 things? Was it Chris, was it Terrie, was it Deborah?
- 16 A. Chris.
- 17 Q. And what was -- was it your belief that
- 18 Ryan was doing those things?
- 19 A. I don't know.
- Q. Did you feel that Ryan was unjustifiably
- 21 blamed a lot around the house?
- 22 A. Sometimes, yes. There was one incident I
- 23 felt was very unjustified.
- Q. Unjustified or justified?
- 25 A. Unjustified.

- 1 Q. And how old was Brandon for that event, the
- 2 one you thought was very unjustified?
- 3 A. No, I'm saying Ryan.
- 4 Q. I'm sorry. My mistake. I switched the
- 5 names around. How old was Ryan when there was that
- 6 unjustified incident?
- 7 A. He was about 16.
- 8 Q. Okay. Do you have any idea what the whole
- 9 story was?
- 10 A. I was in the livingroom. Chris came out.
- 11 He called for Ryan. He came out. Chris asked him if
- 12 he felt loved in the house. He answered truthfully
- 13 saying no. He hit him, knocked him to the floor,
- 14 told him to get up. When he got up, he asked him the
- 15 question again and he hit him again after he said I
- 16 don't feel loved in this house.
- 17 Q. But in that scenario Ryan was being
- 18 unjustifiably blamed for doing something wrong.
- 19 A. He asked him a question and Chris didn't
- 20 like the answer.
- 21 Q. If you know did Ryan spend time with his
- 22 biological dad when he was living with you guys?
- 23 A. There was a few times he would leave the
- 24 house and go to his father's.
- 25 Q. One more question about the master

- 1 bedroom. If you ever saw Brandon leave the master
- 2 bedroom angry or upset, you would have asked him what
- 3 was wrong, correct?
- 4 A. Yes.
- 5 Q. Did you ever see him leave the master
- 6 bedroom upset or angry?
- 7 A. Yes.
- 8 Q. Did you ask him what was wrong?
- 9 A. Yes. He got grounded once for telling
- 10 Chris he didn't like Tinkerbell. He got grounded for
- 11 two weeks.
- 12 Q. How old was Brandon for that?
- 13 A. About 15, 14.
- Q. And how many times did you see, did you ask
- 15 Brandon why he was angry or upset after leaving the
- 16 master bedroom?
- 17 A. I'd normally ask him once what he got upset
- 18 for.
- 19 Q. How many times did you ask him that
- 20 question?
- 21 A. A lot but he never told me what happened
- 22 until that day.
- Q. Okay. So are you assuming now that every
- 24 time Brandon left the master bedroom angry or upset,
- 25 that something had happened in the master bedroom,

- 1 something sexual had happened in the master bedroom?
- 2 A. I had my suspicion. That's why I asked but
- 3 I didn't get any answer to that.
- 4 Q. Okay. At what age did you start having
- 5 suspicions that there was something with Brandon?
- 6 A. About 16 or 17.
- 7 Q. Just to be clear, you were 16 or 17 or
- 8 Brandon?
- 9 A. I was 16 or 17.
- 10 Q. So that would make Brandon eight or nine.
- 11 A. About.
- 12 Q. Okay. So you thought there was something
- 13 already happening to Brandon when he was eight or
- 14 nine years old.
- 15 A. Yes.
- 16 Q. Did you ever talk to Deborah about that?
- 17 A. No.
- 18 Q. You never talked to Terrie about that.
- 19 A. No.
- 20 Q. You actually spoke to Metro in September of
- 21 2014, correct?
- 22 A. Correct.
- Q. Do you recall telling the detectives about
- 24 the fact that this wasn't the first time you had been
- 25 interviewed regarding potential abuse at the house?

- 1 A. Yes.
- 2 Q. There was an incident when you were maybe
- 3 nine or ten years old, correct?
- 4 A. Yes.
- 5 Q. Where you had talked about physical abuse
- 6 at the home, correct?
- 7 A. Yes.
- 8 Q. Fair to say that you did not feel listened
- 9 to by the system?
- 10 A. At that time I was hit by a pipe when we
- 11 were cleaning out the garage
- 12 and a pipe was thrown at me.
- 13 Q. Okay.
- 14 A. I went to the school nurse because my head
- 15 was hurting so much and I was getting headaches and
- 16 they saw the bruising on the back of my head and
- 17 that's when child services was called and stuff like
- 18 that, and they asked me questions.
- 19 Q. Okay. And when you were asked questions
- 20 about it, did you say that it happened on purpose or
- 21 that it happened accidentally?
- 22 A. I didn't know if it happened on purpose or
- 23 not.
- Q. Okay. Did anybody -- were you interviewed
- 25 at school or at home further?

- 1 A. At school.
- 2 Q. Did they ever come to your house and
- 3 interview anybody at your house?
- 4 A. I believe so because when I came home, I
- 5 had a major butt whipping.
- 6 Q. And at that point Deborah and Terrie were
- 7 both living at home with you, correct?
- 8 A. I believe so.
- 9 Q. And Chris obviously.
- 10 A. Yes.
- 11 Q. And there was no follow-up beyond that
- 12 conversation after school, correct?
- 13 A. Correct.
- 14 Q. Police never came by the house or anything
- 15 like that, correct?
- 16 A. After that, yes.
- 17 Q. You told Brandon about that incident,
- 18 correct?
- 19 A. Correct.
- 20 Q. About the fact that you had reported abuse
- 21 when you were younger and nobody cared and nobody did
- 22 anything about it.
- 23 A. Yes.
- Q. Did you tell Ryan that you had told briefly
- 25 and nobody cared and nobody did anything about it?

- 1 A. No.
- 2 Q. You only told Brandon about that.
- 3 A. I told Brandon.
- 4 Q. Okay. At what point did you relay that
- 5 story to Brandon?
- 6 How old was Brandon?
- 7 A. He was in his teens.
- 8 Q. He's 17, 18 now so was it last year.
- 9 A. I think he was like 13.
- 10 Q. Okay. What caused you to relate that
- 11 information to Brandon?
- 12 A. We were talking about the physical abuse at
- 13 the house like him throwing remotes at us, throwing
- 14 objects at us. Sometimes we would get hit or slapped
- 15 for something stupid or the times that I got
- 16 strangled and stuff like that so.
- 17 Q. And so you thought that it was important
- 18 information to the Brandon that if you tell, nobody
- 19 will listen?
- 20 A. I feel like nobody listens.
- Q. Did you feel like maybe it was worth trying
- 22 a second time?
- 23 A. After we got out of the house I was afraid
- 24 that he'd come after us.
- 25 Q. But when you -- but then you eventually did

1 make the decision to go to the police, correct?

- 2 A. Yes.
- 3 Q. And they listened to you, correct?
- 4 A. Correct.
- 5 Q. And Chris was arrested, correct?
- 6 A. Correct.
- 7 Q. Did you -- Chris also had friends in Metro,
- 8 correct?
- 9 A. Correct.
- 10 Q. And you felt that that, you felt those
- 11 friends at Metro would prevent you from making any
- 12 type of a report, correct?
- 13 A. Correct.
- 14 Q. Did the friends at Metro tell you that?
- 15 A. No. I knew and was told that they can't
- 16 really do anything.
- 17 Q. I'm sorry. I can barely hear you. I'm
- 18 sorry.
- 19 A. I was told that they could barely do
- 20 anything for me.
- Q. Who told you that they would barely do
- 22 anything for you?
- 23 A. We were told by Chris. At one point in
- 24 time I recall that being told to me. Also if I did
- 25 call the police and stuff, I do recall that he told

- 1 me go ahead and call the police, I have 15 to 17
- 2 minutes before that he can do whatever he wants to
- 3 me.
- 4 Q. How old were you when that conversation
- 5 happened?
- 6 A. 14.
- 7 Q. So after that conversation occurred, did
- 8 you still see friends of Chris's that were Metro
- 9 officers around the house?
- 10 A. They came over but we were in the main
- 11 house and he took his officer friends to the office.
- 12 We weren't really that much allowed to talk to them.
- 13 Q. Do you remember the names of any of the
- 14 officers that came around the house?
- 15 A. Officer Brinkley and his wife. There was a
- 16 few other officers, but I don't remember their names.
- 17 Q. Okay. And did you participate at all in
- 18 the events that the family business put on for Metro
- 19 last year I think it was?
- 20 A. You mean for the CC shooting.
- 21 O. Yes.
- 22 A. No.
- Q. You didn't attend the event at all?
- 24 A. No.
- Q. Were you working yourself that day?

- 1 A. I was working.
- 2 Q. You also told the detectives I believe that
- 3 you were -- you worked at an Albertsons.
- 4 A. Correct.
- 5 Q. Which Albertsons was that?
- 6 A. Sloan and Charleston.
- 7 Q. Sloan and Charleston?
- 8 A. Sloan and Charleston.
- 9 Q. And how long did you work at that

10 Albertsons?

- 11 A. For almost two years.
- 12 Q. And it was your opinion that Chris had
- 13 people at that store watching you, correct?
- 14 A. Correct.
- 15 Q. And reporting back to him what was going on
- 16 at work.
- 17 A. Yes.
- 18 Q. He had friends that worked with you.
- 19 A. Yes.
- Q. Did you know who those people were?
- 21 A. Ms. Christine.
- Q. Ms. Christine. Do you know her last name?
- 23 A. I don't know her last name.
- Q. In what facility did she work -- sorry.
- What was her job at Albertsons?

- 1 A. Security.
- 2 Q. Do you know if she still works at that
- 3 Albertsons?
- 4 A. No.
- 5 Q. I'm sorry. My fault. Does she still work
- 6 at that Albertsons?
- 7 A. I don't know.
- 8 Q. That's why that question was my fault.
- 9 A. Okay.
- 10 Q. Anybody else at that store that you felt
- 11 was reporting back to Chris?
- 12 A. That was just the security and Shawn.
- 13 Q. And who is Shawn?
- A. Shawn is a friend of Chris's that comes to
- 15 my work once in a while to get some groceries or go
- 16 to the Hawaiian restaurant next door.
- 17 Q. Okay. What was Shawn's last name?
- 18 A. I don't recall.
- 19 Q. Okay. And you felt it was your opinion
- 20 that Shawn was actually checking up on you.
- 21 A. Correct because every time when he came
- 22 over to visit me, he called Chris and saying that he
- 23 had saw your daughter. She's doing this and that.
- 24 She's right in front of me now. Do you want to speak
- 25 to her?

- 1 Q. Okay. Did Tails have a job when he lived
- 2 at the house?
- 3 A. No.
- 4 Q. So he was home most of the time.
- 5 A. At this point of time he was out of the
- 6 house.
- 7 Q. Okay. When you were working at the
- 8 Albertsons.
- 9 A. Yes.
- 10 Q. When did you -- were you still working at
- 11 the Albertsons on June 12, 2014, when you guys left
- 12 the house?
- 13 A. I gave two weeks' notice.
- Q. On what day?
- 15 A. The week before June 12th like Thursday.
- 16 Q. Okay. And that was -- you were done
- 17 working there at that point?
- 18 A. Yeah. I turned in my stuff. I went back
- 19 to get my check, and they told me that Chris was
- 20 bothering them every day with phone calls and coming
- 21 in and asking if they seen me and they even allowed
- 22 him to write a note on my checkstub saying please
- 23 come home.
- Q. Okay. Because at this point when you go to
- 25 get your check, Chris had no idea where you and

- 1 Deborah and Brandon are, correct?
- 2 A. I believe so.
- 3 Q. And at this point when you go get your
- 4 check, it's probably been at least a week or two
- 5 after you guys had left the house, correct?
- 6 A. About three weeks after.
- 7 Q. About three weeks after?
- 8 A. Yeah.
- 9 Q. And he has no idea where two of his
- 10 children are and his current wife, correct?
- 11 A. Correct.
- 12 Q. And the note said please come home.
- 13 A. Yes.
- Q. Okay. When you were working at Albertsons,
- 15 how many hours a week were you working?
- Was it a full-time job or part-time?
- 17 A. It was part-time.
- 18 Q. Did you have another job in addition to
- 19 that?
- 20 A. No.
- Q. Were you going to school or anything like
- 22 that?
- 23 A. No.
- Q. So how many hours a week were you working
- 25 at Albertsons?

- 1 A. About 32 or 30.
- 2 Q. And when you weren't at work, were you
- 3 primarily at home?
- 4 A. Yes.
- 5 Q. Did you have a boyfriend?
- A. No, I didn't keep boyfriends because every
- 7 time I brought a boyfriend over, Chris would have his
- 8 gun on his side to terrorize them or just to show off
- 9 and after they leave and stuff like that, he would
- 10 ask me comparing to their sex life was he best or
- 11 they were better.
- 12 Q. Did you have that conversation with Chris
- 13 or did you walk away?
- What happened with those conversations?
- 15 A. I normally answered to what he wanted to
- 16 hear.
- 17 Q. So you would have that conversation with
- 18 Chris is what you're saying.
- 19 A. Yes.
- 20 Q. You did have a boyfriend at one point in
- 21 time named Kristoff, correct?
- 22 A. Correct.
- Q. What was Kristoff's last name?
- A. It's a long name. It's hard to pronounce.
- Q. How old were you when you were dating

- 1 Kristoff?
- 2 A. I think 22 or 23.
- 3 Q. Okay. How long did you and Kristoff date?
- 4 A. Not very long.
- 5 Q. What's not very long?
- 6 A. About a couple of months.
- 7 Q. I'm sorry. Not very long to somebody who
- 8 is 24 is totally different than not very long to
- 9 somebody who is my age. Fair you told the police you
- 10 came close to confiding in Kristoff?
- 11 A. Kristoff actually figured some of it out.
- 12 He didn't know who but he did believe that I was
- 13 raped.
- Q. Okay. And after Kristoff, did he say that
- 15 to you?
- 16 A. He asked me am I a rape victim.
- 17 Q. And you denied it or you told him yes?
- 18 A. I didn't answer.
- 19 Q. You didn't answer. How long after Kristoff
- 20 asked you that question did you guys break up?
- 21 A. About two weeks.
- Q. Outside of the family, Deborah and Brandon,
- 23 who was the first person that you told about
- 24 (inaudible)?
- 25 A. We didn't tell anybody.

- 1 Q. But you eventually did tell people. Who
- 2 was the first person that you told that was outside
- 3 the family?
- 4 A. I think aunt Barbara was first. Yes, aunt
- 5 Barbara was first.
- 6 Q. I'm sorry. Aunt Barbara. Who exactly is
- 7 aunt Barbara?
- 8 A. Aunt Barbara is the stepsister of Deborah.
- 9 Q. And what is Barbara's last name? You don't
- 10 know. I'm sorry. You're shaking your head no.
- 11 A. No. Sorry.
- 12 Q. Does aunt Barbara live here in Las Vegas?
- 13 A. No.
- Q. Do you know what town or do you know what
- 15 city she lives in?
- 16 A. She moved but she's still in Maryland.
- 17 Q. Somewhere in Maryland.
- 18 A. Somewhere in Maryland. She's still there,
- 19 but I don't know what street or town.
- 20 Q. Okay. How -- did aunt Barbara come to Las
- 21 Vegas for a visit or did this conversation happen on
- 22 the phone?
- 23 A. Over the phone.
- Q. Was it a conversation that you had with
- 25 Barbara or was it a conversation that Deborah had

- 1 with aunt Barbara?
- 2 A. Deborah had with aunt Barbara.
- 3 Q. Who is the first person that you told?
- 4 A. Richard.
- 5 Q. Who is Richard?
- 6 A. Richard is a cousin.
- 7 Q. Was that over the phone?
- 8 A. Over the phone.
- 9 Q. Okay. And do you know Richard's last name?
- 10 A. Tuchman.
- 11 Q. Tuchman. Could you spell it, what you
- 12 think it is.
- 13 A. T-U-C-H-M-A-N.
- 14 Q. Did you know Richard when you were living
- 15 at the Yellowstone address?
- 16 A. No.
- 17 Q. You met him after you and Deborah and
- 18 Brandon moved out.
- 19 A. After Deborah was arrested actually.
- Q. After Deborah was arrested. So the first
- 21 person that you told outside of Deborah and Brandon
- 22 was Richard. And you told him after Deborah was
- 23 arrested.
- 24 A. Yes.
- Q. And Deborah was arrested in December,

- 1 correct?
- 2 A. Correct.
- 3 Q. So what about all the police officers that
- 4 you spoke to in September.
- 5 A. I rarely spoke to them when they called me
- 6 in to ask me more questions or show me pictures and
- 7 videos.
- 8 Q. So let me back up a second. You actually
- 9 talked to the police long before you talked to
- 10 Richard, correct?
- 11 A. Yes.
- 12 Q. And you talked to Detective Samples.
- 13 A. Yes.
- 14 Q. Before Detective Samples did you talk to
- 15 anybody at Metro?
- 16 A. There was another detective and that was in
- 17 September when I was giving my report. I don't
- 18 recall his name though.
- 19 Q. Okay. I'm sorry. When you were giving
- 20 your report or your reward?
- 21 A. No, my report.
- Q. Just making sure I got the word correct.
- 23 And you don't remember his name?
- 24 A. No.
- Q. And what report are you referring to?

- 1 A. My situation of what happened to me.
- 2 Q. Okay. Were you -- Deborah went to the
- 3 police first or you went to the police first?
- 4 A. We all went to the police the exact same
- 5 time, the exact same day.
- 6 Q. And it was that day you got your report.
- 7 A. I told my report.
- 8 Q. Was that person -- were you audiotaped or
- 9 videoed that day?
- 10 A. I was audiotaped and videoed I believe.
- 11 Q. And you were also audiotaped and videoed
- 12 when you talked to Detective Samples, correct?
- 13 A. Yes.
- Q. So it's your memory you've been audiotaped
- 15 and videoed twice by Metro.
- 16 A. Yes.
- 17 Q. Did you -- after Detective Samples did you
- 18 talk to anybody at Metro in detail about what
- 19 allegedly happened?
- 20 A. No.
- Q. Did you ever have any type of medical exam?
- 22 A. No.
- Q. The detectives didn't suggest that you go
- 24 get some type of sexual assault examination?
- 25 A. No.

- 1 MS. RADOSTA: I probably have maybe another
- 2 20 minutes.
- 3 THE COURT: We'll go until 4:00 o'clock
- 4 depending on how long -- we will go if they can start
- 5 their redirect.
- 6 MS. RADOSTA: I'll try to. Thank you, Your
- 7 Honor.
- 8 Q. We talked about -- so it was Detective
- 9 Samples and the other detective, those are the only
- 10 people at Metro that you spoke to about this,
- 11 correct?
- 12 A. Correct.
- 13 Q. Did you ever talk to any therapist, any
- 14 counselors, anything like that about what was
- 15 allegedly happening at home?
- 16 A. Yes.
- 17 Q. Okay. Just one person, more than one
- 18 person?
- 19 A. The day that we left and went to safe
- 20 house, safe house provided therapy.
- Q. Do you remember the name of the therapist?
- 22 A. Felicia.
- Q. Do you know Felicia's last name?
- 24 A. No.
- Q. Was it one-on-one or group therapy?

- 1 A. It was one-on-one therapy.
- 2 Q. How many times did you see Felicia?
- 3 A. Once every week.
- 4 Q. While you were at safe house or after you
- 5 left safe house as well?
- 6 A. Safe house and after leaving safe house.
- 7 Q. Are you still seeing Felicia now?
- 8 A. No. I have another therapist.
- 9 Q. What's that therapist's name?
- 10 A. Lorene.
- 11 Q. Is she also affiliated with safe house?
- 12 A. Yes.
- 13 Q. Do you know Lorene's last name?
- 14 Are you still going once a week?
- 15 A. Yes.
- 16 Q. So you've been going once a week for
- 17 therapy for approximately a year now?
- 18 A. Yes.
- 19 Q. Actually more than a year. About 14,
- 20 15 months.
- 21 A. Yes.
- Q. When you were younger, Terrie was the one
- 23 that stayed home and took care of all the kids,
- 24 correct?
- 25 A. Correct.

- 1 Q. Deborah went out and worked at her place of
- 2 employment, the one that we talked about earlier.
- 3 A. Yes.
- 4 Q. And fair enough to say that Terrie was the
- 5 caretaker to the kids?
- 6 A. Yes.
- 7 Q. If you guys were sick, she was the one that
- 8 would take your temperature, whatever, anything like
- 9 that.
- 10 A. Correct.
- 11 Q. How old were you when Terrie started going
- 12 to work?
- 13 A. She started going back to work when the
- 14 boys were going into first grade.
- 15 Q. Then the boys were born in '99 so maybe
- 16 2003, 2004.
- 17 A. 2004.
- 18 Q. All right. And when you say went back to
- 19 work, that's when she started as a teacher.
- 20 A. As a substitute teacher.
- Q. As a substitute teacher. Okay.
- You are currently living with Brandon,
- 23 correct?
- 24 A. Correct.
- Q. Are you, is it just you and Brandon?

- 1 A. Just me and Brandon.
- Q. And he's still in high school, correct?
- 3 A. Yes.
- 4 Q. Is he just about to start his senior year?
- 5 A. He's in his senior year now.
- 6 Q. Oh, school's already started. Are you
- 7 supporting Brandon?
- 8 A. Yes, and the state.
- 9 Q. Okay. So he's also getting financial
- 10 assistance from the state.
- 11 A. Yes.
- 12 Q. Are you getting financial assistance from
- 13 the state as well?
- 14 A. Yes.
- 15 Q. As a result of these allegations?
- 16 A. I don't make enough.
- 17 Q. Okay. So it's just about your income that
- 18 you're getting financial assistance.
- 19 A. Yes.
- Q. And are you Brandon's only family member
- 21 that is emotionally supporting him now or does he
- 22 have other emotional support besides you?
- 23 A. So far it's me, aunt Barbara, and Richard,
- 24 and my grandparents.
- Q. And your grandparents are Terrie's

- 1 parents.
- 2 A. Yes.
- 3 Q. And they live here locally, correct?
- 4 A. Yes.
- 5 Q. And they've lived here the entire time this
- 6 alleged abuse was occurring, correct?
- 7 A. Yes.
- 8 Q. And you never confided in your grandmother
- 9 about what was allegedly happening, correct?
- 10 A. Correct.
- 11 Q. You never told your grandfather, correct?
- 12 A. Yes.
- 13 Q. And Terrie has three or four sisters that
- 14 live here as well, Melissa and Kim and there's
- 15 another one I believe as well.
- 16 A. Melissa, Kim, and then my other aunts. I
- 17 don't see them as much.
- 18 Q. But you never told them anything that was
- 19 going on at the home either, correct?
- 20 A. Correct.
- Q. You actually are quite upset that Deborah's
- 22 being prosecuted by the State, correct?
- A. Correct.
- Q. And you actually wrote a letter to the
- 25 press about it, correct?

- 1 A. Yes.
- Q. And said that it's not fair that Deborah's
- 3 being prosecuted for these alleged crimes.
- 4 A. Not only Deborah but Terrie as well.
- 5 Q. But you didn't have anything to say about
- 6 Christopher of course, correct?
- 7 A. Correct.
- 8 Q. And you said -- you actually mentioned
- 9 earlier that in talking to Metro that you watched
- 10 videos, correct?
- 11 A. Correct.
- 12 Q. So you gave your statement -- -- when you
- 13 talked to the detective, you talked to one then you
- 14 talked to the other. How many days --
- 15 A. I'm sorry. Please repeat the question.
- 16 Q. You said you talked to two different
- 17 detectives and you were audiotaped and videoed for
- 18 both of those conversations, correct?
- 19 A. Correct.
- 20 Q. Do you remember how far apart those two
- 21 conversations were?
- 22 A. It took about two weeks in between.
- Q. And Detective Samples was the second one.
- 24 A. Detective Samples was there on both of the
- 25 times except for that one detective.

- 1 Q. So now there's three times that you spoke.
- 2 A. Samples was there when I gave my statement
- 3 and once there was another person and then
- 4 Mr. Samples called me back again to see pictures and
- 5 videos.
- 6 Q. Okay. And then did you -- how many
- 7 different videos did you watch with Detective
- 8 Samples?
- 9 A. I saw quite a few of them.
- 10 Q. Okay. And was it just you in the room with
- 11 Detective Samples when that was happening?
- 12 A. There was a guy that was playing the
- 13 videos.
- Q. Okay. But and this was before Deborah was
- 15 arrested, correct?
- 16 A. Correct.
- 17 Q. Okay. So Deborah wasn't in the room with
- 18 you.
- 19 A. No.
- Q. And Brandon wasn't in the room with you.
- 21 A. Correct.
- 22 Q. And Ryan wasn't in the room.
- 23 A. Yes.
- Q. And Terrie wasn't in the room.
- 25 A. Correct.

- 1 Q. And Tails --
- 2 A. He was not there either.
- 3 Q. So is that the only time that you reviewed
- 4 videos in this particular case?
- 5 A. No.
- 6 Q. Okay. How many other times have you
- 7 reviewed videos in this case?
- 8 A. Before the hearing with Deborah.
- 9 Q. Okay. Who had you reviewed videos in the
- 10 case before Deborah's hearing?
- 11 A. The D.A. in front of me.
- 12 Q. The male or female?
- 13 A. Both of them.
- 14 Q. All right. And that was as part of your
- 15 prep for your testimony.
- 16 A. Yes.
- 17 Q. Did you have to review them again before
- 18 Christopher's hearing today?
- 19 A. No.
- 20 Q. You never reviewed the videos with any
- 21 other attorneys other than the D.A.s.
- 22 A. Other than the D.A. and Detective Samples,
- 23 that was it.
- Q. Okay. Did you ever have a conversation
- 25 with Ryan about reviewing the videotape?

- 1 A. No.
- 2 Q. You never had a conversation with him. You
- 3 never told him that you saw videos of him and Chris.
- 4 A. No.
- 5 Q. Prior to seeing the videos, were you aware
- 6 that there were videos?
- 7 A. I had no idea there was videos.
- 8 Q. Okay. You didn't see any videos of
- 9 yourself, correct?
- 10 A. Correct.
- 11 Q. Did you have an opinion as to whether Chris
- 12 preferred Deborah or Terrie in the house?
- 13 A. No.
- 14 Q. It was equal?
- 15 A. It was equal.
- 16 Q. He treated them the same way?
- 17 A. He would pretty much it was the same. It
- 18 was pretty much the same.
- 19 Q. You didn't feel that he wanted Deborah in
- 20 the house more than he wanted Terrie in the house or
- 21 vice versa?
- 22 A. He wanted Deborah more in the house than
- 23 Terrie but in other cases it was equal.
- Q. And Terrie did move out of the house on
- 25 several occasions, correct?

- 1 A. Correct.
- Q. And Chris never said "don't go" or "come
- 3 right back" or anything like that, correct?
- 4 A. He wanted us to give a full report of what
- 5 Terrie was doing and stuff like that and he was
- 6 telling me that he still loved Terrie and stuff like
- 7 that.
- 8 Q. Okay. But he knew they were leaving and he
- 9 let them move out of the house, correct?
- 10 A. She just left. She just -- she just walked
- 11 out of the office, gave him the key and go.
- 12 Q. And she got in the car with Ryan and drove
- 13 away.
- 14 A. Yes.
- 15 Q. And many times were you aware that she
- 16 stayed in her mother's house?
- 17 A. A few occasions yes.
- 18 Q. And that's here in Las Vegas, correct?
- 19 A. Correct.
- 20 Q. And Chris didn't go over to your
- 21 grandmother's house and bring Terrie back home,
- 22 correct?
- 23 A. Not that I recall.
- Q. You never saw that happening, correct?
- 25 A. No.

1 Q. And actually Tails also moved out of the

- 2 house when he turned 18, correct?
- 3 A. Correct.
- 4 Q. And he was allowed to move out of the house
- 5 and pack his belongings, correct?
- 6 A. He just left.
- 7 Q. He just left?
- 8 A. He just left.
- 9 Q. But Chris didn't track him down and drag
- 10 him back to the house, correct?
- 11 A. I don't know because I wasn't home at the
- 12 time when this happened.
- 13 Q. Okay.
- 14 A. I was at work.
- 15 Q. Okay. You were at work. But Tails was
- 16 gone for more than a day, correct?
- 17 A. Yeah, he was gone for quite some time.
- 18 Q. So at any point during the time Tails was
- 19 gone you never saw Chris physically pull, drag him
- 20 back into the house, correct?
- 21 A. No, but he was asking his friends and stuff
- 22 what he was doing and stuff.
- Q. But Chris is Tails' father, correct?
- 24 A. Correct.
- Q. And might be concerned where his son was,

- 1 correct?
- 2 A. Correct.
- 3 Q. What was the relationship between Terrie
- 4 and Deborah like in the house?
- 5 A. They tended to argue with each other but
- 6 sometimes it was drawn to be pit against each other
- 7 like Chris would tell Terrie not to punish Brandon or
- 8 Deborah not punish Ryan so there was kind of conflict
- 9 between the two when the boys got in trouble or
- 10 something happened.
- 11 Q. Did you feel that Terrie liked Deborah?
- 12 A. She was okay with Deborah.
- 13 Q. You didn't ever see her roll her eyes or
- 14 make funny faces behind Deborah's back or anything
- 15 like that?
- 16 A. She did that a few times.
- 17 Q. Did you ever see Deborah do those type of
- 18 things to Terrie?
- 19 A. No.
- 20 Q. Do you recall -- I talked about this a
- 21 couple times already -- your statement to Detective
- 22 Samples on September 17, 2014? Do you recall that
- 23 statement?
- A. I guess.
- 25 Q. I mean you recall going and talking to

- 1 Detective Samples.
- 2 A. Yeah.
- 3 Q. Do you recall telling him -- I'm looking at
- 4 page 28 -- that your grandmother knew about the
- 5 incident. She knows about dad fucking me because she
- 6 was there.
- 7 A. Wait, what?
- 8 Q. Do you recall telling the detectives that
- 9 your grandmother knew about the incident? She knows
- 10 about dad fucking me because she was there.
- 11 A. No.
- 12 Q. If I were to show you your statement to
- 13 Detective Samples, would that refresh your
- 14 recollection?
- 15 A. On some of the statements that was on there
