42, 435 P.3d 1217 (2019) ("*Jessup 1*"). Plaintiff, Las Vegas Development Group, LLC, appealed the Order granting Summary Judgment on June 18, 2019. Defendants, James R. Blaha and Noble Home Loans, Inc. f/k/a FCH Funding, Inc., filed a Notice of Cross Appeal on July 2, 2019.

On May 7, 2020, the Nevada Supreme Court issued an Order vacating its prior Order in *Jessup 1* and replacing it with an Order Affirming in Part, Reversing in Part and Remanding to the district court. *Bank of Am. v. Jessup*, No. 73785, 2020 Nev. Unpub. LEXIS 471 (May 7, 2020) ("*Jessup 2*"). Pursuant to *Jessup 2*, the *en banc* Supreme Court wholly reversed the Panel's decision in *Jessup 1*. The parties hereto thereafter jointly requested that this Court certify its intent vacate the Order granting Summary Judgment.

On September 3, 2020, the Nevada Supreme Court issued an Order Granting Motion for Limited Remand, remanding the case to this Court for the limited purpose of allowing this Court to enter an Order vacating the Order Granting Summary Judgment entered on or about May 24, 2019. GOOD CAUSE APPEARING THEREFOR,

IT IS HEREBY ORDERED the primary basis for the entry of this Court's Order Granting Summary Judgment entered herein on May 24, 2019, was invalidated or substantially changed by the Nevada Supreme Court's decision in the matter of *Jessup 2*.
