1 H. Date proceedings were commenced in district court: Complaint was filed on
2 December 31, 2018.

3 I. Brief description of nature of the action and result in district court, including
4 type of judgment or order being appealed and relief granted by district court:

5 On December 31, 2018, TitleMax, a lender licensed under Chapter 604A, filed
6 a Complaint for Declaratory Judgment naming the Department of Business and Industry,
7 Financial Institutions Division as Defendant ("FID"). TitleMax pled for the Court to
8 declare that refinancing a title loan does not violate NRS 604A.5074(3) or NRS 604A.065
9 and for the Court to declare that interest and fees should not be considered as part of the
10 fair market value of the vehicle when determining loan amount for a title loan and the
11 customers' ability to repay the loan.

12 The FID filed a motion for summary judgment. TitleMax responded with a counter-
13 motion for summary judgment. The matter was fully briefed and oral argument was heard
14 on May 1, 2019. On June 20, 2019 the Court issued an Order denying the FID's motion for
15 summary judgment and granting TitleMax's counter motion. The FID is appealing the
16 District Court's Order on both issues.
