**THIRD MOTION FOR EXTENSION  
TO FILE ANSWERING BRIEF**

Respondent TitleMax of Nevada, Inc. requests a 30-day extension through May 20, 2020, to file the answering brief. NRAP 31(b)(3). This is the third motion for extension. (The parties previously stipulated to extend the deadline pursuant to NRAP 31(b)(2), and respondent's previous two motions for extension were granted.) The brief was originally due January 17, 2020 and, without an extension, would be due April 20, 2020.

While a draft of the brief is complete, additional time is needed to make the brief more succinct and allow for client review. Completion of the brief has been delayed over the last 30 days for multiple reasons, including the outbreak of COVID-19 and the unusual work schedules

and practices caused by the outbreak. Collaboration on the brief has been delayed with everyone working remotely and on different schedules. The primary drafting attorney and lead paralegal have been impacted by school closures and the need to care for their young children while trying to work. In addition, the primary drafting attorney's 2-year-old son recently broke his arm and needs additional care.

The additional time will enable respondent's counsel to receive client input and ensure that all relevant considerations in this important appeal are presented succinctly.
