MOTION TO WITHDRAW AS COUNSEL OF RECORD

Here, Appellants have elected to be represented by Micah Echols, Esq., who no longer works at the law firm of Marquis Aurbach Coffing and has appeared as counsel of record in this matter at his new law firm. *See Superpumper, Inc., et al. vs. Leonard*, Docket No. 79355 (Motion to Stay Briefing, or, Alternatively, Motion for Extension of Time to File Opening Brief and Appendix, Jan. 29, 2020). Further, Kathleen A. Wilde, Esq., and Tom W. Stewart, Esq., of Marquis Aurbach Coffing, have consented to withdrawal as counsel in this matter. SCR 46(1). This withdrawal can be accomplished without material adverse effect on Appellants' interest. NRPC 1.16(b)(1). As a result, good cause exists for the withdrawal of the law firm of Marquis Aurbach Coffing. NRPC 1.16(b)(7).

Appellants Superpumper, Inc.; Salvatore Morabito; and Snowshoe Petroleum, Inc. will continue to be represented by Micah S. Echols, Esq., now at the law firm of Claggett & Sykes, along with Frank Gilmore, Esq., at the law firm of Robison, Sharp, Sullivan & Brust. Appellant Edward Bayuk, individually and as Trustee of the Edward Bayuk Living Trust, will continue to be represented by Micah S. Echols, Esq., now at the law firm of Claggett & Sykes, along with Jeffrey Hartman, Esq., at the law firm of Hartman & Hartman.
