



ORDER GRANTING MOTION

Extraordinary circumstances and extreme need having been shown, and notwithstanding respondent's opposition, appellants' motion requesting a third extension of time to file the opening brief is granted. NRAP 31(b)(3)(B). Appellants shall have until July 6, 2020, to file and serve the opening brief. Any additional extensions will be granted only on showing of extraordinary circumstances and extreme need. *Id.* Counsel's caseload normally will not be deemed such a circumstance. *Cf. Varnum v. Grady*, 90 Nev. 374, 528 P.2d 1027 (1974). Failure to timely file the opening brief may result in the imposition of sanctions, including the dismissal of this appeal. NRAP 31(d).
