My name is Matthew Houston, and I am
being illegally incarcerated at Three Lakes Valley
Conservation Camp, between Southern Desert
Correctional Center and High Desert State
Prison down here in Indian Springs, NV. I
am visually impaired and neurologically disabled
from traumatic brain injury. Having acquired
knowledge of the law and claiming my right
to ~~sovereignty~~ sovereignty, I am having
extreme difficulty in properly filing my legal
work, complaints and petitions in my advocacy
for other disabled veterans, prisoners of war, etc.

I request contact information ~~and~~ for
whatever group is responsible for investigating
wrongful convictions and malicious prosecutions,
which would be the equivalent of a Board
Of Judicial Review. My being refused medical
treatment by Justice of the Peace De la Garza
down here has caused too much emotional
distress and other damages. With the court
ignoring my educational merits and service to
this State and this Nation, and other ^{states} wrongs,
my illegal incarceration has been further continued

to 5 months of inmate overstay, past my granted
release date of March 31st, 2019. My levels of
pain and suffering as result of this is unbearable,
and who is to say the prison will even release
me before expiration of sentence April 27th, 2020.

Division of Probation and Parole was ordered by the
Par Board of Parole to have me released 3/31/2019,
since I not only meet, but exceed their standards
as set forth in NRS 208. I really do not know
how this corruption exists in 'justice' these days.
Also included in this letter is my "Appeal of
Conviction, Case No. C-17-323614-1". Please
have this filed, and if there's anything
that needs corrected please inform me of
