**APPELLANTS DESIRE EVANS-WAIAU AND GUADALUPE
PARRA-MENDEZ'S MOTION FOR EXTENSION OF TIME TO FILE
OPENING BRIEF AND APPENDIX**

Appellants DESIRE EVANS-WAIAU and GUADALUPE PARRA-MENDEZ, by and through their counsel of record, Dennis M. Prince and Kevin T. Strong of PRINCE LAW GROUP, hereby move to extend the time to file their Opening Brief and Appendix by twenty-one (21) days up to and including Friday, April 17, 2020 pursuant to NRAP 31(b)(3). The parties previously stipulated to a thirty (30) day extension on January 27, 2020, which was approved by this Court. On March 5, 2020, this Court granted Appellants' Motion requesting a thirty (30) day extension of time to file their Opening Brief and Appendix. This Court has not previously denied any

requests for extensions of time to file briefing in this matter. Appellants' Opening Brief and Appendix are currently due on March 27, 2020.

Appellants respectfully request an additional brief extension of time to complete their Opening Brief. As this Court is certainly aware, the ongoing concerns related to the COVID-19 pandemic have caused interruptions and delays in business operations across the State of Nevada. The operations of Appellants' counsel's office have similarly been impacted. Many of the undersigned counsel's staff members have worked from home for the better part of two (2) weeks. However, there were some delays that resulted while securing remote access for staff members to simultaneously work from home. Several staff members also continue to address personal issues with various family members that have arisen as a result of the closures that were imposed. This has also caused some delay in the operations of the firm. Appellants' counsel did not foresee the acceleration of the spread of this virus and the impact it would have on his practice and businesses in Nevada and around the country for that matter.

Based on the underlying circumstances, Appellants contend that good cause supports their requested extension. Accordingly, Appellants respectfully request a twenty-one (21) day extension up to and including Friday, April 17, 2020 to file their Opening Brief and Appendix.
