MOTION FOR EXTENSION TO FILE ANSWERING BRIEF

Respondent Babylyn Tate requests an extension of four days, through September 4, 2020, to file her answering brief. NRAP 31(b)(3). This is the fourth such motion. (The parties previously stipulated to extend the deadline pursuant to NRAP 31(b)(2).) The brief was originally due May 18, 2020, and without an extension, would be due August 31, 2020. No requests for extension have been denied or denied in part.

Undersigned counsel has never before asked for this many extensions and certainly appreciates the extraordinary nature of it. Briefing is complete—several times over, in fact. Unfortunately, it was discovered today that attorneys have been editing competing versions of the brief over the last few days, unbeknownst to each other. The logistical fog has been exacerbated by an attempt to trim a few thousand words from the last draft(s) in order to meet the word limit, as well as operational complications arising from all team members working remotely. On top of that, the coordinating author was in a significant car accident last week. (Thankfully, she was not injured terribly.)

As a result, respondent has serious concerns about whether important edits made to previous drafts of the brief are included in the current version, whether citations to the record are accurate and complete, and whether essential legal authorities remain. This short, additional extension will enable counsel to ensure quality and prevent the need for filing an amended brief.
