STIPULATION TO EXTEND BRIEFING SCHEDULE

Appellant, ATHANASIOS SKARPELOS (“Appellant”), and Respondents, WEISER ASSET MANAGEMENT, LTD., A BAHAMAS COMPANY; AND WEISER (BAHAMAS) LTD., A BAHAMAS COMPANY (collectively “Respondents”), by and through their respective counsel of record, hereby stipulate and agree as follows:

1. Appellant's Combined Reply Brief and Response Brief on cross-appeal is currently due on September 21, 2020.

2. The parties agree to extend the due date to file and serve Appellant's Combined Reply Brief and Brief on cross-appeal to and including October 21, 2020.

3. Respondents' Reply Brief on cross-appeal shall be extended from October 19, 2020 to and including December 21, 2020.¹ This is a total of sixty days (60) instead of the standard thirty days (30) because Respondent's counsel has a brief due mid-to-late November in another case.

4. The parties enter into this stipulation in good faith for the following reasons: (1) Appellant's counsel is currently working on a brief that is due the first week in October in another case and requires the additional time to adequately prepare the brief in this case and (2) as mentioned above, Respondents' counsel has a brief due in mid-to-late November in another case and requires the additional time.
