**SECOND MOTION FOR EXTENSION
TO FILE OPENING BRIEF AND APPENDIX**

Appellant requests a 31-day extension through, December 16, 2019, to file the opening brief. NRAP 31(b)(3). This is the second motion for extension. (The parties previously stipulated to extend the deadline pursuant to NRAP 31(b)(2), and Appellant previously filed one unopposed motion for extension, which was granted.) The brief was originally due September 16, 2019 and, without an extension, would be due November 15, 2019. No request for additional time has been denied or denied in part.

Completion of the brief has been delayed due to a variety of extraordinary and unforeseeable circumstances over the last 30 days,

including the hospitalization of the lead attorney's father who suffers from Parkinson's and has needed additional care. Lead counsel, Mr. Polsenberg, and another attorney who would ordinarily have helped take over the drafting of the brief, Mr. Smith, fell suddenly and severely ill for multiple weeks. Mr. Smith had to miss work, and Mr. Polsenberg was also traveling during this time.

Additionally, the trial transcripts were lengthy and had to be thoroughly reviewed and incorporated into the brief. The additional time will enable appellant's counsel to hone the argument section and ensure that all relevant authorities and considerations in this important appeal are presented as thoroughly and succinctly as possible.
