**THIRD MOTION FOR EXTENSION
TO FILE OPENING BRIEF AND APPENDIX**

Appellant requests a 14-day extension through, December 30, 2019, to file the opening brief. NRAP 31(b)(3). This is the third motion for extension. (The parties previously stipulated to extend the deadline pursuant to NRAP 31(b)(2), and Appellant previously filed two unopposed motions for extension, which were granted.) The brief was originally due September 16, 2019 and, without an extension, would be due December 16, 2019. No request for additional time has been denied or denied in part.

Appellant's draft of the opening brief is substantially complete. However, completion and refinement of the brief, including the

insertion of appendix citations, has been delayed due to a variety of extraordinary circumstances. Following the lead attorney's father's hospitalization after complications from a fall related to Parkinson's, he needed additional care at home (in addition to caring for the lead attorney's two young children). The paralegal who normally compiles and inserts appendix citations was on leave for the past week through today. In addition, one missing transcript was not received until after Thanksgiving. Pre-arranged travel schedules and familial obligations have contributed to the delay.

While the brief is substantially complete, an extension of two weeks is requested to allow time for revision, the insertion of citations, and review by the client. The additional time will enable appellant's counsel to ensure that all relevant authorities and considerations in this important appeal are presented as thoroughly and succinctly as possible.
