**THIRD MOTION FOR EXTENSION TO FILE COMBINED BRIEF**

Respondent/Cross-Appellant the Dr. Miriam and Sheldon G.

Adelson Educational Institute respectfully requests a 30-day extension

to file its Combined Responding Brief and Opening Brief on Cross-Appeal (Docket No. 78341), and Opening Brief in consolidated Docket No. 79464 (“Combined Brief”). Pursuant to the Court’s June 4, 2020 Order, the Combined Brief is due on June 26, 2020.

This is Respondent/Cross-Appellant’s third motion for an extension. No request for additional time has been denied or denied in part. Completion of the Combined Brief has been delayed due to a multitude of circumstances, including the recent, unprecedented consequences of the COVID-19 pandemic. Counsel for Respondent/Cross-Appellant are still working on navigating through the COVID-19 pandemic and its far-reaching consequences, which has and continues to cause major disruptions to counsel’s ability to apply the requisite time and other resources to the brief.

In addition, the closure of all schools as directed by Governor Sisolak presents delays and challenges in the requisite communication with our client.

If the Court grants this request, then the Combined Brief would be due on July 26, 2020.
