**STIPULATION TO EXTEND BRIEFING SCHEDULE**

Appellant, ATHANASIOS SKARPELOS (“Appellant”), and Respondents, WEISER ASSET MANAGEMENT, LTD., A BAHAMAS COMPANY; AND WEISER (BAHAMAS) LTD., A BAHAMAS COMPANY (collectively “Respondents”), by and through counsel hereby stipulate and agree and request the Court enter an order modifying the briefing schedule as follows:
