**MOTION TO EXTEND TIME TO FILE APPELLANT'S COMBINED
REPLY BRIEF AND ANSWERING BRIEF ON CROSS-APPEAL**

Appellant ATHANASIOS SKARPELOS ("Appellant"), by and through his counsel of record, Woodburn and Wedge, hereby moves this Court pursuant to NRAP 26(b) and NRAP 31(b)(3) for an order to extend the time within which to file

and serve his Combined Reply Brief and Answering Brief on Cross-Appeal (“Reply/Answer”) based on the following:

1. Appellants Reply/Answer is currently due October 21, 2020.
2. This Court has previously granted Appellant one extension of time to file his Reply/Answer, which originally was due on September 21, 2020.
3. No previous requests for an extension of time to file the Reply/Answer have been denied.
4. I request this extension because I was primarily responsible for preparing and filing a recent Answering Brief in another case before this Court, *Bella Vista Ranch Company, LLC, et al. vs. The Regional Transportation Commission of Washoe County*, Docket No. 80855. That brief was filed on October 12, 2020. Its preparation was much more time-consuming than I had anticipated and has left me with less than adequate time to prepare the Reply/Answer in this case. Although I have been diligently working on the brief, I need a few extra days to prepare a thorough response.
5. Appellant is requesting an extension of three business days, up to and including Monday, **October 26, 2020**, to file his Reply/Answer.

6. I have notified Respondents' counsel of my request and they have indicated they do not object. *See Exhibit 1*, attached. Respondents' Reply Brief on Cross-Appeal is currently due on December 21, 2020.
7. This request is made in good faith and not for purposes of delay. No further extensions to file the Reply/Answer will be requested.

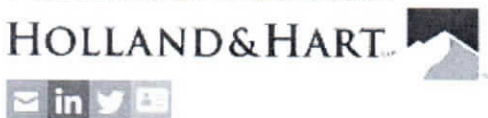
