**UNOPPOSED MOTION TO RESCHEDULE
ORAL ARGUMENT DATE**

The undersigned counsel for Respondents, WEISER ASSET MANAGEMENT, LTD., A BAHAMAS COMPANY; AND WEISER (BAHAMAS) LTD., A BAHAMAS COMPANY (collectively “Respondents”), pursuant to NRAP 34(a) respectfully moves the Court to vacate and reschedule the oral argument currently set for October 13, 2021, at 10:00 a.m. to October 27, 2021 or to the next available oral argument date or session, on the grounds that counsel will not be available on the date currently scheduled for oral argument, as explained more fully below.

1. On August 18, 2021, counsel received notice that oral argument has been scheduled for October 13, 2021.

2. Counsel will be in southern Utah on a long-planned family vacation from October 5 to October 12, 2021, the day before oral argument. Consequently, counsel will not have adequate time to prepare for oral argument.
