assessment of what I was presenting. He's had the discovery for almost
four years now, and the exhibits and the testimony that I elicited, the jury
can evaluate for themselves, the credibility of each and every witness.
MR. MILES: And I do have follow-up, it's very brief. He's

1	right, but as a Prosecutor, it is not okay for a Prosecutor to present
2	testimony that knows is false. That's not

17	the record during those motions, he said he didn't benefit from the
18	absence of evidence. It seems like he's really benefiting right now, by
19	the absence of that evidence.
20	So I just want the record to reflect that, and I feel like my trial
21	is totally unfair, a violation of the 14th Amendment to United States
22	Constitution. And I don't really believe this is right, I really don't. So I
23	just I'm glad Your Honor heard me out, that's what I wanted to make a
24	record of.

13	him. He's supposed to be on your witness list.

15	Your Honor. I know Your Honor knows the law. I mean I don't think the
16	evidence should be excluded, because it wasn't a bad faith attempt. I
17	was just you know, I thought he was going to call the witnesses. We'd
