First of all, if an employer ever told you that they were going to fire you because you were serving on a jury, let me know. I've got a place for that individual. It's across the street. It's called jail. Okay?

It is illegal for an employer to tell you they were going to terminate you or somehow adversely affect your employment for serving on a jury. Okay? Once in a while I get an employer who decides they're going to tell some employee that. It usually takes about one phone call and that employer's either no longer employed or that employer gets the drift of my decision and my statement to him very quickly. Okay?

We all have those things that are going to come up. The thing that the computer didn't know, and this happens, believe it or not, is if you had an open-heart surgery scheduled for tomorrow, there's no way the computer would know that; okay?

We actually had a gentleman in here a couple months ago who showed up with his air tank and everything. And was, "Your Honor, I'm proud to serve. But I have open-heart surgery tomorrow. Can we postpone it a couple days." I really thanked him for his gusto and his desire. I let him go because he had open-heart surgery planned for the very next day. Okay? There are circumstances that prevent us from being able to serve.

If I release you here, what I do is I send you back down

to floor three, where the jury pool is and, yes, you could get assigned to that six-month construction defect case. So think about what you ask or what you talk about or request because you never know how bad the answer's gonna be.

So what I'm gonna do right now is I'm gonna have all you rise and raise your right hand. My clerk is going to swear you in.

[THE PROSPECTIVE JURY WAS DULY SWORN.]

THE COURT: Thank you. Now, what I'm going to do is there's basically kind of a division in here in regards to what's going on. As you'll notice, we have certain individuals who are sitting at a table called the Plaintiff and we have certain individuals sitting at a table called the Defendant. Okay?

Now, the case at that time was ultimately closed, as the investigation could not identify the Defendant. There was a sexual assault kit taken -- this is just a little preview of the case. So you'll hear more about it. But there's a sexual assault kit taken, where they took samples from the victim. And they store that kit.

At the time, Metro did not have the funds to test all these kits. About 18 years later, 2015, they received lots of funding. These kits were tested from years ago and the Defendant's DNA was found from the vaginal swab on the victim.

23	walking out in the hallway or one of the attorneys sees you
24	walking out in the hallway, or happen to be in the elevator or

going to Capriotti's or wherever you choose to lunch at, please understand this: We're gonna ignore ya. Okay?

And the reason we have to do that is all of us, as officers of the court, took an oath that basically says we will have no contact with the jury. That includes the judge. The only person that's going to have contact with you during this process will be one of my Marshals; okay? No one else is allowed to speak to you.

So basically, if you walk past one of the attorneys or you walk past one of my staff members, outside of my Marshal, and you give them a "hello," they're gonna put their head down and walk right past you. Please understand, they're not trying to be rude or discourteous. It is a requirement.

All the attorneys know that if they as so much as simply look at you or waived at you or even smiled back at you, it would be a violation of the oath they took. And it could become very troublesome for them in front of this judge. But it also becomes troublesome in the case.

So understand, they're not trying to be rude. They're not trying to be what you may think, antisocial. They're just not allowed to acknowledge you; okay? And you'll see that a lot. You have a little white badge on. Most of the attorneys know that makes you a very special person. So other attorneys that will walk down the hallway will basically see your white

badge, put their head down, and walk right past you, even though they're not in their courtroom. It's just by habit they automatically do that.

For some reason, some juror always wants to ask some attorney, "What do you think about this?" "What do think about that?" The attorney's gonna walk right past ya; okay? They know that if they were to speak to you and it came to one of the judges that they spoke to a potential juror, it's ugly. Okay? So understand that.

The other thing that's gonna happen, it's most importantly, I'm gonna read for you -- I actually read this. No matter how many times I say this and no matter how many times I've actually got it memorized, I read it. And it's very important that you understand it.

Back in the good old days, we never worried about social media posting. Someone's gonna ask me, "Judge, can I call my employer or my spouse or someone else, "and say, 'Hey, I'm in Department 29 in front of Judge Jones and we're talking about this case.'"
