order, judgment or written disposition of the last-remaining timely motion.

A notice of appeal was timely filed on September 13, 2019. This appeal should not be dismissed for lack of jurisdiction because an order was submitted and filed with the district court on October 23, 2019. At the time the docketing statement was filed, the order had yet to be signed by the district court judge. However, Counsel for Appellant did not want to be time barred and filed the docketing statement without the filed order.

Now that Order has been filed, Appellant respectfully requests that this Court allow the appeal to proceed.

CONCLUSION

It is respectfully requested that this Court find jurisdiction to hear Appellant's matter and that the order suspending briefing be lifted.
