- I, Alina M. Shell, declare, pursuant to Nev. Rev. Stat. § 53.330, as follows:
- 1. I am counsel for Appellant GreenMart of Nevada NLV LLC ("GreenMart") in this matter. I have personal knowledge of all matters contained herein and am competent to testify thereto.
- 2. GreenMart is appealing from the order of a district court for the Eighth Judicial District Court granting Respondents' motion for a preliminary injunction.
- 3. Pursuant to NRAP 27(d)(2), a motion may not exceed 10 pages absent leave from the Court.
- 4. In preparing GreenMart's proposed Motion to Suspend Preliminary Injunction Pending Appeal ("Motion"), which I have been working on diligently, I have endeavored to present the arguments as succinctly as possible.
