*ORDER DISMISSING CROSS-APPEAL IN PART*

This appeal and cross-appeal challenge a district court order granting a preliminary injunction in part. Eighth Judicial District Court, Clark County; Elizabeth Goff Gonzalez, Judge.

On April 23, 2020, this court entered an order granting the motion of counsel for NEVCANN LLC, Green Leaf Farms Holdings LLC, and Red Earth LLC to withdraw. On May 20, 2020, this court entered an order granting the motion of counsel for Green Therapeutics LLC, to withdraw. Because corporations may not proceed on appeal in pro se, see NRAP 46A(b)(2), this court ordered NEVCANN LLC, Green Leaf Farms

Holdings LLC, and Red Earth LLC to retain new counsel and cause new counsel to file a notice of appearance in this court by May 26, 2020, and ordered Green Therapeutics LLC to retain new counsel and cause new counsel to file a notice of appearance in this court by June 19, 2020. This court cautioned that failure to comply could result in the dismissal of these parties' cross-appeals.

To date, no counsel has filed a notice of appearance on behalf of NEVCANN LLC, Green Leaf Farms Holdings LLC, Red Earth LLC, or Green Therapeutics LLC, and these parties have not otherwise communicated with this court. Accordingly, the cross-appeals of NEVCANN LLC, Green Leaf Farms Holdings LLC, Red Earth LLC, and Green Therapeutics LLC are dismissed. The clerk shall amend the caption of this matter consistent with the caption on this order. NEVCANN LLC, Green Leaf Farms Holdings LLC, Red Earth LLC, and Green Therapeutics LLC shall not be permitted to file documents in this matter.
