MOTION FOR EXTENSION OF REPLY BRIEF AND ANSWERING BRIEF ON CROSS-APPEAL

Appellant/cross-respondent Nevada Organic Remedies, (NOR) requests 30 days, until September 18, 2020, to file its combined reply brief and answering brief on cross-appeal. NOR on July 6 moved for an

extension on the reply to the state respondent's answering brief (filed June 4), and on July 20 moved for an extension on the reply and answering brief to the remaining respondents'/cross-appellants' brief (filed June 19). Without an extension, NOR's brief would be due August 19, 2020.

The requested extension is necessary in light of the differing positions of the parties and ongoing settlement discussions. Although some of the issues have been streamlined with the state respondent's agreement with NOR's position in the opening brief, NOR still has to address the positions of the remaining respondents/cross-appellants, who are adverse to the state's (and NOR's) position. These issues are complex and are in the process of being addressed in the parties' settlement negotiations. The requested extension would enable the parties to focus on these discussions and perhaps avoid the necessity for further briefing.

In addition, lead appellate counsel has had to take time from the preparation of the combined brief for his work in the ABA House of Delegates. Beyond counsel's regular caseload, counsel have been drawn into emergency preparations for two evidentiary hearings, both of which

are scheduled in the next few weeks, and in responding to a subpoena for the firm's documents in an unrelated matter.

In light of these circumstances, NOR respectfully asks this Court to grant the requested extension.
