**STIPULATION AND REQUEST TO EXTEND TIME TO FILE  
REPLY BRIEF AND ANSWERING BRIEF TO  
RESPONDENTS/CROSS-APPELLANTS' OPENING BRIEF ON  
CROSS-APPEAL**

IT IS HEREBY STIPULATED AND AGREED by the parties to this appeal and cross-appeal, by and through counsel, the following:

Respondent State of Nevada ex rel. Department of Transportation's (the "Department") Reply Brief and Answering Brief to Respondents/Cross-Appellants' Opening Brief on Cross-Appeal (an "Answering Brief") was initially due July 17, 2020. This Court granted extensions of the time to file the Answering Brief on July 29 and August 13.

Appellant/Cross-Respondent GreenMart of Nevada NLV LLC's received extensions of the time to file its Answering Brief on July 16, on August 4 and on August 13, 2020. Its Answering Brief is currently due September 18.

Appellant/Cross-Respondent Nevada Organic Remedies, LLC received extensions of the time to file its Answering Brief on July 10, July 29 and August 13, 2020. Its Answering Brief is currently due September 18.

The parties have executed a settlement agreement that will narrow or fully resolve the issues in this appeal and cross-appeal. Proceedings continue in the district court, however, and those proceedings may also

The parties respectfully request, pursuant to Nevada Rules of Appellate Procedure 26(b)(2) and 31(b)(2), that this Court enter an order extending the Department, GreenMart
