2 **MEMORANDUM OF POINTS AND AUTHORITIES**

3 On February 3, 2022, the Court granted En Banc reconsideration
4 from opinion filed on September 3, 2021 in the Supreme Court case num-
5 ber 79715. Supreme Court provided notice of supplemental brief on Febru-
6 ary 4, 2022. This motion follows:

7 The time allotted for supplemental brief will soon expire. The under-
8 signed counsel has spent extensive time researching the additional law on
9 the subsequent issue raised with counsel's current schedule in light of the
10 COVID-19 Pandemic, the difficulties of a sole practitioner in these trying
11 times have made drafting the supplemental brief in this case problematic.

12 For these reasons, counsel would request an extension of time to file
13 the Supplemental Brief and Appendix in this appeal. The Supplemental
14 Brief and Appendix are due February 18, 2022. Counsel would request an
15 additional sixty days with which to prepare and file the Supplemental Brief
