ORDER


In response to this court's orders to show cause as to why its appeal in Docket No. 79917 should not be dismissed for lack of jurisdiction, appellant Nanyah Vegas, LLC (Nanyah) has submitted a copy of a written, file-stamped stipulation and order by the district court formally dismissing Nanyah's remaining claims. As it now appears the district court entered a final judgment in district court case A-16-746239-C, there is jurisdiction over Nanyah's appeal, as well as the cross-appeal filed by respondents/cross-appellants Sig Rogich, individually and as trustee of the Rogich Family Irrevocable Trust, and Imitations, LLC (the Rogich parties). Thus, briefing on Nanyah's appeal and the Rogich parties' cross-appeal is reinstated under the briefing schedule set forth at the conclusion of this order.


In addition, respondent/cross-appellant Eldorado Hills, LLC (Eldorado) has responded to this court's orders to show cause as to why Eldorado's cross-appeal in Docket No. 79917 from a May 22, 2018, order entered in district court case A-16-746239-C and an October 4, 2019, order entered in case A-13-686303-C should not be dismissed for lack of jurisdiction. Having considered Eldorado's response, we are not persuaded that this court has jurisdiction over its cross-appeal. Accordingly, because Eldorado has not carried its burden to establish jurisdiction, *see Moran v. Bonneville Square Assocs.*, 117 Nev. 525, 25 P.3d 898 (2001), its cross-appeal is dismissed.


Further, the parties have filed a document entitled, "Stipulation for Consolidation," which we construe as a joint motion to

consolidate Docket Nos. 79917, 81038, and 81238, and establish a consolidated briefing schedule. The motion is granted.¹ See NRAP 3(b)(2); NRAP 27. Briefing shall proceed as follows: Nanyah shall have 60 days from the date of this order to file and serve a single opening brief addressing all issues raised in these consolidated appeals and an appendix. The Rogich parties shall have 30 days from service of Nanyah's opening brief to file and serve a combined answering brief on appeal and opening brief on cross-appeal. Eldorado, respondent Teld, LLC, and respondent Peter Eliades, individually and as trustee of the Eliades Survivor Trust of 10/30/08 (Eldorado), likewise shall have 30 days from service of Nanyah's opening brief to file and serve an answering brief to Nanyah's opening brief. Nanyah shall have 30 days from service of the Rogich parties' combined brief and the answering brief to file and serve a combined reply brief on appeal and answering brief on cross-appeal, likewise Eldorado shall have 30 days from service of the Rogich parties' combined brief to file an answering brief on cross-appeal. Finally, the Rogich parties shall have 14 days from service of Nanyah's combined brief to file and serve a reply brief on cross-appeal, if deemed necessary. See NRAP 28.1.

It is so ORDERED.
