

ORDER AND SUMMARY JUDGMENT

ORDER AND SUMMARY JUDGMENT

The Counterclaim of Defendant Counterclaimant Sigmund Rogich aka Sig Rogich
against Plaintiff Antonia Nevada, LLC have come on regularly to be heard on October 28, 2013
and good cause appearing, the Court finds the following undisputed material facts:

1. Antonio Nevada invested \$3,000,000 in Defendant Eldorado Hills, LLC in 2006.
2. Sig Rogich was a co guarantor of said investment.
3. In 2007, the said investment was fully repaid and Eldorado Hills, LLC was no longer obligated to Antonio Nevada.
4. By reason of said repayment, Sig Rogich had no obligation to Antonio Nevada under his guaranty or otherwise.
5. Sig Rogich mistakenly believed that as guarantor he owed Antonio Nevada interest on its investment and paid Antonio Nevada \$270,000.00.
6. Said \$270,000 was not due and the payment was a mistake of fact or law.

LEGAL DETERMINATIONS

1. The Motion for Summary Judgment on Sig Rogich's Counterclaim is granted.
2. Sig Rogich should be awarded Judgment against Antonio Nevada in the sum of \$270,000 plus interest and costs.

Let Judgment enter accordingly.

JUDGMENT

Sig Rogich, aka Sigmund Rogich is awarded Judgment in the amount of \$270,000 plus interest in the sum of \$33,782.67, attorneys fees ^{and} in the amount of \$~~_____~~ ^{to be} with costs taxed in ~~the amount of \$_____~~ ^{the subject of further ascertainment as to costs (NRS 18.110) as} motion ^{practically as to attorneys fees (NRS 18.010).}


