## MOTION FOR ORDER FOR TRANSMISSION OF SEALED TRANSCRIPT

COMES NOW, the State of Nevada, by and through counsel, and seeks an order from this Court, directing the clerk of the district court to transmit to this Court, under seal, the transcript of proceedings for the sealing hearing that took place in Department 10 on December 19, 2019, at 9:00 a.m. in the matter of Mailyn Deposoy Kang, District Court Case No. CV19-01896.

At issue in this consolidated writ is the Second Judicial District Court's procedure regarding the resolution of petitions to seal criminal records. The State has referenced the proceedings in its Reply, and the transcripts are

necessary to illustrate that the judges of the Second Judicial District Court vary in their interpretation of prosecutorial obligations.

In its Order Denying Motions of March 19, 2020, this Court acknowledged that review of this transcript is warranted, but noted that the State had not demonstrated it could not be included in a Supplemental Appendix. Accordingly, the State offers the following information and attached exhibits in support of its Motion to Transmit the transcript of the Kang matter, Second Judicial District Court Case Number CV19-01896.

At the time of the sealing hearing in this matter, the State was required to appear, but not permitted to make a record. The State requested the transcript from the court reporter, but the court reporter refused based on instructions from the presiding judge. *See* Exhibit 1. The State is, thus, unable to procure the transcript and unable to include the transcript in its Third Supplemental Appendix. *See* Exhibit 2. Therefore, the State requests that this Court direct the district court clerk to transmit the
