1 like under control. And today, you know, seems like everything is very  
2 unstable and it could be, you know, could cause a problem at any time.

3 We have -- we have no control whatsoever of everything that  
4 happened. The only thing that we can hope for is faith. And we were  
5 hoping that there was some supernatural or the higher force that could  
6 help to us deal with all this situation. And this is the way that had no  
7 return at all somehow.

8 So what left for me is for me to me to try to face the situation  
9 and try to be better. And try to live a life that I believe is bearable. But I'm  
10 sure that happiness, true happiness is that that -- happiness, real  
11 happiness I do -- I do not believe it exists anymore for me. For those who  
12 lost a child, if there is unhappiness that is fake or masked. And the  
13 happiness that, in fact, it just -- it just not firm.

14 And like this I try to think of and hope for the best for Dudu. His  
15 name and my love for him and I hope that all this thing will not end soon.  
16 And we try to be together, stronger, and with a lot of love. And because  
17 his being is so strong, his presence used to be very, very strong. And  
18 made me -- make us believe that we are not here just by any chance.  
19 And each one of us will find whatever this situation can offer to us.

20 And, again, one day we will meet again. For now, for now, at  
21 this time, it just sadness, sadness, and sadness. Nothing that can bring  
22 Dudu back but I'm quite sure that now he went with peace. It doesn't  
23 matter where he went but with peace and love. Just like me that I will  
24 search my way to do exactly that.

25 THE WITNESS: [In English] That's it.

1 THE INTERPRETER: That's it, Your Honor.

2 THE COURT: Thank you very much.

3 Do we have another victim speaker?

4 MR. DIGIACOMO: No, Your Honor.

5 THE COURT: No, okay. All right.

6 And for the record I did indicate that I had read the letters that  
7 were submitted on behalf of the defendant. I also did receive the letters  
8 that were submitted on behalf of the victims that were in Portuguese and  
9 they were translated into English. And I did read those as well.

10 [Colloquy between the Court and the Court Clerk]

11 THE COURT: Can we get the spelling of your name? I'm sorry.

12 THE SPEAKER: My name?

13 THE COURT: Yes.

14 THE SPEAKER: Isabel.

15 THE COURT: How do you spell it?

16 THE SPEAKER: I-s-a-b-e-l.

17 MR. DIGIACOMO: And your last name.

18 THE WITNESS: G-a-i-o-l-l-i, Gaiolli.

19 THE COURT: All right. Thank you.

20 And I'll also note for the record the -- one of the letters included  
21 a letter from his sister, the victim's sister, and she talked about how she  
22 suffered since the passing of her brother. To include the physical  
23 manifestations of the emotional toll that his death took on her, as well as  
24 the other family and how the family overall misses, clear in all the letters I  
25 read, the impact it took on their entire family and how they used to be and

1 how they are today. And so I'll note that for the record.

2 All right. All right. So having taken into consideration the  
3 State's argument, the defendant's request, including counsel, and I  
4 considered your letter, I also considered the letters of your family  
5 members.

6 And certainly I was the one who heard the evidence this case. I  
7 have a few observations before I announce sentence.

8 Your attorney and you are right that at the time that you were  
9 interviewed, you were unaware that he had died. You knew there had  
10 been an accident but you were unaware that he had died. That wasn't  
11 lost on me and I don't think that was lost on the jury. I assume that part of  
12 the reason why they came back the way they did with the verdict was  
13 because they agreed that you didn't go out that night intending to kill  
14 anybody. You went out that night intending to make money.

15 And that seems to be your history. I understand you had a  
16 troubled teenage years and you didn't necessarily have the easiest of  
17 childhoods but you're not alone. There are lots of people that go through  
18 that and lots -- unfortunately and it's all too common that individuals suffer  
19 the way that you did.

20 But that doesn't explain or justify your actions. I have standing  
21 before me a perfectly abled body, well-spoken woman who has chosen to  
22 live a life of crime. I don't think I have any information before me showing  
23 that you have had any long term or legitimate job. You were arrested  
24 numerous times for theft related offenses. And even when you were put  
25 on probation and given a chance to stay on the straight and narrow, you

1 violated the Court's trust and the public's trust by stealing \$1,000 from a  
2 victim in that case.

3 I think that you only know a life of crime, which is concerning to  
4 the Court. And it's certainly concerning that in light of the fact that I  
5 understand you didn't know he died when he made -- when you  
6 interviewed with the detective in this case.

7 On the flip side you knew he had died when you made those  
8 phone calls and you talked to your family after the conviction. And it is  
9 very troubling to the Court that you blame your daughter for what  
10 happened to you, in words that should never be said to a child or to  
11 anyone in your family.

12 You -- your daughter got on the phone in one of the those calls  
13 and said, Hi, mom. And you responded and said, See what you did, see  
14 what you did by giving out -- pardon my language -- my fucking code, see  
15 what you did.

16 Your daughter's a child. She doesn't know any better.

17 You then berated her. You told her -- you said that what she  
18 did was stupid as fuck.

19 You then talked to other family members and you blame -- I  
20 believe your -- I don't know if it's your grandmother or your mother or your  
21 stepmother, but you say that what happened to you is no thanks to her  
22 granddaughter, which I'm assuming is Promise. And tell her, Thank you  
23 fucking a lot. It's all her mother's fucking fault with her stupid ass.

24 And then you said, If she wouldn't have said nothing, it wouldn't  
25 have been no fucking case. Do you understand? And you had another

1 case.

2 So to me there's a difference between at the time you make that  
3 three hour statement where you initially deny any involvement in all of the  
4 crime, flash forward to you hear all the evidence in the case, and then you  
5 make these statements where you shift the blame of your conduct onto  
6 your daughter, which impacts my consideration of how much of  
7 acceptance of responsibility do you really have.

8 I take your letter to heart. I think that you are genuinely sorry.  
9 But I'm worried that you're only sorry you got caught. Because the calls  
10 that I have before me, and there could be other ones and there could be  
11 other letters, I don't have any, I'm sorry that I killed a young kid. I'm sorry  
12 that I made the choices that I made that night. I'm sorry that I didn't stop  
13 and give the watch back. I'm sorry I took the watch.

14 Instead it's curse words at a minor child. And I can only hope  
15 you understand that by treating your daughter the way that you have you  
16 potentially drive her towards the life that you had. And I don't think you  
17 want that for your children. I don't think you want them to have lives of  
18 crime.

19 Am if I wrong about that?

20 THE DEFENDANT: Right.

21 THE COURT: So there has to be some balance. I came from a  
22 system that really clearly delineated what I should consider when I'm  
23 sentencing a defendant and those are really adopted in Nevada cases  
24 also. And the things that I consider are everything from the nature and  
25 characteristic of the defendant, so you; your past, your criminal past; what

1 happened in this case. I also consider the nature and seriousness of the  
2 offense.

3 There's no serious -- more serious offense than when someone  
4 dies and it doesn't matter what circumstances that person dies.

5 I have to consider deterrence from criminal conduct. I have to  
6 consider whether or not the crime is sufficient but not greater than  
7 necessary to achieve these factors, amongst other things.

8 So that leaves me with a question of how will I ever bring  
9 closure to the family? I won't. That won't happen. They'll never get their  
10 child back.

11 You are lucky that you have your children. And I hope that you  
12 sit and think about the fact that you're lucky and perhaps -- and I implore  
13 you not to talk to your children ever again like that because you're lucky  
14 you have them and they have to suffer for the rest of their lives without  
15 their child.

16 I have to say I really admire the family. You're incredibly strong.  
17 You came and sat through this trial and like saw those pictures and heard  
18 the evidence and you were incredibly strong. I think that speaks to what's  
19 going to happen next for you.

20 I hope you all can understand me. Are you understanding me?

21 MR. OSORIO: Yes, yes.

22 THE COURT: Okay. All right. You need each other and you're  
23 get through this. So remember that.

24 UNIDENTIFIED SPEAKER: Thank you.

25 THE COURT: Your family, also needs your family, and I --



1 that's not lost on me. I'm glad to see that you have family here. That is  
2 important. It is important to what comes next in your life. And I hope what  
3 comes next in your life is not this, to never, ever engage in any of this sort  
4 of behavior again. Which means in the time that you're in custody you're  
5 going to have to work hard to turn your life around, to get the skills that  
6 you don't have now, and to figure out how you're going to get out and do  
7 something productive for society and to be a good mom.

8 And I can tell you, and I can tell you everyone who's come in  
9 contact with the criminal justice system, that you're not being a good  
10 parent when you are committing crimes. And you're not being a good  
11 parent when you're not accepting responsibility for what you did.

12 So, again, I go back to, I appreciate your letter because I do -- I  
13 do take that as being sincere.

14 All right. With that being said, in accordance with the laws of  
15 the State of Nevada you're hereby adjudged guilty of the crimes of second  
16 degree murder, which is a felony, in violation of NRS 200.010 and  
17 200.030.5, which is a category A felony, carrying a possible term of life,  
18 with a possibility of parole after 10 years or a definite term of 25 years  
19 eligible -- with a parole eligible after 10 years.

20 Count 2 is robbery, a felony, a category B felony, in violation of  
21 NRS 200.380, which carries a 2 to 15 year term in Nevada Department of  
22 Corrections.

23 Grand larceny is Count 3, a category b felony, in violation of  
24 NRS 205.220.1 and 205.222.3, which carries a 1 to 10 year term in  
25 Nevada Department of Corrections and up to a \$10,000 fine.

1           And, Count 4, duty to stop at the scene of a crash involving  
2 death or personal injury, which is a violation of NRS 484E.10, a category  
3 B felony, which carries a 20 to 20 year sentence in the Nevada  
4 Department of Corrections, and not less than \$2,000 but up to \$10,000  
5 fine.

6           I'll note that the PSI makes, really doesn't really make a  
7 recommendation. It suggests two alternatives. One is to sentence you to  
8 the definite term of 25 years and the other one is a 10 to 25 year  
9 sentence.

10           But I agree with Mr. DiGiacomo there -- there isn't a lot of  
11 information as how they're making that recommendation.

12           I have heard the arguments of counsel, and your counsel  
13 requested a 10 to 25 year sentence, and I've also heard the State's  
14 request.

15           I do believe taking into consideration everything and the facts  
16 and circumstances of this case, as well as your history, that the State's  
17 request is appropriate, and that is an aggregate sentence of 18 to life.

18           So let me go through how we're going to go there. As to  
19 Count 1, I am sentencing you to eight -- make sure I'm saying this right,  
20 Mr. DiGiacomo -- it would be 18 to life is what you want me -- or 10 to life  
21 with that running -- with the other ones running consecutive; is that  
22 correct?

23           MR. DIGIACOMO: Correct.

24           THE COURT: All right.

25           MR. DIGIACOMO: And you have to enter a sentence of life

1 with the minimum parole eligibility after 10 years on Count 1.

2 THE COURT: All right.

3 MR. DIGIACOMO: And then the other one.

4 THE COURT: So it will be a sentence of life with a parole  
5 eligibility at 10 years.

6 Count 2, I'm imposing a 72 to 180 month sentence, that will run  
7 concurrent with Count 1.

8 As to Count 3, I'm imposing a sentence of 48 to 120 months, to  
9 run consecutive to Counts 1 and 2.

10 And as to Count 4, I'm imposing a sentence of 48 to 120  
11 months, which will run consecutive to Counts 1 -- 1 and 2, which are  
12 running concurrent, and Count 3, which is running consecutive. So  
13 Count 4 will run consecutive to Count 3.

14 I'm also imposing a sentence of \$2,000 as dictated by statute as  
15 to that Count 4.

16 I'm also going to order that you pay a \$25 administrative  
17 assessment fee, which is standard in every criminal case; your DNA's  
18 already been taken; so there will be a \$3 DNA assessment fee. I'm  
19 ordering a one -- extradition fee in the amount of \$1,891.05 and restitution  
20 in the amount of \$59,227.93 and that is for Count 1 as set forth in the  
21 presentence investigation report.

22 Again, in making my determination I find the sentence is  
23 sufficient but not greater than necessary in light of all the considerations I  
24 stated on the record and taking into full consideration the letters that were  
25 submitted, the arguments of counsel, the defendant's statements, the

1 victim's statements, as well as the evidence at trial.

2 Anything further that I need to put on the record?

3 MR. DIGIACOMO: There's 610 days credit time served to the  
4 sentence.

5 THE COURT: Thank you.

6 I will also give her 680 --

7 MR. DIGIACOMO: 610.

8 THE COURT: 610.

9 610 days of credit for time served.

10 MR. DIGIACOMO: Thank you, Judge.

11 MR. MUELLER: Thank you, Your Honor.

12 THE COURT: All right.

13 MR. MUELLER: For the record, defense objects to the  
14 sentence as being -- and the materials that were used is inappropriate.





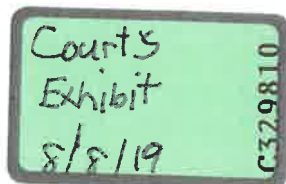

### **Summary of Findings**

#### **I. Examiner Qualifications**

#### **II. Search Authorization**

Authorization to search the electronic storage devices in reference to this case is granted by a search warrant authored by Detective Salisbury of the Las Vegas Metropolitan Police Department on June 27, 2019.

Examination of the electronic storage devices in this case is limited to searching for evidence of the crimes of Murder With A Deadly Weapon, Robbery With A Deadly Weapon, Leaving the Scene of A Crash Involving Death, Soliciting or Engaging in Prostitution, and Grand Larceny. Specific evidence sought is:

- (1) Digitally stored records of user and/or device created data, including stored communications such as voice, text, Email, messaging and/or social media content, photos, graphic files or videos, geo-location information, stored internet browser and application data, contacts and call history, stored documents, software applications, which may constitute evidence of Ronneka Ann Guidry's involvement in the planning or commission of the crime(s) of Murder With A Deadly Weapon, Robbery With A Deadly Weapon, Leaving the Scene of A Crash Involving Death, Soliciting or Engaging in Prostitution, and Grand Larceny between the dates of 1/3/18 and 1/10/18.
- (2) Digitally stored records, information and data which would tend to establish the identity of persons who were in sole or joint control of the digital storage device.

*Only relevant data is chronicled in this report and supporting links. Images of the devices were retained with LVMPD CFL under the digital case file if case investigators require it. 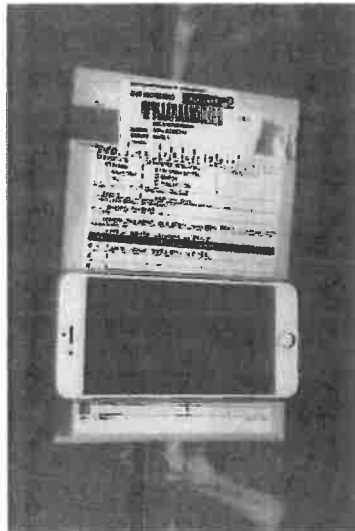
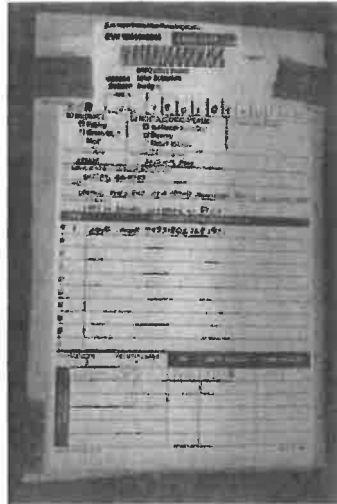

## VI. Findings & Analysis

The digital storage device was retrieved from the LVMPD's Evidence Vault and was sealed and intact in an LVMPD evidence package. The item sealed in the LVMPD evidence package was accessed by cutting a slit in the package.

This is a second search warrant authorized acquisition of this device. A new tool, GrayKey a proprietary software solution for acquisition of data (artifacts), is now available that was not available at the time of the first acquisition.

The phone was placed inside a faraday enclosure and charged to a level sufficient for examination. Upon powering on the device inside the faraday enclosure the device was still in airplane mode from the first acquisition. The device was connected to GrayKey and a Full File System acquisition was completed.

The resulting acquisition was saved as a zip file with the following identifying characteristics:

UFED Physical Analyzer and Magnet Axiom were used to examine the artifacts.

There are two (2) areas to address in this search, the purported Snapchat message and additional evidentiary artifacts on the device related to the crimes under investigation.

### SNAPCHAT MESSAGE

Craig Mueller, Esq. representing Guidry purported in a Motion To Suppress Evidence, that on January 9<sup>th</sup>, 2018, before Guidry was released from police custody that a person named Teresa Patten (Patton) received a message from Guidry's phone on Snapchat reading "What up boo."

Reading the Affidavit of Teresa Patton June 26, 2019, Exhibit 17, it states:

*'That on January 9, 2018 at approximately 9:30 AM, I received a message on my Snapchat account from my cousin Ronneka Guidry, who at the time was residing in Las Vegas, Nevada. The message stated 'What up boo.'*

### BACKGROUND

As documented in the first examination report dated February 6, 2018, on January 11, 2018 at the LVMPD Forensics Vehicle Lab Bay during the examination of the vehicle. At that time, I entered the passcode provided by the Detective, turned on airplane mode and powered off the device for later examination.

Using the GrayKey File System extraction as the data source, Cellebrite Physical Analyzer and Axiom Examine for analysis the artifacts were examined for the purported instance of a Snapchat message sent while the device was in police custody.

**Snapchat** is a multimedia and messaging application that allows users to exchange messages, pictures and short videos (snaps). Logging into Snapchat can be done from a mobile device with the user login and password credentials.

- Cellebrite Physical Analyzer and Axiom Examine reported that 'Snapchat' was installed on the examined device.
- The application was allowed access to the following other applications: Camera, Microphone, Pictures (Photos), and Contacts (Address Book).
- The version of Snapchat was 10.22.2.0, Snapchat iPhone 7.1, and the application ID was listed as 53934E41-96C0-4E4A-B0CF-DF014F40FE4A.
- The 'Identifier' for the Snapchat application is com.toyopagroup.picaboo.

In order to send a Snapchat message from the device as purported, the device would:

1. Need to be unlocked;

2. The Snapchat application used; and,
3. Data would have to be transmitted from the device.

### ANALYSIS

Databases on the device were queried for activity:

- a) On January 9, 2018 at or around 9:30 am Pacific Standard Time when the Snapchat was received;
- b) After the stop and arrest of Guidry on January 8, 2018 at 9:13 pm Pacific Standard Time until January 11, 2018 when the device was handled by this examiner at the LVMPD Forensics Lab Vehicle Bay.

### DATABASES QUERIED

1. **knowledgeC.db**- This database is an internal system log that merges the User and internal system activities on the device. Recorded events include: Locked and Unlocked states, Plugged in, Backlit, inFocus (application usage), batteryPercentage, Video calls, and Snapchat along with many others.

Two categories in this database related to different events queried were:

- a. Device Lock States- indicates that the device is locked or unlocked and the time frame for each events duration. **The database showed that the device was locked from 1/8/2018 23:11 hours PST until 1/11/2018 13:25 hours PST.**
  - b. Application Focus- Snapchat usage was identified in the database by the entry 'com.toyopagroup.picaboo'. **The database showed the last time that the application was run on this device was on January 8, 2018 from 21:02 hours PST through 21:05 hours PST.**
2. **DataUsage.sqlite**- this database tracks the data usage by an application.
- a. **The last Network Activity of Snapchat on this device was on January 8, 2018 at 21:15 hours PST.**

**Based on the artifacts available on this device, there was no activity consistent with the purported Snapchat being sent on January 9<sup>th</sup>, 2018 from this device while it was in police custody after the arrest on Guidry on January 8, 2018.**

### Vehicular Manslaughter

In Nevada, a driver commits "vehicular manslaughter" by:

- Violating a traffic law, and
- Negligently causing the death of another person.

**Simple negligence.** Generally, crimes have two components that the prosecution must prove: an act or omission and a mental state. In Nevada, the mental state for vehicular manslaughter is "simple negligence." A person acts with simple negligence by failing to exercise the degree of care that a reasonable person would under like circumstances.

**Causation.** A driver cannot be convicted of vehicular manslaughter unless there is proof that the victim's death was a "natural or probable" result of the driver's negligence. It's not enough to merely show the defendant was negligent and someone died—there needs to be a link between the negligence and the death. Vehicular manslaughter is a misdemeanor in Nevada.

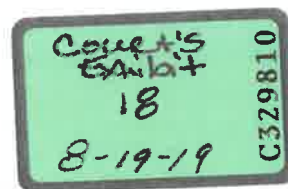

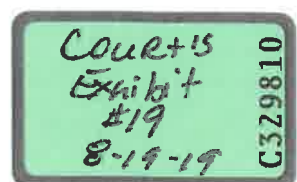
