Recording. Hello, this is a free call from Ronneka Guidry, an inmate at Clark County Detention Center. This call is subject to recording and monitoring. To accept this free call press one. To refuse. Thank you for using Securus. You may start the conversation now.

RG: Don't hang up because this cost money.

Male: I just hanged up. The phone said the calls being terminated and it hung up on me.

RG: Okay. Um, they convicted me with, um, duty to stop, grand larceny, um, robbery and murder two. They was gonna get me involuntary, but the... it wouldn't go with the murder. So, involuntary I would have been, I would have been... I would of be getting released. So, they got me murder two, so I think I gotta do like seven more years thanks to your daughter.

Male: Number two, yeah _____ little hurt. She don't even know what she _____.

RG: No, but she should of never said nothing. I wouldn't even be in this situation. She, if she wouldn't of said nothing, it wouldn't of been no fucken case. Do you understand? None.

She just fucked my whole life up. I won't get out until I'm almost 40 years old cause your fucken daughter opened her fucken mouth.

Male: No, I don't say your business. Nobody ever did.

RG: Uh, yeah. If they give me another, uh, if they give a eight, if they give me a eight I'll be out in six years. I'll be out, um, when I'm 36, you know. But I mean...

Male: Yeah, I thought that shit was gonna go way better than that.

RG: No, it was, it was going to, but they kept talking about the watch. It... I
