Justified Killing

Limitations of Self-Defense -Original Aggressor-

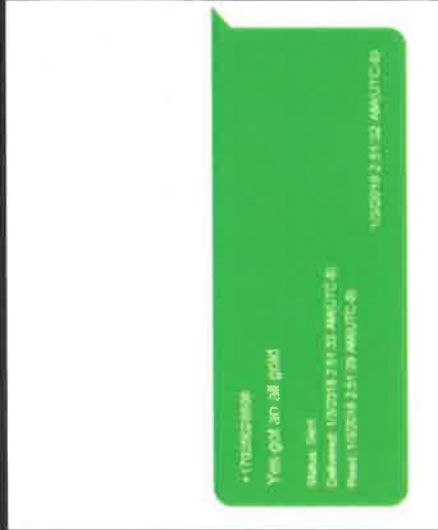
- Where a person without voluntarily seeking, provoking, inviting, or willfully engaging in a difficulty of her own free will, is attacked, she has the right to stand her ground
- But, when a person is engaged in criminal activity, that person must retreat instead of using deadly force.

Limitations of Self-Defense-Response to Victim Force-

- A victim of larceny has the right to use force to resist the taking and escape with property.
- A person who has taken the property **may not rely on self-defense** when the force is **in response** to the victim trying to prevent the taking or escape.

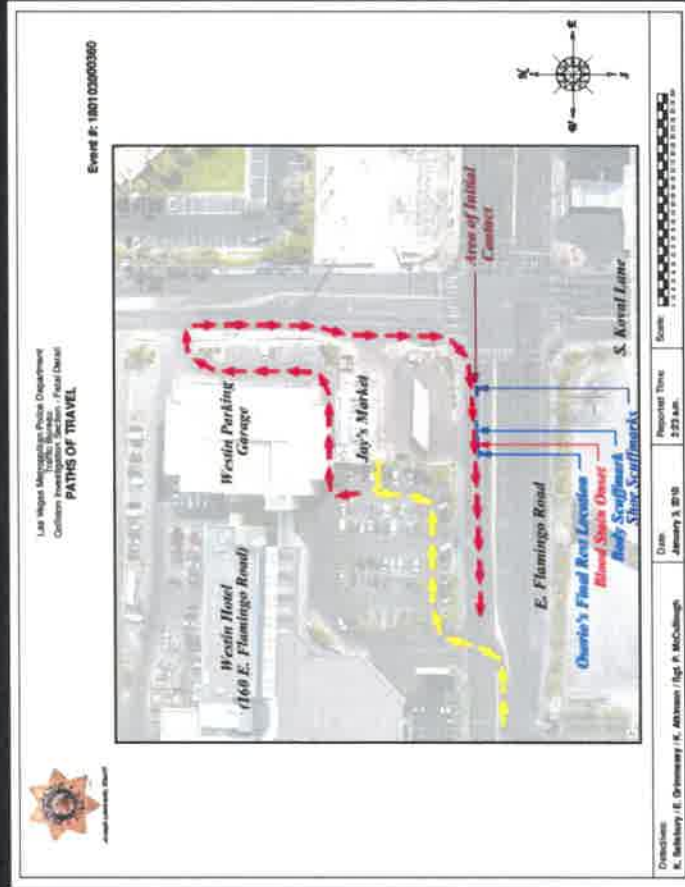

Involuntary Manslaughter: Generally

- Killing of a human, without any intent to do so, in the commission of an unlawful act;

Involuntary Manslaughter: Limits

- BUT, where the involuntary killing occurs in the commission of an unlawful act, which, in its consequences, *naturally tends to destroy the life of a human being* or is committed in the prosecution of a felonious intent, the offense is *MURDER*.

Deadly Weapon

- Any weapon, device, instrument which, under the circumstances in which it is used, is readily capable of causing substantial bodily harm.

What is Murder?

- Murder is the unlawful killing of a human being with MALICE AFORETHOUGHT, either express or implied.
 - The unlawful killing may be effected by any of the various means by which death may be occasioned.

MURDER WITH USE OF A DEADLY WEAPON

■ MALICE AFORETHOUGHT

- the intentional doing
- of a wrongful act (KILLING)
- without legal cause or excuse or what the law considers adequate provocation.
 - Can be Express or Implied

MALICE AFORETHOUGHT

- Malice Aforethought may arise from:
 - anger, hatred, revenge, or
 - from particular ill will, spite grudge toward the person killed.
- It may arise from:
 - any unjustifiable or unlawful motive or purpose to injure another,
 - proceeding from a heart fatally bent on mischief or
 - with reckless disregard of consequences and social duty.

FELONY MURDER LAW

There is a kind of murder which carries with it **conclusive evidence of premeditation and malice aforethought.**

FELONY MURDER LAW

That class of murder is committed in the
perpetration or attempted perpetration of a
robbery.

FELONY MURDER -ROBBERY

Any killing which is **committed** in the **perpetration** or attempted perpetration of a **robbery**

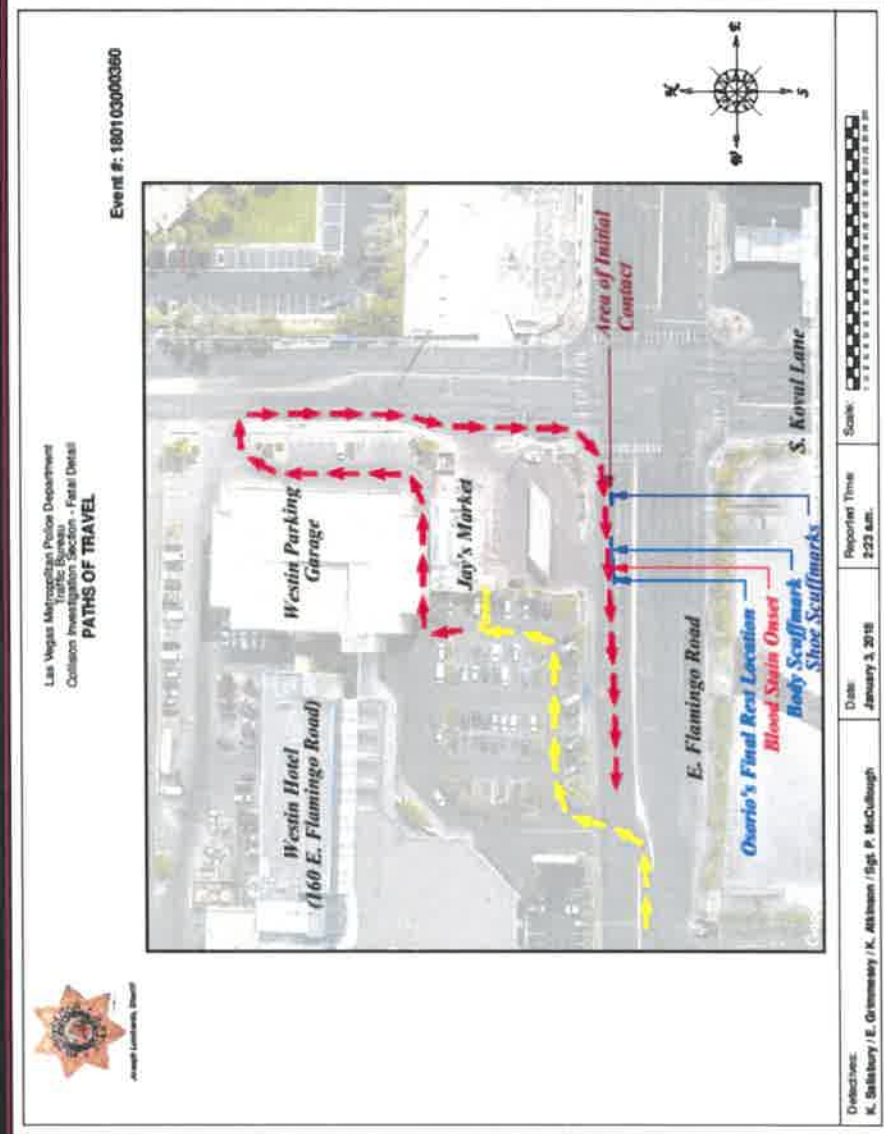

- Although acts of violence and intimidation preceded or followed the actual taking of the property and may have been primarily intended for another purpose, it is enough to support the charge of robbery when a person takes the property by taking advantage of the terrifying situation she created.

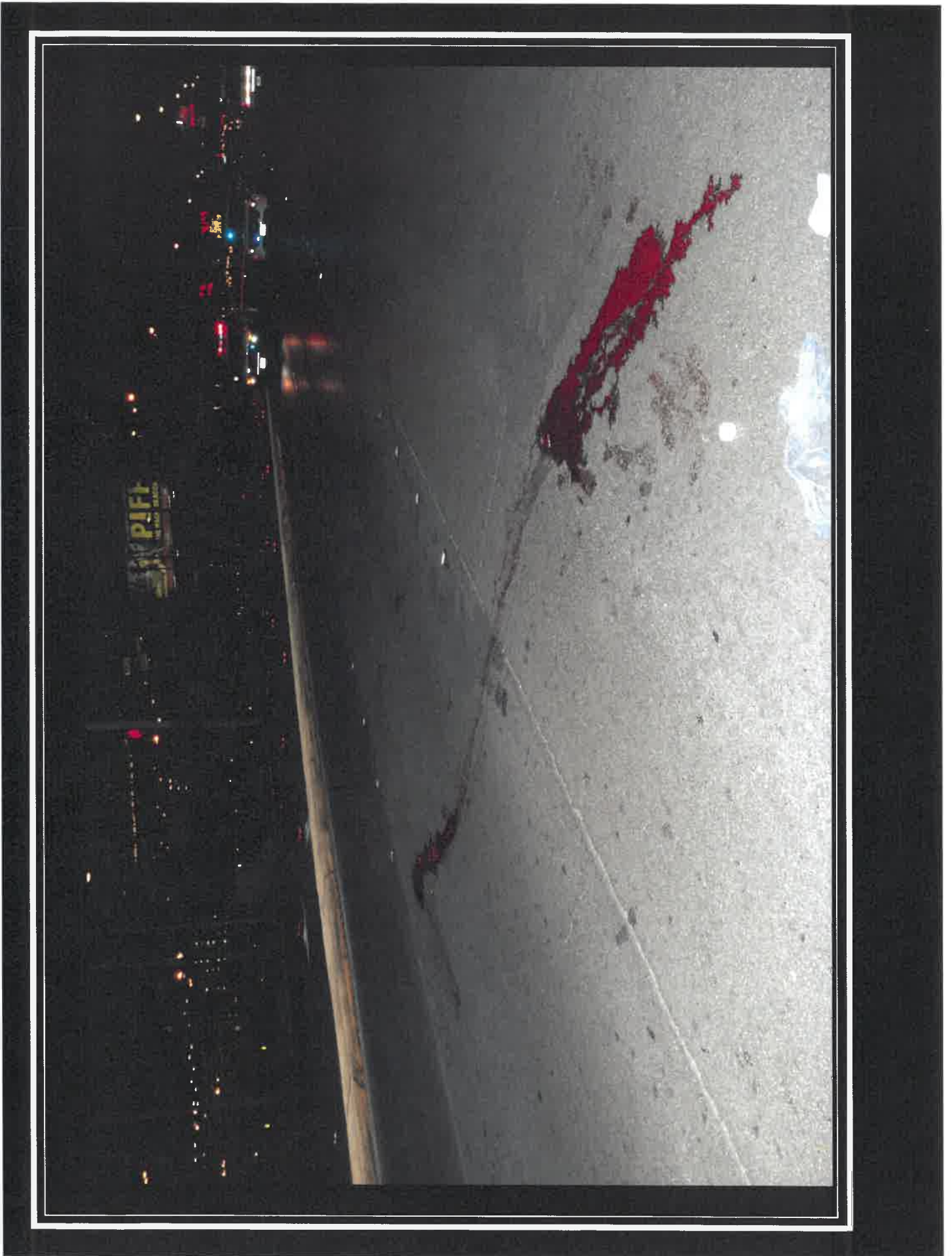
