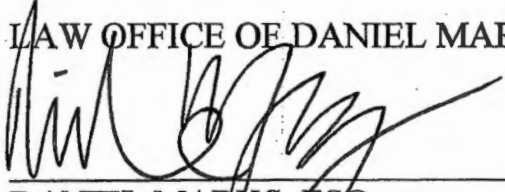
STIPULATION TO WITHDRAW

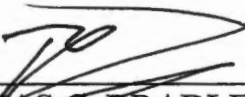

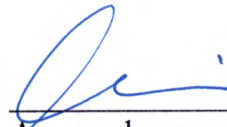
