- APPEARANCES CONTINUED: Attorney Christopher Rose for Wellness Connection of Nevada LLC.

Mr. Puzey appeared by telephone.

Court noted, as a background, that as Mr. Shevorski previously represented to everyone that the State would essentially give a tolling period for everyone through June, a trial was set in April to make sure there would be a decision by that date.
