1 Pursuant to Nevada Rule of Appellate Procedure 29, Respondent Charles
2 “Randy” Lazer hereby submits this opposition to the First Amendment Lawyers
3 Association’s (“FALA”) motion for leave to file amici curiae brief in support of
4 defendant-appellant, filed January 4, 2021.
5

6 FALA presents itself as a free speech protection association. By all
7 accounts, that is exactly what FALA appears to be. However, Marc J. Randazza,
8 Esq., counsel for Appellant, is a member of FALA, and in fact is a Chair Emeritus
9 of FALA. See Exhibit A, printout from FALA’s website identifying Mr. Randazza
10 as a Chair Emeritus; and Exhibit B, Mr. Randazza’s membership detail page for
11 FALA. Thus, FALA’s independence and motivations for filing its amicus brief
12 are in question. Allowing FALA to file an amicus brief in this matter would be
13 akin to giving Mr. Randazza an opportunity to file a second brief. Mr. Randazza’s
14 strong association with FALA should disqualify FALA from filing an amicus
15 brief.
