Respondents Green Tree Servicing, LLC; The Bank of New York Mellon f/k/a The Bank of New York, as Successor Trustee to JPMorgan Chase Bank, N.A., as Trustee for the Certificateholders of CWABS Master Trust Revolving Home Equity Loan Asset Backed Notes, Series 2004-T (together, **bank respondents**), respectfully submit this motion, pursuant to NRAP 31(b)(3), requesting this court grant bank respondents' request to extend the time to file their response to appellant Saticoy Bay LLC Series 133 McLaren's petition for review.

Pursuant to NRAP 31(b)(3)(A), bank respondents submit the following information:

- i. The response is currently due on July 20, 2020.
- ii. Bank respondents received a telephonic extension of the original deadline of July 3, 2020. The court granted the stipulation and set a deadline of July 20, 2020.
 - iii. This is bank respondents' first motion request.
 - iv. No requests for extension of time have been denied.
 - v. Counsel for appellant does not oppose this extension request.
- vi. Good cause exists to grant the requested extension. This is one of several post-decision petitions from appellant or a related entity regarding the same issue. *See* Case Nos. 76672, 76683, 78338, 78733, 79065. While bank respondents' response is nearly complete, counsel needs additional time to hone the arguments and obtain approval from multiple clients and the loan owner, Federal National Mortgage Association.

vii. Bank respondents request a three week extension up to including, August 10, 2020, to file its response. This request is made in good faith and not for delay.
