**MOTION FOR EXTENSION OF TIME TO FILE REPLY BRIEF ON
APPEAL AND ANSWERING BRIEF ON CROSS-APPEAL**

Shawn Bidsal requests an extension through July 23, 2021, to file his reply brief on appeal and answering brief on cross-appeal. NRAP 31(b)(3). This is the fourth such motion. The parties previously stipulated to extend the original deadline from March 24, 2021, to April 23, 2021, and this Court granted Mr. Bidsal's unopposed motion to extend the deadline from April 23, 2021 to May 24, 2021. This Court later
