At present Jan 11, 2020 Kim has been moved to Disciplinary Housing unit 9D6. This is a "phony balcony" charge by a young guard that was envious of and Old Man's knowledge of the law. Refused to give name and badge number for a Citizen's Review Board (CRB) complaint. Sgt. Kim "appealed" to refused to give Kim name and Badge # (required to have these for complaint).

Enclosed as Exhibit 4EP20 is a letter that was given with my rejected envelope that was marked VOID back and front.

This envelope was purchased by Kim it was brought in from court with my legal materials in a banker's box from court which contained envelopes purchased from Kim's previous wrongful

detainment in June-July of last year.

Kim must anticipate that Kim could be locked up from court anytime Kim goes to court because of possible lawless judges! See former judge Steve Jones, Frances Fine, Meluccchia and narveum. Kim was never a boy scout yet Kim believes "be prepared" is a good policy to abide by (it is biblical as well). "Beware ye for ye know not when the Master cometh" quote also in Shawshank Redemption.

Exhibits 1EP20 - 3EP20 are in rejected mailing. Hopefully Kim can get this to the Court soon!

This Court must stop this CCDC process of delaying or refusing legal mail to the Court. Kim had already started to address this in writing to the Court and through administrative remedies when the Unknown guard wrongfully sent Kim to disciplinary because of Kim's attempt to talk to Sergeant. This Court must stop leaving these issues of bad and illegal behavior of CCDC to the federal courts alone through federal Civil Rights actions und 28 USC 1983. 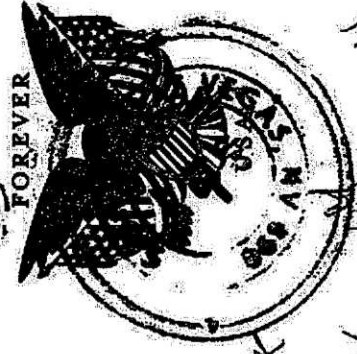
