*ORDER REMOVING FROM SETTLEMENT PROGRAM
AND REINSTATING BRIEFING*

Pursuant to the recommendation of the settlement judge, this appeal is removed from the settlement program. See NRAP 16(b). Accordingly, we reinstate the deadlines for requesting transcripts and filing briefs.

While this appeal was assigned to the settlement program, appellants/cross-respondents (appellants) filed a transcript request form. See NRAP 16(a)(1) (upon the clerk's issuance of a notice that an appeal has been referred to the settlement program, the time for requesting and preparing transcripts and filing briefs is automatically stayed). The clerk shall attach a copy of that transcript request form to this order. Court reporter Peggy Isom shall have 30 days from the date of this order to prepare and deliver the requested transcripts and to file a certificate with this court acknowledging the delivery of the transcripts. See NRAP 9(c).

Respondent/cross-appellant (respondent) shall have 14 days from the date of this order to file and serve a transcript request form. If no transcript is to be requested, respondent shall file and serve a certificate to that effect within the same time period *See* NRAP 9(a).

Further, appellants shall have 90 days from the date of this order to file and serve the opening brief and appendix on appeal. In preparing and assembling the appendix, counsel shall strictly comply with the provisions of NRAP 30. Respondent shall have 30 days from service of appellants' opening brief to file and serve a combined answering brief on appeal and opening brief on cross-appeal. Appellants shall have 30 days from service of respondent's combined brief to file and serve a combined reply brief on appeal and answering brief on cross-appeal. Finally, respondent shall have 14 days from service of appellants' combined brief to file and serve a reply brief on cross-appeal, if deemed necessary. *See* NRAP 28.1.

It is so ORDERED.


