



2 **19-344122-1. Defendant was sentenced on January 7, 2020 to a term of twelve (12) to thirty**
3 **(30) months in the Nevada Department of Corrections, concurrent with C-19-344122-1. Of**
4 **relevance to this appeal, at the sentencing hearing, Defendant requested a total of 99 days of**
5 **credit for time served. However, the District Court granted zero (0) days of credit for time**
6 **served. Defendant now appeals the District Court's sentence as it relates to the lack of any**
7 **credit for time served being awarded the Defendant.**






