**APPELLANT’S RESPONSE TO ORDER TO SHOW CAUSE**

PLEASE TAKE NOTICE that, pursuant to NRAP 9, the Appellant, Clark County Department of Aviation, (“Appellant” or the “CCDOA”), by and through its counsel, Fisher & Phillips, LLP, hereby files its Response to the June 5, 2020 Order to Show Cause.

The Court has concluded CCDOA’s Motion for Reconsideration filed in the District Court on February 21, 2020 “carried tolling effect.” As of 3:50 pm PST on July 6, 2020, the District Court has not issued an order fully resolving the CCDOA’s Motion for Reconsideration.<sup>1</sup> Thus, the

2 that this matter may be dismissed without prejudice to the CCDOA right to  
3 refile its appeal within 30 days of the District Court issuing an order fully  
4 resolving the CCDOA’s Motion for Reconsideration.
