NOTICE OF SUPPLEMENTAL AUTHORITY

Per NRAP 31(e), JSJBD Corp. and related parties provide this Notice of Supplemental Authority. Tropicana Investments, LLC filed a cross-appeal. In its Reply Brief in support thereof, Tropicana Investments incorrectly cites *Old Aztec Mine, Inc. v. Brown*, 97 Nev. 49, 52, 623 P.2d 981, 983 (1981).

Rather, the legal standard that applies to permissible arguments responding to an appeal is stated in *Saavedra-Sandoval v. Wal-Mart Stores, Inc.*, 126 Nev. 592, 599, 245 P.3d 1198, 1202 (2010) (“This court will affirm a district court’s order if the district court reached the correct result, even if for the wrong reason.”). *See also Harvest Foundation, LLC v. Alternative Med. Ass’n*, 477 P.3d 368, 2020 WL

7663460, at *2 (Nev. Dec. 23, 2020) (“respondent may defend judgment in its favor under any fairly presented legal basis”); *Smith v. Phillips*, 455 U.S. 209, 215 n.6 (1982) (“Respondent may, of course, defend the judgment below on any ground”).
