**APPELLANT / CROSS-RESPONDENT JSJDB CORP.'S
OBJECTION TO BILL OF COSTS**

JSJBD Corp and related parties hereby object to the bill of costs filed by
Tropicana Investments.

NRAP 39 covers costs on appeal. NRAP 39(e) lists the costs that can be
asserted in a bill of costs. It states:

The following costs on appeal are taxable in the district court for the benefit of the party entitled to costs under this Rule:

- (1) the preparation and transmission of the record;
- (2) the reporter's transcript, if needed to determine the appeal;
- (3) preparation of the appendix;
- (4) premiums paid for a supersedeas bond or other bond to preserve rights pending appeal; and
- (5) the fee for filing the notice of appeal.

In its bill of costs, Tropicana Investments asserts costs for (1) lodging; (2) rental car; and (3) photocopy fees for copying of brief / appendix.

First, lodging is not one of the permitted cost items, above. The entire lodging amount should be eliminated.

Second, "rental car" is not one of the permitted cost items. The amount should be disallowed.

Finally, there are no "photocopy fees" for "copying of Brief(s) and Appendix," as the briefs and appendix were filed electronically. They already existed in digital format and were combined electronically into a pdf. No copies are transmitted to the Supreme Court. The amount should be disallowed.
