PLEASE TAKE NOTICE that Appellant Franchise Tax Board of the State of California ("FTB") has lodged with the Court and delivered to all counsel a CD that contains the hyperlinked backup of documents submitted with its Opening Brief filed on August 3, 2020.

This hyperlinked brief allows review of the brief and its supporting documentation in one document without resort to paper materials or internet access. The supporting documentation includes both the appendix as well as legal authority.


Due to the size of the hyperlinked brief, it will perform better if it is moved to your hard drive, since CD drives access data slower than hard drives. After placing the CD into your computer, go to "My Computer," double-click on your CD drive (usually drive D), and drag and drop the file to your Desktop. (You can also move it to "My Documents" if you prefer.) Once you have moved the file to its new location, simply double-click on it to open it.

Using the hyperlinked brief is fairly simple. Just scroll through the pages to read it as you would any other PDF document. However, when you encounter a hyperlink, it will be underlined in blue. Click on the hyperlinked text, and it will jump you forward in the brief to the referenced page. To return to the page in the brief that you were viewing prior to clicking on the hyperlink, you can press "Alt" and the left back arrow on the keyboard, or just click the blue back arrow on the toolbar within Adobe (see screen-shot below).



Note that sometimes you may have to hit the back button a few extra times to get back to the original page (this would happen if you have scrolled a few pages past the initial hyperlinked page).

If you do not have the back-arrow button at all on your toolbar, you may need to add it. Right-click on your toolbar, choose "Page Navigation," scroll down until you find the "Previous View" and "Next View" options (see screen-shot below), and select both of them. The arrow buttons will then appear on your toolbar.
